<p>This meeting chaired by Peter Wilson</p> <p>Welcome, introductions and apologies – Attendees/Apologies (refer later in this document)</p> <p>Minutes tabled - Approved by Peter Wilson, seconded by Kamlesh Lai</p> <p>GS1 Australia Trade Practices Compliance notice – Referred to each meeting, accessible on HCNPCAG HUB (Link)</p> <p>Review of Action Items</p> <ul style="list-style-type: none"> ○ 2.1 - Executive level 'Value proposition' development – draft shared with HCNPCAG for review and approval Action: feedback invited till 25th May. ○ 3.3 – UNSPSC selection process improvement – Murray Robb. Further details regarding specific issues that were to be solved by this action have not been forthcoming so this item is proposed to be closed. Agreed by group to do so. <ul style="list-style-type: none"> • Interest in a gap analysis between version currently in use (v19.0501) and most recent version. UNSPSC changes have a significant impact on classification of products and on business processes that rely on this classification. It was decided not to move the sector to the most up to date version during the dataset review but this can be revisited if required. Review of the differences between the latest UNSPSC and v19 (AU HC default) to be completed and shared with the group. The difference between Australian HC and NZ Healthcare was also highlighted. Refer new action item. ○ 4.1 - Suggestions on what else GS1 or HCNPCAG can do to help drive the Data Quality improvement within NPC. No feedback received but opportunities to drive data quality improvement from NPC reimagined process. Murray Robb – industry group to provide input into data quality report. To be reviewed at next advisory group. Further discussion in latter part of meeting where Data Quality Statistics were presented. ○ 5.3 - Explore options to show a catalogue has had a full review as part of the DQI reporting (Is this an Industry wide 'Ready' status?) Murray Robb - could be solved via changes to Data Quality Reporting. Further discussion in future HCNPCAG meetings and potential sub group to discuss this could be needed. ○ 5.4 - Explore how to signify where a catalogue has been reviewed by another recipient (Is this an Industry 'Live' status?) Murray Robb – industry group to provide input into data quality report may resolve this. To be reviewed at next advisory group in greater detail to determine best approach.

- **5.5 - Investigate the possibility of an 'Interim load' of data (refer Dataset review feedback)** to be discussed later in this meeting as part of Reimagining deliverables.
- **6.7 - Development of report informing suppliers which recipients are using/have accessed their data within the previous month** – Murray Robb. Proposed that we close this action item due to the difficulties with understanding how recipients are using data because of M2M integration. Some of the challenges related to this may be solved via the proposed Data Lake (refer later in minutes/agenda)
- **7.1 – AMT-CTPP Action Plan** – (This action is an amalgamation of 3.2, 6.3, 6.4). ADHA staff (Sarah Kong) not available to provide update at this meeting so it is to be provided at next meeting.
- **7.2 –Dataset Review changes implemented post go-live** – Murray Robb. Final changes from dataset review were inclusion of changes to the data quality reports in Feb/ March. All tasks completed – so propose that this can be closed. Any additions should become a new requirement.
 - Request received from Ian Boyle (QH) for us to add volume as an attribute? **Action to be taken by NPC team (Ramesh/Murray) to investigate and suggest solution/options**
- **7.3 – Review/Assessment of data usage.** Suggest this is kept as a standing item for review when we have 12 months of data post data review
- **7.4 – Use Case review/update to reflect Re-Imagining workshops and inputs** – Use Cases updated and provided in pre-reads. **Action: feedback invited till 25th May.**

- **Comments/Questions from group:** Kam issues 2 (Missing Manufacturer Name) and 4 (Missing Manufacturer Internal Reference) in the data quality reports are related so should be handled together
- **Peter Wilson** – Prosthesis rebate codes for hospital sector are critical and change 3 x per year due to federal changes. Wrong rebate codes cause significant issues. NPC is perfect vehicle for trying to map this and this is a high priority. Agreement that it is important to get a robust process around this. Currently there are validation rules in place to highlight where old codes exist and prompt for code to either be updated or removed. Ramesh to look into rebate code options.

AMT CTPP/GTIN project update - Presented by Ramesh Rayer – see slides for detail. Will seek to provide an update from ADHA perspective in-between meetings or at the next meeting

Recipient Program Updates – None for this meeting

Additional Topics

Recipient Insights re 'API' Pilots/POC – Long Lam. API has significant potential to enable process efficiency, semi automation of a lot of the manual processes, etc. NPC API has limited application at the moment because the NPC has some improvements that still need to be implemented. Data Lake will provide an industry wide product catalogue. Initiatives such as using CTPP as reference codes facilitates links into other datasets to source alternatives (both direct and therapeutic). The current process for sourcing alternatives is time consuming and manual. Having codes, etc. will mean that automated referencing of codes can suggest alternatives without having to rely on pharmacist. API will allow reps to find alternatives for particular products (used in conjunction with things like macro-enabled workbooks to provide information on products).

Testing has shown significant improvements in efficiency from implementing these types of process e.g. in sourcing cheaper products. Current manual processes provide no time to consider alternatives and people just purchase what is front of mind.

Potential for all health services and reps to use and access NPC to get this information.

Suggestion of forming a small group to further discuss the use of APIs.

ANZHPR – Health Jurisdictions collaboration re NPC and Data Quality – Kamlesh Lai – The need for complete and accurate data has never been more important. Jurisdictions are looking for benefits from increased automation, supply chain surety, etc. and are undertaking strategic reviews of supply chain information. Suppliers will be requested to supply data via the NPC. Benefits of providing accurate master data:

- Streamline processes
- Reduce manual rework
- Faster payment processing
- Ability to implement EDI
- Improved outcomes for patients
- Ensure the right product, in the right place, at the right time
- Elimination of waste
- Automation of processes
- Recall management
- etc

NPC & AusUDID – progress in project to enable suppliers to use NPC to allow data to flow to TGA around to support implementation of AusUDID. Will reach out to users to participate in pilot and to get feedback. Cath Koetz happy to engage one-on-one with interested parties.

Reimagining deliverables – Detailed discussion

Reimagining NPC for Healthcare – Progress Overview, Project Plan and updates

Detailed analysis carried out within the GS1 team to determine best approaches to the actions/issues raised during the 'Reimagining' review process in 2021. Apology for the delay in coming back to the HCNPCAG with details, however this process has taken some time in order to ensure that we had right sized and prioritised suggestions for the sector consider. Summary of the proposed solutions and delivery dates were provided as a pre-read ahead of the meeting and will continue to be provided as a project update to help track progress of the actions.

- **Updated Use Cases Item 12.2** (refer pre-read: Standardised Data Use Cases) – Cath Koetz. **Action: feedback invited till 25th May.** Initial suggestion to remove covid references and make more generic.
- **Value Propositions Item 12.1** (refer to pre-read: Value Propositions) – Mark Blitenthal. **Action: feedback invited till 25th May.**
 - Peter Wilson – suggested these be shared again separately?
- **Online User Interface improvements (Items 1.1, 1.3)** – Justin Middleton/Mike Lee. Showcase of NPC Xpress platform to provide insight into planned future improvements for suppliers. Positive initial feedback. Suggestion for a further, more detailed demonstration and discussion of how this should be implemented for healthcare to be scheduled in future as planning to create commence – sector will have input. **Action: Meeting to be scheduled with interested user community members in future date TBC (NPC Product Management).**
 - **Question** asked re whether this will provide improvements for recipients (Elizabeth Donohoo), and though they are related this platform is focussed on suppliers and separate improvements for Recipient UI will be presented at future meetings.
- **Pricing Update (Item 2.1)** – Ramesh Rayer. Confirmed pricing is able to be updated without updating item data as long as the item has been published to a recipient already. Agreement by group to close this item
- **Interim Load (Item 2.2)** (refer pre-read: Interim Load) – Murray Robb. Provided high level overview of the need for Interim loading. Further discussion needed within the sector stakeholders to determine next steps and possible more detailed solutioning. **Actions: Working group to be formed. Call for nomination for participants to follow meeting. Group to provide detailed recommendation to the next HCNPCAG for sign off. (WG owner – Murray Robb)**
- **Distributor data loading (Item 2.3)** (refer pre-read: Distributor Data Load) – Murray Robb. Provided high level overview of the need for a change to how distributors (non-sponsors) are required to provide data via the NPC to help eliminate unnecessary duplication of effort and confusion where data does not match between

sponsor/supplier and their distributors. Further discussion needed to unpack issues and define a solution. Kamlesh Lau supported this - keen to improve supplier data from big distributors. **Actions: Working group to be formed. Call for nomination for participants to follow meeting. Group to provide detailed recommendation to the next HCNPCAG for sign off. (WG owner – Murray Robb)**

- **Proposed simplification of 'Ready' process (Item 3.1)** (refer pre-read: Ready process) – Deborah Prince. Proposed solution to remove recipient specific 'Ready' process in place of industry 'Ready' as the review is identical for all recipients due to the industry dataset. Allowance can still be made for additional ready steps if a recipient requires for a particular reason. The proposal was put to the HCNPCAG for a vote via Poll - 100% support for simplified ready process. **Action: The change to the ready process for healthcare will implemented as quickly as possible. Update to be provided at next HCNPCAG (Deb Prince)**
- **Use of NPC in Tendering (Item 4.1)** – Murray Robb. Further analysis of the request is needed and therefore the establishment of a sub-group with representatives from all stakeholder groups is suggested. **Actions: Working group to be formed. Call for nomination for participants to follow meeting. Group to provide detailed recommendation to the next HCNPCAG for sign off. (WG owner – Murray Robb)**
- **Increasing NPC data access flexibility via API (Item 5.1)** – Justin Middleton. Existing API (within NPC) capability presented. Sector suggested that they would like to see JSON output and to be able to use search/seek using more than GTIN and GLN. Examples provided included ARTGID and UNSPSC. **Action: Cath Koetz to provide opportunity to provide feedback in the follow up to the meeting.**
- **Increased ITEM data availability via proposed 'Data Lake' (Item 5.4)** – Keith Lai. One of the suggestions GS1 have is for a whole of sector data lake to be created to allow for suppliers to publish Item data into one place for all recipients to access & search. Requirement for individual publishing would remain required for pricing to be published (due to secure nature of pricing) however for ITEM master the data is common. Primary advantage would be that more users could access and use suppliers data, this would also allow for sector specific API or other more flexible user interfaces to be created to help with accessing of data across all recipients. The concept was put to the HCNPCAG for a vote re support for GS1 to pursue this further via Poll. 100% support received to continue with this. Reinforcement that this would address issue with need to access ALL product data. **Action: NPC product management (Justin/Keith) to provide further updates on plans re this at next HCNPCAG. Sector stakeholders to be included in consultation where needed to refine requirements.**
 - **Question** re whether this is the same as the proposed change to the 'Ready process'. The 'Ready' process is designed to help ensure data meets defined minimum requirements before suppliers publish to any trading partners, whilst the sector 'Lake' is designed to help all recipients to access the data. The two will certainly be related once the lake is in place but the change to the ready process will immediately reduce the cost and time for suppliers and should speed up their ability to share data with all trading partners using the NPC
- **Development of additional In-system communication (Item 8.2)** – Cath Koetz. Proposal to close this. To be taken offline for vote due to time constraints
- **Improve speed of Dataset Reviews (Item 13.1)** – Cath Koetz. Proposal to close this. To be taken offline for vote due to time constraints

Any other business/Topics – Peter called for a subgroup to collaborate on UNSPSC use in the sector and how to improve it. **Action to be taken by NPC team (Ramesh/Murray) to analyse V19 and newer versions to support further discussion. Pending results a small sub group will be formed to discuss further and report back to HCNPCAG at the next meeting.**
