  plates not approved. Any major change to the label/plates may require re-submission for compliancy review.
- The Project i-Trace Barcode Certification will remain current for the earlier of two years from the date of certification or, in the event of a change to the applicable standards, up to six months after the date of applicable standards change. Re-certification can be requested and delivered upon payment of the then current fees.
- Certification of Project i-TRACE Barcodes only entitles the organisations developing, distributing or using the certified versions of the label/plates to represent that the barcode samples are certified and not the organisation or its team members or partners. The organisation warrants that it will only use the certification marketing seals granted to it for the purpose the seals were intended
- GS1 does not warrant that any Project i-TRACE Barcodes will be fit for purpose or compliant with the standards, that the standards will not change in the future requiring further certification, or that the organisation seeking certification will derive any material benefit from such certification.
