2.4 Introductions and Attendance (Quorum)

Delivered by Melanie Wishart , as the chair (proxy) for the meeting.

Melanie welcomed the new participants. Mickey Smith has left the business and Thomas Carter has commenced as the new Food Recall Coordinator at Food Standards Australia New Zealand (FSANZ), for all food recall-related enquiries. Thomas was unable to attend the meeting and James Valentine and Sabrina stepped in today on behalf of Thomas at FSANZ.

Dr Geoffrey Annison – from the AFGC has retired and we will be contacting another representative from the AFGC to join the group.

There was a total of 18 attendees, and this did meet quorum. Quorum specifies 10 participants - 2 receivers and 5 suppliers.

The meeting was recorded, and this was communicated to the group



2.5 Review of Past Meeting Actions

We are reaching out to Vic Dairy and will provide an awareness and overview campaign to all dairy regulators on GS1 Recall and mock recalls

2.6 Current Position of Recall Service

Report Summary of the current position of the Recall Service - delivered by Chris Drougas.

- Subscriber Onboarding 97% live (10 outstanding). The benchmark is 20 so this is a good result
- Mock notifications excellent, shows companies are keeping on top of training and annual ready/live process. From June to December 2022 there were 167 mock recall notifications.
- 4 Recalls listed on FSANZ site Q1 TD 2023. None from the recall subscribers.

2.7 Recall Development Roadmap

Roadmap update - delivered by Chris Drougas, GS1 Australia

- There are 3 releases planned for 2023 and one to be prioritised R1 for April $1^{\mbox{st}}$ 2023
- The next release is booked for July-August, and we are the process of finalising what these requirements will be.
- In April there are 9 Requirements due for development. The main changes include:-

Correction Mode

There will be a new enhancement build that allows you to correct the notification without issuing an update. If a notification is already live and has been issued and a minor amendment (Correction) is required, this can now be done without creating a second copy



of the notification. The recipient of the notification can see the changes at their end but will not receive a second email. If FSANZ information is changed they will be notified, but recipients are not.

Annual email reminders

Annual email reminder will be issued for those companies that have expired certifications and are therefore not 'Recall Ready" or active in the platform and still paying fees for the service.

Non-Subscriber Guest Portal

If you send notifications a to non-subscriber of the portal and add their email address, the company gets an email PDF that they can download. If they require more detail, they have to do so outside of the portal. This new enhancement means that they can view the notification and communicate via the portal. This provides many benefits for both the initiator and for the non-Recall subscriber.

Updated Item Reporting.

Updated table for item reporting for better user experience – items displayed more clearly and responses are more easily logged.

The Recall roadmap for 2022 releases, and completed enhancements can be reviewed in the Advisory Group meeting presentation and included in detail in the presentation appendix.

2.9 Guest Speaker – Leah Williamson, Own Brand Product Compliance Manager, Quality & Technical Standards Coles and Co-Chair of the Advisory Group

Our co-chair Leah provided a very in-depth presentation on Covid related issues, food safety, food safety culture, supply chain resilience and food fraud. Leah provides a summary of these issues in the new 2022 GS1 Recall "Year In Review".

Leah shared many useful tools and resources, critical to building food safety and food defence plans as well as carrying out hazard analysis and risk assessments for your businesses and supply partners.

3.1 Marketing, Events and Comms

• Year in Review report 2023

Tracey advised that the 2023 Recall Year in Review Report is now available. Produced by GS1 Australia, the report includes articles from Leah at Coles and HACCP, as well as a look into what the future holds for product recalls. • GS1 Global Forum

Melanie provided an update on the recent GS1 Global Forum. It was the first hybrid global forum to celebrate 50 years of the barcode. There was a total of 2,521 participants from 111 countries. 897 in person and 1,624 virtual – the main focus of the forum was the Global transition to the 2D barcode and Melanie recommended viewing the Retail Plenary Session to find out more.

NGTAG Open Industry Event

Melanie provided an overview of the NGTAG open industry "Traceability For Biosecurity". This was held on Tuesday 28th February.

GS1 Australia and the National GS1 Traceability Advisory Group (NGTAG) are committed to working with government and industry to provide practical pathways for enhanced national biosecurity and traceability.

This session yesterday featured a presentation from DAFF on the national biosecurity strategy and how it relates to the national traceability strategy. We also heard from the Executive Director of Biosecurity Victoria and the Chief Biosecurity Officer at QLD Government on their biosecurity plans and how they must link to traceability capabilities.

6.0 GS1 Australia Limited Trade Practices Compliance Notice

Participants on GS1 Boards, committees, task forces, work groups, or other similar bodies, must always remember the purpose of the Board, committee task force, or work group is to enhance the ability of all industry members to compete more efficiently and effectively to provide better value to the consumer or end user. GS1 activity almost always involves the cooperation of competitors; therefore, great care must be taken to assure compliance with trade practices laws in Australia and in other jurisdictions. (Including the Australian Consumer Law, the Competition and Consumer Act and state based Fair Trading Legislation).

This Means:

- Participation must be voluntary, and failure to participate shall not be used to penalise any company.
- There shall be no discussion of prices, allocation of customers or products, boycotts, refusals to deal, or market share. (For the avoidance of doubt, this does not preclude discussion of GS1 Australia's prices, customers or products.)
- If any participant believes the group is drifting toward impermissible discussion, the topic shall be tabled until the opinion of lawyer(s) with experience in trade practices law can be obtained.
- Where appropriate, meetings shall be governed by an agenda prepared in advance and recorded by minutes prepared promptly after the meeting.
- Where appropriate, tests or data collection shall be governed by protocols developed by GS1 Australia.
- GS1 reserves the right to seek opinion of lawyer(s) with trade practices experience on any matter or document arising out of any GS1 activity.
- The recommendation coming out of a GS1 Board, committee, task force, work group or task group are just that. Individual companies remain free to make independent, competitive decisions.
- Any Standards developed must be voluntary standards.
