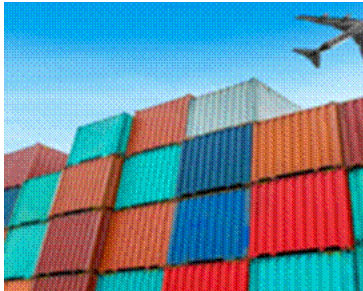


## EU Guidance for Legacy Devices published
