3.0 Setting up a Price Relationship for Woolworths

Before entering prices for Woolworths, please contact NPC Customer Support to set up a price relationship. The price relationship consists of your 'Retailer Vendor ID (8 digits) – Subrange (4 digits)'. Example: 20012565-0000, 20012565-0001, 20012565-0002...etc.

For suppliers using Certified Product Partner's software, please contact your software provider to set up a price relationship.

If you do not know your Retailer Vendor ID and Subrange, this information can be obtained from the Woolworths NPC Team by emailing them on npc@woolworths.com.au.

4.0 Pricing Elements for Woolworths

- Woolworths require a LIST_PRICE for all products on the orderable GTIN level.
- Woolworths support a deferred deal allowance (DEFERRED_DEAL_1),
 Off invoice allowance (OFF_INVOICE_DEAL_1) or a miscellaneous
 allowance (MISCELLANEOUS). These are known as Article level
 allowances because they apply at the Article level. Woolworths support
 the following Article level charges, CDS on invoice (CONTAINER) or CDS
 deferred (DEFERRED_CONTAINER), FREIGHT or MISCELLANEOUS.
- **Do not show Warehouse and Ullage allowances** against the trade item as these are Vendor level allowances for Woolworths. They are not required to be loaded on the NPC.
- Pricing is not required for Rental Products (e.g. carpet cleaning machines) or Promotional Products (e.g. a free mug with every purchase). Only item data information is to be entered on the NPC for these products.

5.0 Steps to Adding New Prices for Woolworths

Before loading a new price for Woolworths, please ensure that relevant price agreements are in place and have been approved by the relevant Woolworths business team (Category Manager/Category Assistant). The negotiation and approval of new prices is managed outside of the National Product Catalogue (NPC).

1.	Determine how your product is ordered by Woolworths.
	 If your product is <u>ordered</u> by carton then you must enter pricing against the CASE GTIN on the NPC.
	• If your product is <u>ordered</u> by each, then you must enter your pricing against the BASE GTIN on the NPC.
2.	Determine how your product is invoiced.
	 If your product is <u>invoiced</u> by carton, then you must enter the price value and price basis quantity for the CASE GTIN.
	• If your product is <u>invoiced</u> by each, then you must enter the price value and price basis quantity for the EACH GTIN.
3.	Determine the agreed allowances and charges which apply to the product.
	Some agreed article level allowances/charges are paid post invoice cost, in settlement. These still need to be shown in the NPC as an Allowance/Charge.
4.	Check if your pricing is a National or State based price.
	 If your product is <u>distributed nationally</u> and <u>the cost is the same for all states</u> you would only need to enter a single National List, Allowance/Charge for your product on the NPC. If your product is <u>distributed to specific states only</u> and <u>the cost is the same for all the specified states</u> you would only need to enter a single National List, Allowance/Charge for your product on the NPC.

- If your product is <u>distributed nationally</u> and <u>the cost differs for some states</u> you would need to enter a National List, Allowance/Charge (for each state that have the same cost) as well as a State specific cost for the states that differ from the National cost for your product on the NPC.
- If your product is <u>distributed to specific states only</u> and <u>the cost differs for some of the specified states</u> you would need to enter a National List, Allowance/Charge (for the states that have the same cost) as well as a State specific cost for the states that differ from the National cost for your product on the NPC.

5. Check the agreed distribution channel for your product.

In some cases, you may supply the same article nationally via a Distribution Centre (DC) and Direct Store Delivery (DSD). Where the price values are the same for DC and DSD – a single national price must be supplied for DC against that product. Where the two are different - the national DSD price types must be captured by state (List with applicable allowances) and you must also provide a national List for your DC prices.

6. Enter New NPC Prices

Once you have determined which elements need to be applied to your prices, the next step is to enter the prices on the National Product Catalogue (NPC). You must release all price elements (List, Allowances/Charges) together.

Prices will be rejected by the Woolworth's system if they are not released together.

Important Notes:

For a price that has yet to be synchronised by Woolworths (not accepted):

- You cannot change a released/sent price other than to end date it. For example, if you have forgotten to add an allowance, you will need to end date all prices for the article and then add the updated prices with the changes.
- You can however, make changes to the price while it is still in 'Working' or 'draft' state.
- If you make a mistake with prices and you have released them already, please do not end date the incorrect price with the same day as your start date. The end date must be in the future.

Please refer to **Section 7** (below) before submitting a **Price Change** for a synchronised (accepted) price.



6.0 Woolworths Pricing Examples

There are three different pricing scenarios that you may encounter for your products. Please refer to the examples below.

- Basic Woolworths Price
- State Based Pricing
- National DC & DSD Pricing

6.1 Basic Woolworths Price

6.1.1 Example 1

- Your product is <u>ordered by carton and invoiced by carton</u>
- Your product is supplied nationally via DCs
- Your product has a warehouse allowance of 5% which is **not** a requirement to show on NPC.
- You have a standard deferred deal allowance of \$5.00.

Important Notes:

- 1) Whenever a State Price is added on the NPC, an accompanying National Price must also be added.
- 2) List prices must be entered for each state individually, even if the dollar values for those states are the same, otherwise the National Price will be assumed for the state incorrectly.
- 3) State prices must have the following fields entered: 'Reference Document ID' = EXCEPTION and 'Reference Document Description' = EXCEPTION_PRICE.
- 4) If an Allowance/Charge applies to a National Price but does not apply to the State Price, an Allowance/Charge record is still to be added in the State Price but with a **zero value**.

- 5) For additional information on CDS Charge, please refer to the Container Deposit Scheme (CDS) Quick Guide
- 6) You may have regional prices (e.g. Far North Queensland) applicable to an item. In this instance, use the 'Alternate Location Grouping' attribute to specify the region. Please clarify the code list for your region with your Woolworths Buyer team before entering prices. **Do not** enter a value for 'State' if entering a value for 'Alternate Location Grouping'.

6.3 National DC and DSD Pricing

- Your product is ordered by carton and invoiced by carton.
- Your product is sold nationally through DC
- Your product is sold in VIC with a DSD price that is different to the national DC price
- Your product has a warehouse allowance of 5% which is **not** a requirement to show on NPC.
- You have a standard off invoice allowance of 5.00.

7.0 Price Changes

For synchronised prices (accepted), **Woolworths requires all suppliers to submit price changes (increases or decreases) via the Partner Hub 'Price Change Submission' module**. The only exception to this requirement is detailed below.

Unless submitting a price change for one of the exception scenarios, suppliers must <u>not</u> enter a price change via the NPC. For more information, refer to <u>Grocery Code</u> – <u>Price Change Submission NPC</u>

7.1 Exceptions - Price Structure Changes

The Partner Hub 'Price Change Submission' module must be used for all price changes unless,

- Adding a new State based Price
- Adding a new Distribution Method



Steps To Change Initial Price Record (Before Synchronization) For Woolworths

1.	Ensure that the price structure has been agreed with your trading partner before updating the NPC. Price changes must be made typically 12 weeks before they are due (as per Woolworths' requirements)
2.	End Date all existing prices for your article. Ensure that the same date is entered for the whole price structure.
	Important Note: End dates cannot be the same as the start date of the product. DO NOT RELEASE or send the end dated prices ahead of your new price changes. If changes to existing prices and addition of new prices arrive separately in Woolworths' system, these records will get rejected. 'Save' the changes until you have finished adding new prices and then you may release them together.
3.	Add the new List Prices (Refer to below Examples).
	A copy of the existing List Prices, with current price values, are to be added with a new start date. Add a new price record for new pricing structure (i.e. new state price or new distribution method price) including relevant allowances/charges.
	Important Notes:
	• The end date of existing prices and start date of new prices should fall on consecutive dates. For example, if you end date the existing prices on Sunday, 18 th June, the start date of your new prices must be Monday, 19 th June.
	• If an Allowance exists for an existing National Price Record, you must ensure that an allowance record is loaded for each new price record even if no allowance applies. If there is an allowance to the new price, then you may add the appropriate value. If no allowance applies to the new price, then you are still required to add an allowance with a \$0 value.
4.	Check your prices prior to releasing/sending to your recipient.
	You must release all prices together (old and new) to avoid Woolworths' System rejecting the updates.
	Important Note: Once you release a copy of existing prices, be careful to change prices to up to date values (the value shown in Partner Hub).
5.	When your buyer accepts the price change you should see a confirmation message against the new state or distribution method price record with a status of 'SYNCHRONISED'.

Important Note: A 'REVIEW' status will be received for the existing price records (other than the new state or distribution method price record). This is expected behaviour when updating 'SYNCHRONISED' price records for Woolworths.

Important Note:

If you wish to add a new State based or Distribution Method price record **and** wish to update an existing price record(s) (i.e., this change has not yet been submitted via Partner Hub), please contact your NPC support team for assistance.



Steps To Add Distribution Method Or A New State Price For Woolworths
