Transport EDI Software Certification

- Complete the transport standards certification form and email to freight.logistics@gs1au.org
- A GS1 EDI Consultant will be assigned to discuss the certification process.
- Develop the relevant XML transport message template (as per [Australian Transport EDI Guideline](#)) into your solution.
- GS1 EDI Consultant will specify various transport scenarios and request XML message samples. You will also need to provide examples, ie, screenshots demonstrating your software's ability to process the message.
- Review of XML files and reports/screenshots showcasing ability to process EDI messages is expected to be completed in 4 – 8 working days.
- Upon completion of testing, an invoice will be issued to the company and nominated contact. Upon receipt of payment, the Product Certification Certificate and logo will be sent via email.
