- Subscriber onboarding 97% live (10%)
- (New) Mock notifications tracking well, shows companies are keeping on top of training and annual ready/live process
- 16 recalls listed on FSANZ site, 1 Recall subscriber has issued via Recall

2.7 Recall Development Roadmap

Roadmap update - delivered by Chris Drougas, GS1 Australia

- 2 releases per year
- Nov 20th Deployment for R2 2021 was successful
 - Workflow in the Food & Consumer Goods portal and updates to post recall reporting for FSANZ have been updated to be more closely aligned to the FSANZ Recall Report
 - o Tweaks to Item area allows select multiple, faster load times
 - Can save and come back at a later stage, error log displays missing information
- R1 2022 scheduled for 26 March
- R2 2022 locked down for September 2022
- The Recall roadmap for 2022 releases, and completed enhancements can be reviewed in the Advisory Group meeting presentation and included in detail in the presentation appendix

2.8 Issues / Challenges / Opportunities

Dr Geoffery Annison – AFGC asked if we send out surveys for feedback for the Recall enhancements

Chris advised that every 6 months we send survey of requirements for the future releases and ask community to vote on those and prioritise for the development. We also ask for other feedback for additional requirements.

There was a discussion around the growth strategy and how we can increase the use of the recall portal



There was a suggestion to contact those that have conducted recalls via FSANZ and ask them why they didn't use the portal. Chris advised that this is a good idea, however, a sensitive issue.

Andrew Steele – GS1 advised that there is currently engagement in the foodservice sector and QSR with discussions underway with IPCA/subway and McDonalds as well as the 5 major foodservice distributors in Australia. This new engagement will be added to the next Recall AG agenda as it may provide opportunities for the participants in the group.

Andrew Steele advised that Woolworths' 2D barcodes with batch/lot and date code will be able to do much more targeted recalls at the POS as well as provide a lot more opportunities to send suitable affected products to Foodbanks. 28-30% recall is due to labelling issues. By March 2022 Woolworths are hoping that there will be some additional product categories that will implement GS1 2D Barcodes (GS1 DataMatrix). These are the companies that are currently already printing 2D barcodes on their products, including packaged fresh produce and some dairy products.

GS1 will invite Woolworths to provide an update on this in the March 2022 meeting.

FSANZ Update

Michael Smith – FSANZ. FSANZ is still reviewing the Food Industry Food Recall Protocol. Due to resourcing, changes and evolving priorities, the release of the updated protocol is delayed. We do not have an anticipated time at this stage, however it is likely to be late 2022. Michael will be happy to provide an update at the next meeting in 2022.

ACTION: GS1 to reach out to Foodbank and ask for clarification on the Charities Act and re-labeling requirements for Foodbank.

3.0 Guest Speaker

Carolyn Dennis QA Manager at Peters and Co-chair of Recall Advisory Group provided an overview and demonstration of the GS1 Recall Platform

Carolyn advised that smaller companies may not be aware of the GS1 Recall and that quality is sometimes in the back seat for these businesses. They may not implement anything until they need it. Recall bootcamps are a great resource to bring awareness to the platform. Carolyn uses the platform for training within Peters and involves others in the business to ensure that they can use it in her absence. "It's a systematic way of showing what a recall would entail". She also provides an overview to senior management and advises certifying bodies and private label partners that they use the platform to prove they are ready should a recall or withdrawal occur.

Carolyn provided a demonstration of the portal and showed how initiators and recipients can access the mock recall.

- GS1 provided a comparison between Recalls in on FSANZ webpage, vs usage of portal and subscribed Recall portal users. GS1 will continue to maintain this comparison on an ongoing basis.

GS1 advised that the revised traceability framework GTS2 has been ratified and released. In addition, GS1 has also ratified and published a generic industry sector traceability guidelines template document and a guideline for Fish Traceability (Europe) which can be used as a sample of a completed and ratified sector-based traceability guideline.

Association involvement – ACCC has asked to be removed from the Advisory Group invitations.

• GS1 will continue to send meeting minutes as a courtesy.



It was noted that the release timeframes provided too short notice.

 GS1 have negotiated longer timeframes for UAT with developer allowing users time to book UAT session in their calendars. GS1 has negotiated longer UAT period

GS1 will provide data and stats as pre reading work to shorten the duration of reporting. GS1 will only report on highlights and anomalies if required.

New feature demonstrations/presentations on industry topics maybe added to forums

Stakeholders were in favour of reviewing a message of support or endorsement for the portal. GS1 Aust. will draft up the sample endorsement for review. This endorsement will be used as information for potential and new users, also existing users to reaffirm their engagement with the system.

- The Recall Endorsement letter has had 10 positive responses; 3 customers have advised they will not (main reason is these companies usually don't endorse products or services outside of their company range) and11 companies are yet to formally respond.
- \circ GS1 will use the endorsement as it currently has 10 supporters
- GS1 to include this endorsement as part of the onboarding of significant new subscribers (e.g. Caltex)
- Endorsement letter is now "in production" however stakeholders can be added at any time

Foodbank update – In December 2018 / January 2019, GS1 and Foodbank will discuss impact of discussions held by Michael Davidson (Foodbank) and other AG Members such as Simplot. Effort is still required to further understand the operational process when a donation occurs. And to also explore the different process that occurs for undeclared allergen versus foreign matter contamination.

- GS1 And Simplot to review above in January; findings to be tabled at AG in June
- GS1 has added the Foodbank contact details within the portal to enable users to directly contact foodbank in addition to them receiving the notice.

GS1 will be providing facilities for the AIFST workshop on product recall in Melbourne on 28 February 2019 – Relevant guest speakers will be completing a briefing before the meeting and Recall will be a feature within the workshop.

 AIFST event was successful with Fiona Fleming, (AIFST) Andrew Brown (GS1) and Peter McGee (Victual) presenting. GS1 have started discussions for opportunity to hold the event around Australia on a regular basis.

GS1 were well received at the presentation for the NRA product safety technical committee in October. Discussions around contacting consumers via publications and newspapers occurred. The case study from WD-40 has been published and was distributed at NRA conference.

7.0 Trade Practices Compliance Notice

Participants on GS1 Boards, committees, task forces, work groups, or other similar bodies, must always remember the purpose of the Board, committee task force, or work group is to enhance the ability of all industry members to compete more efficiently and effectively to provide better value to the consumer or end user. - If any participant believes the group is drifting toward impermissible discussion, the topic shall be tabled until the opinion of lawyer(s) with experience in trade practices law can be obtained.
- Where appropriate, meetings shall be governed by an agenda prepared in advance, and recorded by minutes prepared promptly after the meeting.
- Where appropriate, tests or data collection shall be governed by protocols developed by GS1 Australia.
- GS1 reserves the right to seek opinion of lawyer(s) with trade practices experience on any matter or document arising out of any GS1 activity.
- The recommendation coming out of a GS1 Board, committee, task force, work group or task group are just that. Individual companies remain free to make independent, competitive decisions.
- Any Standards developed must be voluntary standards.
