## Update:

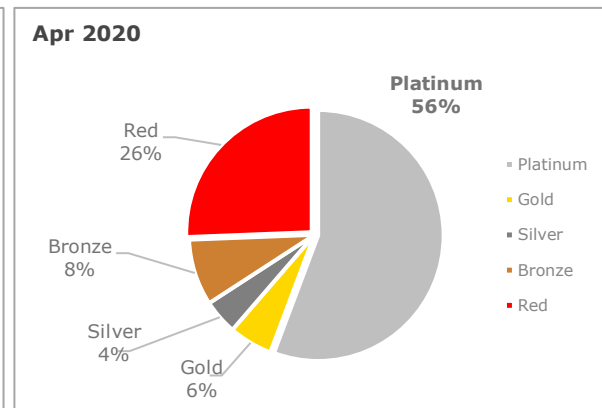
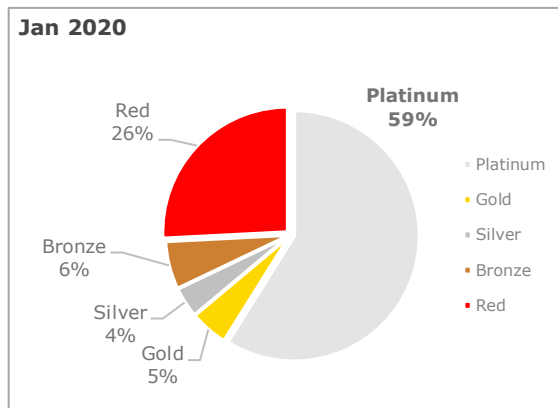
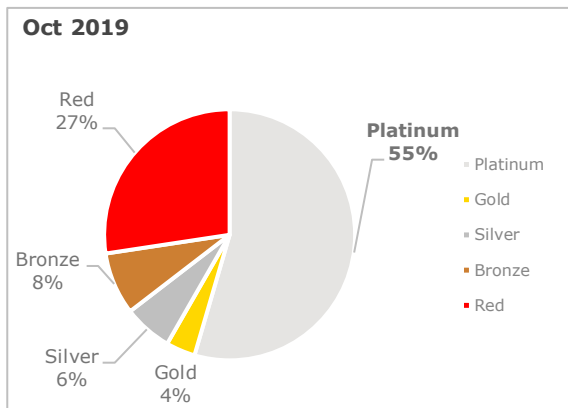

# Australian Medicines Terminology



Activity led by Australian Digital Health Agency National Clinical Terminology Service (NCTS)

## Objectives:

- Transition from manual mapping process
- Ensure that all medicinal products have an assigned & validated AMT CTPP linked to the products GTIN to enable accuracy across patient medication management processes

## Current state:

- S3, S4, S8 Consumer packs in NPC = 9,838, current AMT CTPP 3,656 (37 suppliers)

## Planned:

- Engagement from ADHA continues, automated prompts/data quality checks to be implemented

# Global Data Sync – Major updates Healthcare



## Background:

- Regular global releases occur within GDSN to meet changing global requirements
- Global Healthcare leadership team (industry stakeholders) decided that limiting changes to GDSN for Healthcare was necessary due to global nature of the sector
- Changes identified at local level not already available in global model can be implemented locally but roll into global release on an annual basis (though may be available sooner)
- Many local updates are already available in global so do not require major release development

## Key updates:

- EUDAMED data requirements scheduled for inclusion in next HC release
- Several other new data fields may be suitable for AU as replacement for local attributes (to help align further to global model) – will be raised in dataset review
