Purpose

The GS1 Australia Traceability Solution Validation is available to GS1 members, organisations and solution providers that offer traceability solutions to the Australian marketplace and industry sectors.

The service delivers validation that the GS1 system is correctly implemented within a solution and is using the most adequate GS1 standards i.e., numbering, barcoding, labelling, **AIDC**¹, **RFID**², **GDSN**³, **EDI**⁴, **EPCIS**⁵ and **CBV**⁶, **GTS**⁷ etc.

This helps GS1 members, organisations and solution providers evidence that a traceability solution adheres to and complies with the GS1 system and GS1 traceability standards and meets a minimum set of criteria required for the solution to be considered a validated GS1 traceability solution, suitable for the purpose of internal and external product traceability.

Solution Validation comprises two (2) parts:

- **Part A** - Traceability Solution Self-Assessment
- **Part B** - Traceability Solution Validation (Details not included in this guide)

Part A: Traceability Solution Self-Assessment

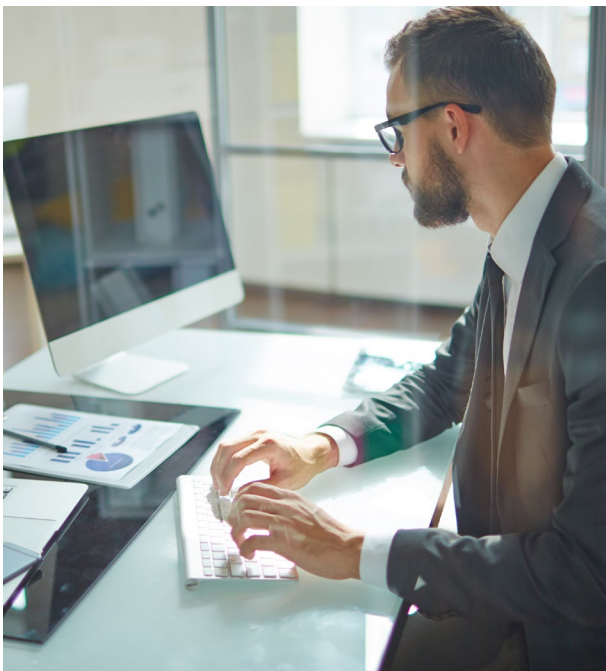
The Self-Assessment Tool™ is used to complete and submit the on-line Self-Assessment Form.

The Self-Assessment Form contains criteria and questions to the collection and submission of information. The results of the Self-Assessment Review are also provided to the submitter using this form.

Self-assessment serves two purposes. Firstly it helps the submitter to recognise and understand the current capabilities and performance of their solution against the GS1 System and GS1 Traceability Standard requirements. Secondly it acts as a learning exercise for the submitter to gain a better appreciation of global standards.

The criteria and questions do not cover every possible traceability solution implementation scenario. They do however provide a framework and foundation from which additional questions can be formulated.

Not every criteria and question is relevant for every traceability solution, therefore, criteria and questions should be selected to best fit the solution for which the self-assessment is being undertaken.



Self-Assessment Process

A. Initial Discussion

A GS1 member, organisation or solution provider contacts GS1 to take part in the solution validation process by downloading the online form on the [GS1 website](#).



B. Self-Assessment

The Self-Assessment Form is provided to the submitter for completion in conjunction with the assessment criteria and questions.



C. Self-Assessment Form Submission

The Self-Assessment Form is submitted electronically to GS1 Australia for review.



D. Self-Assessment Form Results

The validation summary and self-assessment results are returned to the submitter.
