# **ELIGIBILITY CRITERIA**

- 1. Groups or organisations must be located in The Tweed Shire and deliver their project, initiative to residents of the Tweed Shire.
- 2. Applicants must be either a not for profit community based group or organisation, a school P&C Association and/or a non-government organisation. Note: P&C school projects must demonstrate benefit to the broader school community, and not be for curriculum delivery.
- 3. Applications must be complete and submitted on this official Application Form.
- 4. Applications must be received by 5pm on Sunday 21st September 2025.
- 5. Projects, initiatives, purchases must be completed and acquitted within 12 months of receipt of funds.
- 6. Applicants must agree to acquit the grant.

- 1. Applicants must meet all eligibility criteria.

# **PRIVACY**

- 6. We will contact you about future ITV TCIF funding rounds unless you have specifically requested that you're not to be contacted regarding future funding opportunities.
- 7. By completing and submitting ITV TCIF grant submission, you consent to the information you provide being used for the above purposes.
