## MAXIMIZE YOUR EDUCATION

ITC Seminars' International Live Patient Programs are customized and tailored to meet the needs, goals, and interests of each individual doctor. Upon registration, you will receive an online surgical survey that evaluates your experience and skills in oral implantology. Within the same survey, you will also have an opportunity to fill out a checklist with all of the different types of procedures that you would like to perform during the live patient program. Based on the results of the online surgical survey, our instructors will select the specific cases/patients for you. This way you can focus on the areas you need the most practice on.

## WHAT TO EXPECT ON THIS SEMINAR?

You will perform dental implant placements, related surgeries and bone grafting procedures under our supervision for 5 full days. In order to maximize your learning experience, we limit the number of participants to 8 doctors per live patient program.

You will encounter various kinds of dental cases and surgical situations. Therefore, the number of implants you will place will depend on your skills and the cases you choose to approach. Thus, if you select a case that requires ridge splitting, sinus lift, bone grafting, etc., you may spend an extensive amount of time performing other techniques or procedures that may compensate for the time you could be placing dental implants.

Every morning before the program starts, we have a short lecture and a meeting with all the doctors to evaluate and review the treatment plan for the patients that you will be treating that day. In that moment, with the X-Rays in hand, we evaluate the case and decide the best treatment plan and approach for each patient.

## FACULTY

You will have the advantage of being trained by a faculty that has overseen over 25,000 dental implant procedures (oral/maxillofacial surgeons and Doctors of Dental Surgery); they have been involved in dental humanitarian missions for more than 15 years.
