Generac Grid Services \$2,500 ConEd ecosave Rewards Promotion OFFICIAL RULES (the "Official Rules")

- **1. Promotion Period.** This promotion (the "**Promotion**") begins at 12:01:01 AM ET on March 1 and ends at 11:59:59 PM ET on September 30 of the program year (the "**Promotion Period**").
- 2. Eligibility. This Promotion is open to individuals who, at time of entry, are: (a) 18 years of age or older, (b) legal residents of New York, USA, (c) reside at a qualifying address, (d) agree to be bound by these Official Rules, and (e) have already agreed to participate in demand response events pursuant to the Programs Terms and Conditions, which can be found here. Eligibility for entry is subject to Sponsor's sole determination that an entrant is eligible to participate in a demand response program that requires the adjustment of the entrant's thermostat in connection with demand response events initiated by Demand Response Provider (DRP). Generally, eligibility is determined based on a number of factors including, without limitation, which utility provides the entrant's electricity, the entrant's residence location, the amount of time an entrant has been a customer with a smart meter, and Sponsor's ability to match the entrant's name with his or her utility account number. Employees, agents, officers, directors and members of Sponsor, its affiliates, distributors, advertising and promotion agencies and anyone involved in the Promotion's development or execution, and the immediate family members (meaning spouses, parents, siblings, children and their respective spouses, grandparents and grandchildren) and members of the households of such employees, agents, officers, directors and are not eligible to enter or win the Prize in this Promotion. Sponsor reserves the right to disqualify from this Promotion any person it believes has intentionally violated these Official Rules or the Program Terms and Conditions. Promotion subject to all applicable federal, state and local laws.
- **3. How to Enter.** To receive entries into the Promotion you must register to participate in the ConEd ecosave Program (the "**Program**). If you have already agreed to be bound by the Program Terms and Conditions, which can be found here, and you are accepted by Sponsor into the Program, you will automatically earn the chance to win the Promotion when you complete a Full Event. A "**Full Event"** occurs when there is any real or test demand response event, where your thermostat is connected to the ecobee service, and when you do not opt-out of that demand response event for the duration of the demand response event. If you withdraw from the Program on or prior to the end of the Promotion Period, you will not be eligible to earn the chance to win the Promotion. If you do not want to automatically earn the chance to win the Promotion when you complete a Full Event, please contact Sponsor prior to the end of the Promotion Period.

Eligible entrants will receive one (1) chance to win the Promotion for full completion of participation in one (1) Full Event. Completion of participation entails, when participating in a Full Event, each entrant agreeing to allow Sponsor to control his or her or their thermostat to reduce demand during a specified event period by increasing the current setpoint or scheduled target temperature setpoint in order to reduce electrical

demand. These setpoint increases may be preceded by "pre-cool" periods, wherein the current or scheduled target setpoint is temporarily decreased to prepare the premises for the subsequent setpoint increase. Additional details describing how demand response events occur can be found in Program Terms and Conditions, which can be reviewed here. Sponsor estimates that there could be between four (4) to eight (8) or more demand response events during each calendar year. If an entrant opts-out of a demand response event, the entrant will not complete the Full Event and will not earn an entry. Entrant may opt out of an adjustment at any time from his or her or their thermostat or through components of the ecobee service, such as the web portal and smart phone applications. In the unlikely case that a participant is opted out of a demand response event by Sponsor or ecobee and fails to receive one entry for the Promotion, Sponsor and ecobee will not be liable in any way. Entrants may opt out of the Program in its entirety by calling Generac Customer Support at 1-855-388-3148.

You must agree to be bound by the Program Terms and Conditions on or prior to August 1st at 11:59:59 ET in order to be considered eligible to participate in the Program and therefore earn the chance to win the Promotion. If you are accepted into the Program, all Full Events will earn you one (1) chance to win the Promotion. All chances to win the promotion must be generated by 11:59:59 PM ET on September 30.

- 9. Disputes; No Class Action Procedure. This Promotion is governed by the laws of the United States and the State of Wisconsin, without respect to conflict of law doctrines. Although the non-availability of any form of representative or class proceeding is clear from this Agreement, should any dispute arise regarding or relating to the existence, validity, enforceability, or interpretation of the Arbitration and No Class Action procedures provisions above, the federal court located in Waukesha, Wisconsin shall have the sole and exclusive jurisdiction to hear and determine the issue.

THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ANY DEMAND FOR ARBITRATION MUST BE FILED WITHIN ONE (1) YEAR FROM THE END OF THE PROMOTION PERIOD, OR THE CAUSE OF ACTION SHALL BE FOREVER BARRED.
