Introduction of the Guest Editor(s)

Professor Zhisheng Huang is a tenured senior researcher at Computer Science Department of VU University Amsterdam, the Netherlands. He is also a full professor at School of Computer Science and Engineering, Wuhan University of Science and Technology, China. His research interests include Semantic Web technology, knowledge graphs, and ontology engineering, Artificial Intelligence for medicine, and medical informatics. Prof. Huang has published about 300 papers in journals/conferences/workshops, served as a member of the programme/organising committee for over 200 international conferences/workshops. He is the Editor-in-Chief of *Journal of Artificial Intelligence for Medical Sciences*.

Professor Jiao Li serves as the Chief of the Center for Medical Informatics Innovation, Institute of Medical Information/Library, Chinese Academy of Medical Sciences/Peking Union Medical College. Dr. Li received her Ph.D. degree from the Department of Computer Science and Technology, Tsinghua University. She completed her postdoctoral training in the National Center of Biotechnology and Information, the U.S. National Institutes of Health (NCBI/NLM/NIH). Dr. Jiao Li's research interests include medical artificial intelligence, medical data mining, and knowledge engineering. As a principal investigator, she has conducted studies funded by the National Key Research and Development Program of China, National Natural Science Foundation of China and others. She developed computational methods for Chinese electronic medical record processing, disease-specific phenotype identification, clinical guideline representation, large-scale ontology construction towards precision medicine, etc. She has published more than 70 peer-reviewed articles and obtained 4 patents for invention. She has launched AI-empowered decision support system validation via collaboration with the clinical and health management professionals.
