POSITION DESCRIPTION

Convergence is currently seeking a Research Associate to support in the development of market intelligence and knowledge products. This role will be instrumental in further developing Convergence's intelligence and knowledge value proposition to members and is a unique opportunity to help grow an innovative start-up in the development finance space. The Associate will help build out key member offerings, including strengthening Convergence's database of past blended finance transactions, performing data analysis and research on the blended finance market, developing case studies on blended finance transactions, and working with knowledge collaborators in the development finance community.

RESPONSIBILITIES

The following comprises the core responsibilities of the Research Associate; however the scope will evolve over time to match the needs of a growing start-up. At the discretion of Convergence's senior management team, the Associate will also spend some percentage of her/his time supporting other member offerings.

- Develop blended finance intelligence and knowledge that provides actionable tools and insights aligned with our members' needs and interests, including data analysis, case studies, research, and webinars
- Deepen Convergence's database of past blended finance transactions, supporting data collection and validation activities, as well as identifying and working with data partners to improve the database and collect difficult-to-find data/information
- Produce analyses from the database that inform members of trends and benchmarks in blended finance, including data visualization, benchmarking, and comp sets
- Identify blended finance transactions to profile through case studies and prepare case studies through desk research and interviews with deal sponsors and their investors
- Create research reports and support the publication of thought pieces as prioritized by senior management
- Support the refinement of Convergence's strategy for advancing the field of blended finance through knowledge development, dissemination, and practitioner / investor convenings, and collaboration with other organizations
- Maintain Convergence's Knowledge Library of key industry publications and research
