Participants are automatically entered into the Sweepstakes when a participant: 1) registers for a Wellness Challenge AND 2) participates in the registered Wellness Challenge by logging an activity for that week. Participants are eligible to receive a maximum of one entry per week for each Wellness Challenge that participants meet the two criteria above, up to a maximum of four entries per Challenge Month. Participants may only win a maximum of one prize during the Sweepstakes Period, regardless of method of entry or entry through the KP EUTF Wellness Challenge Participation Sweepstakes, or the KP EUTF Wellness Challenge Goal Achievement Sweepstakes.
 - a.2. b.1. b.2. Participants are eligible to receive a maximum of one entry for each Wellness Challenge. Participants may only win a maximum of one prize during the Sweepstakes Period, regardless of method of entry or entry through the KP EUTF Wellness Challenge Participation Sweepstakes, or the KP EUTF Wellness Challenge Goal Achievement Sweepstakes.

You must provide all required information to be eligible to enter and win. All potential winners are subject to verification before any prize will be awarded. Sponsor reserves the right to disqualify any potential winner. By accepting their prize, the winner agrees to these Official Rules, including the use of their name, voice, and/or likeness for the purpose of announcing the winner of the sweepstakes without further compensation. Administrator will select the potential prize winners by a random drawing by Kaiser Permanente from all eligible entries received by the end of the Sweepstakes Period. 9. Governing Law; Binding Arbitration.

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with the Sweepstakes, shall be governed by, and construed in accordance with, the laws of the State of Hawaii, without giving effect to any choice of law or conflict of law rules (whether of the State of California or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Hawaii.

The parties each agree to finally settle all disputes only through arbitration; provided, however, the Sponsor shall be entitled to seek injunctive or equitable relief in the state and federal courts in Honolulu, Hawaii and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator any and all claims, controversies, or disputes arising out of or relating to this Sweepstakes, or the breach thereof, shall be fully and finally resolved by arbitration in accordance with the Rules, Procedures, and Protocols for Arbitration of Disputes of Dispute Prevention & Resolution, Inc., then in effect. In the event arbitration is invoked, the parties agree that one arbitrator shall be appointed to hear and resolve the case. The parties further agree that the award of the arbitrator is binding upon the parties and that judgment on the award rendered by the arbitrator may be entered in any court of competent jurisdiction. If an in-person hearing is required, then it will take place in Honolulu, Hawaii. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in Honolulu, Hawaii. The parties further agree that any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Sweepstakes, but in no event attorneys' fees, and under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, indirect, punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. Sponsor agrees to pay the administrative and arbitrator's fees in order to conduct the arbitration (but specifically excluding any travel or other costs of entrant to attend the arbitration hearing). Either party may, notwithstanding this provision, bring qualifying claims in small claims court.
