**2. OPENING AND CLOSING DATE:** This promotion opens at **00:01 on 16 January 2026 and closes at 23:59 on 20 February 2026** (the “Promotional Period”). Any entries made before the opening date or after the closing date will not be valid and will not be entered into this promotion.
