

TERMS AND CONDITIONS: WIN DREAMSEATS TO A GIG AT COOP LIVE

Entry instructions are deemed to form part of the Terms and Conditions. By entering this promotion all participants will be deemed to have accepted and be bound by the Terms and Conditions and to their details being communicated to the Promoter's representatives so that the Promoter or its representatives can contact the participant in connection with the promotion (as necessary). 1. PROMOTER: This promotion is operated by Co-operative Group Limited, a registered society under the Co-operative and Community Benefit Societies Act 2014, Registered No 525R with registered office at 1 Angel Square, Manchester, M60 0AG. References to "we", "us" or "our" in these terms and conditions are references to the promoter.

2. OPENING AND CLOSING DATE: The promotion opens on the day members receive the email titled "Act Now: Secure your spot in our prize draw" after making a purchase at a Co-op Group food store and closes 30 days from receiving that email. Any entries made before the opening date or after the closing date will not be valid and will not be entered into this promotion.

3. ELIGIBILITY: Co-op Group members selected for this prize draw must make a purchase at Co-op Group food store by the date specified in the email titled "Here's your chance to enjoy an incredible night out on us" to qualify. This promotion is open to residents of England, Scotland and Wales who are members of the Co-operative Group only. Entrants must be over 18.
