References to “we”, “us” or “our” in these terms and conditions are references to the promoter.
- 2. OPENING AND CLOSING DATE:** This promotion opens at **00:01 on 25 July 2025 and closes at 23:59 on 15 August 2025** (the “Promotional Period”). Any entries made before the opening date or after the closing date will not be valid and will not be entered into this promotion.
