

THE BIG CO-OP SURVEY PRIZE DRAW TERMS & CONDITIONS

1. PROMOTER: This promotion is operated by Co-operative Group Limited, a registered society under the Co-operative and Community Benefit Societies Act 2014, Registered No 525R with registered office at 1 Angel Square, Manchester, M60 0AG. References to “we”, “us” or “our” in these terms and conditions are references to the promoter.

2. OPENING AND CLOSING DATE: This promotion opens at **00:01 on 21st March 2026** and closes at **23:59 on 29th May 2026** (the “Promotional Period”). Any entries made before the opening date or after the closing date will not be valid and will not be entered into this promotion.

3. ELIGIBILITY: This promotion is open to UK residents who are members of the Co-operative Group. However, employees of the promoter (or any of its group undertakings and its agencies) who are directly connected with the creation and administration of this promotion are excluded from entering this promotion. The entrant must have Joined in via the Co-op membership dashboard, via an email sent to the member or via a link on the Co-op Membership App and completed THE BIG CO-OP SURVEY within the Promotional Period in order to be eligible. One entry per member.

4. HOW TO ENTER: Entrants must complete THE BIG CO-OP SURVEY prize draw provided through the membership dashboard page, membership email or the membership app to enter the draw.

5. PRIZE: Twenty winners will receive a £50 credit onto their Co-op membership Card. The Winner will be contacted via their email associated to their Co-op Membership account and the prize credited to the Co-op Membership card once confirmed. The prize is not exchangeable, and no cash alternative can be requested. The prize is provided at our discretion, and we may substitute or change it for a prize of an equivalent or greater value if circumstances beyond our control make it necessary to do so.

6. WINNER SELECTION: Following the end of the Promotional Period, the winner will be selected at random from all entries received using a randomised computer generator.
