

TERMS AND CONDITIONS: LOCAL COMMUNITY FUND DREAMSEATS CO-OP LIVE TICKETS PRIZE DRAW

Entry instructions are deemed to form part of the Terms and Conditions. By entering this promotion all participants will be deemed to have accepted and be bound by the Terms and Conditions and to their details being communicated to the Promoter's representatives so that the Promoter or its representatives can contact the participant in connection with the promotion (as necessary). Please retain a copy for your information.

1. PROMOTER: This promotion is operated by Co-operative Group Limited, a registered society under the Co-operative and Community Benefit Societies Act 2014, Registered No 525R with registered office at 1 Angel Square, Manchester, M60 0AG. References to "we", "us" or "our" in these terms and conditions are references to the promoter.

2. OPENING AND CLOSING DATE: This promotion opens at 12:00 pm on 9th January 2026 and closes at 11:59 pm on 18th January 2026 (the '**Promotional Period**'). Any entries made before the opening date or after the closing date will not be valid and will not be eligible for this promotion.

3. ELIGIBILITY: This promotion is open to residents of the United Kingdom and Isle of Man, who are part of a current Co-op Local Community Fund cause. Entrants must be over 18 at the date at which they enter the promotion. Employees from Co-op group undertakings and employees of its agencies directly connected with the creation and administration of this promotion are not eligible to enter. We may ask the winners to provide proof of age and/or identity.

4. HOW TO ENTER: The entrant will need to be part of a current Co-op Local Community Fund cause, and they must enter by clicking the link in the LCF email distributed on 9th January 2026 to the Official contacts at each of our causes. The link will redirect to an entry form which needs to be completed within the promotional period. Internet access is required, and this prize draw is limited to 1 entry per cause. If you submit the entry form multiple times, you will only be entered in the prize draw once and any duplicated entries will be disregarded. Entry to the prize draw does not guarantee a prize.

5. PRIZES: There are 10 prizes for 10 winners to be won and each prize is a maximum of four tickets per winner for selected concerts or comedy acts at Co-op Live in Manchester held in 2026. There are a limited number of tickets per show. Winners will be contacted in the order they are drawn and given a choice of shows to attend, subject to availability. We may substitute or change the prizes for a prize of an equivalent or greater value if circumstances beyond our control make it necessary to do so but there will be no cash alternative. The tickets are non-refundable and cannot be exchanged and are not for resale. Winners may pass on tickets as gifts to friends and family for free through Ticketmaster Transfer. Winners cannot transfer their tickets to any third party that is in anyway a supplier or service provider to the Co-op Group or any of its Group Undertakings and any guest must either be a Co-op Group Colleague or someone not connected to any supplier or service provider to the Co-op Group or any of its Group Undertakings. If a winner tries to resell a ticket, the ticket will be void. The prize does not include food and drink, accommodation, travel ¹ insurance or any other associated cost. These costs also cannot be expensed. ID may be required before you are allowed entry to the event, and you may be refused entry if you do not provide suitable photographic ID (such as a passport or driving licence). If a show selected by a Winner is already full due to earlier selections on a first-come, first-served basis, they will be offered a list of alternative shows that are still available.

By entering, Winner's consent to such information being disclosed upon request. You have the right to ask that we stop any consent-based processing of your personal data after you withdraw that consent.

promotion, verifying the eligibility of the winner and as otherwise set out in these terms and conditions.
