### Member Survey Prize Draw - Terms and Conditions

These Terms and Conditions prevail in the event of any conflict or inconsistency with any other communications, including advertising or promotional materials. PROMOTER:** This promotion is operated by Co-operative Group Limited, a registered society under the Co-operative and Community Benefit Societies Act 2014, Registered No 525R with registered office at 1 Angel Square, Manchester, M60 0AG. References to "we", "us" or "our" in these terms and conditions are references to the promoter.

**2. OPENING AND CLOSING DATE:** This promotion opens on 01 April 2026 and closes on 30 April 2026 (the "Promotional Period"). Any entries made before the opening date or after the closing date will not be valid and will not be entered into this promotion.

**3. ELIGIBILITY:** This promotion is open to UK residents who are members of the Co-operative Group.
