2. OPENING AND CLOSING DATE: This promotion opens at **00:01 on 14 November 2025 and closes at 23:59 on 12 December 2025** (the “Promotional Period”). Any entries made before the opening date or after the closing date will not be valid and will not be entered into this promotion.

3. ELIGIBILITY: This promotion is open to UK residents who are members of the Co-operative Group. However, employees of the promoter (or any of its group undertakings and its agencies) who are directly connected with the creation and administration of this promotion are excluded from entering this promotion.
