

## **MARCH MONTHLY CO-OP LIVE MEMBER DRAW**

### **TERMS & CONDITIONS**

1. **PROMOTER:** This promotion is operated by Co-operative Group Limited, a registered society under the Co-operative and Community Benefit Societies Act 2014, Registered no 525R with registered office at 1 Angel Square, Manchester, M60 0AG. References to "we", "us" or "our" in these terms and conditions are references to the Promoter.

2. **OPENING AND CLOSING DATE:** This promotion opens at 00:01 on 01.03.26 and closes at 23:59 on 24.03.26 (the 'Promotional Period'). Any purchases made before the opening date or after the closing date will not be valid and will not be entered into the prize draws.

3. **ELIGIBILITY:** This promotion is open to residents of the United Kingdom who are colleague members of the Co-operative Group only. Entrants must be over 16 at the date at which they enter the promotion. If you are under 18 years old, you represent and warrant to us by entering this prize draw that your parents/guardians have consented to your entry and to these Terms and Conditions, which they have read. Employees from Co-op group undertakings and employees of its agencies directly connected with the creation and administration of this promotion are not eligible to enter. We may ask the winners to provide proof of age and/or identity

5. **WINNER SELECTION:** The prize draw that will take place within 5 working days of the close of the draw.
