

Declaration of Commitment Known Transporter

In accordance with the Known Transporter Policy, I
declare on behalf of
that
a)
agrees to comply with the Known Transporter Security Programme and the latest version of the Known Transporter Policy (which can be found on the website www.schiphol.nl/knowntransporter), as approved and adopted by Schiphol Nederland B.V. (hereafter: SNBV);
b)
will appoint one or more persons who is/are responsible within
for introducing, implementing and updating the Known Transporter Security Programme and providing the name and contact details of this/these person(s) in the security programme; and
c)
 will ensure that the drivers of vehicles and the security inspectors of the Known Transporter have: the required VOG or VGB documentation; a Certificate showing that they have successfully completed the relevant security awareness e-learning modules, and if necessary for the work, a personal Schiphol Pass with the required authorisation.
d)
will ensure that the vehicles have the correct Schiphol vehicle pass;
e)
will take all measures that can reasonably be required of it to prevent the concealment of Prohibited Items in a vehicle, such as Vehicle Borne Improvised Explosive Devices (VBIEDs), firearms and butterfly knives, folding knives and stilettos, so that the Schiphol Airport Area and the associated Stand-off zone which is a part of that area, as defined in the Known Transporter Policy, can be entered;
f)
has carried out all procedures in the Known Transporter Security Programme prior to the vehicle entering the Schiphol Airport Area;
g) in order to enable SNBV to form a comprehensive picture of compliance with the Known Transporter Security Programme and the latest version of the Known Transporter Policy,

will fully cooperate with all inspections deemed necessary by SNBV, for example by providing access (on location) to the relevant documentation and by answering oral questions;

will notify SNBV as soon as possible regarding (potential) security risks or breeches, or of any other circumstances that may be relevant as part of compliance with the Known Transporter Security Programme and the latest version of the Known Transporter Policy;	
j)	SNBV has the right to withdraw Known Transporter status temporarily or permanently in the event that the Known Transporter fails to meet its obligations or it is believed that it will not meet those obligations.
k)	SNBV reserves the right to make changes to the Known Transporter Policy and the Security Programme unilaterally.
	will be notified of any such changes and the date on which they take effect.
I)	SNBV is not liable for any damage resulting from the temporary discontinuation of, definitive termination of, delays to the granting of the authorisations of the Known Transporter Policy, or of any decision not to do so.
