**At which staff filters and security checkpoints are you required to wear a face mask from the 1st of August?**

The table below shows you at which staff filters and checkpoints you are obligated to wear a face mask.

#### **Do you need to wear a face mask at all security checkpoints? Even if you remain in your vehicle?**

To pass through a security checkpoint, you first need to go through the security filter at that checkpoint. Face masks are mandatory there. Are you in your vehicle or are you returning to your vehicle? Then you may take off your face mask, but you must maintain a 1.5 metre distance.

#### **Do you only need to wear a face mask when going through the security checkpoint building at Schiphol East, or everywhere at Schiphol East?**

At the Schiphol East security checkpoint we ask that you show your access pass from a safe distance. You are not required to wear a face mask at this point. This applies to staff who come in their vehicle, by bicycle or on foot. Those who need to acquire a visitor pass or who need to be inside the security checkpoint are required to wear a face mask.

#### **Do you also need to wear a face mask when in an exit lane of a security checkpoint?**

No, the security staff and driver of the vehicle do not need to wear face masks at this point, as long as they are able to maintain a distance of 1.5 metres.
