<b>INDEX</b>	SOFR ARMs eligible for sale to Freddie Mac use an index based on a 30-day compounded average of SOFR (SOFR Index). The Federal Reserve Bank of New York (New York Fed) publishes 30-, 90-, and 180-day compound SOFR averages available.
