

**Reece Australia NRL National Tipping
Competition 2026 Terms and
Conditions**

1 Introduction

- 1.1 These terms and conditions (**Terms**) govern the Reece National Rugby League (**NRL**) 2026 National Tipping Competition (**Promotion**). Entry into this promotion is deemed an acceptance of these Terms.
 - 1.2 The Promoter is Reece Australia Pty Ltd (ABN 84 004 097 090) of 57 Balmain St, Cremorne VIC 3121.
 - 1.3 Entries for the Promotion will be open for acceptance from 12:00 am Australian Eastern Daylight-Saving Time (**AEDT**) on 2 February 2026 until 12.00 am AEDT on 31 March 2026 (**Entry Period**).
 - 1.4 The Promotion will run from the first Round of the Season until the last Round of the Season (**Promotion Period**).
 - 1.5 In the event of the fixture being changed by the NRL, the Promotion Period will be updated, and participants will be notified via email as soon as is practicable.
 - 1.6 Entry into the Promotion is free.

2 Eligibility

- 2.1 Subject to this clause, the Promotion is open to entry by any person who is an Australian Resident 18 years of age or older (at the time of entry):
 - (a) If an entrant is under the age of 18 years, they must have their parent or guardian's consent to enter the Promotion. The Promoter reserves the right to request this consent in writing; and
 - (b) If a prize winner is under the age of 18 years, the prize will be awarded to the winner's nominated parent or guardian on behalf of the winner.
 - 2.2 Entry is open to all Reece Group trading account holders, their Immediate Family and their employees.
 - 2.3 Entry is also open to employees of Reece Group at their Home Branch, and their Immediate Family, save and except those officers, trustees or members of the Promoter involved in the authorisation or assisting in the conduct of the Promotion.
 - 2.4 If an employee of Reece Group ceases employment for any reason prior to the finalisation of the Promotion, said employee and their Immediate Family will no longer be eligible to receive prizes associated with the Promotion.
 - 2.5 An Entrant may only submit one Entry at their Home Branch. Any additional entries at the Entrant's Home Branch, or other branches will be deemed invalid.
 - 2.6 Each Entrant to the Promotion will be automatically entered into the Reece 2026 Regional NRL Tipping Competition, for which separate terms and conditions apply and which can be found on the Reece Tipping Website.

3 Definitions

- 3.1 In these Terms, the following meanings apply in addition to Terms which are defined elsewhere in these Terms, unless the contrary intention appears:

"Average Margin" means the average of the Entrants' Margin for the Margin Game.

“Away Team” means the team in each Match nominated by the NRL in its official draw to be the away team.

“Draw” means an even score at the conclusion of a Match.

“Entrant” means a person who is eligible to participate in and has submitted a valid entry into the Promotion in accordance with these Terms.

“Home Branch” for account holders and their immediate family and employees, means the branch where the account holder’s trade account is registered, according to Reece records. For Reece Group employees and their Immediate Family, it means the branch where the employee is employed.

“Host Platform” means the third-party platform on which the Promotion will be hosted.

“Host Platform Operator” means Genius Sports UK Limited.

“Immediate Family” means any of the following: spouse, de-facto spouse, child or step- child (whether natural or by adoption), parent, step-parent, grandparent, step- grandparent, brother, sister, step-brother or step-sister.

“Judging Location” means the premises located at 57 Balmain St, Cremorne VIC

3121. **“Leaderboard”** means the overall ladder containing the Entrants’ rankings.

“Margin” means a number of points estimated by an Entrant which represents the difference between the selected winning team’s score and the opposing team’s score for the Margin Game.

“Margin Difference” in respect of a Margin Game means, for an Entrant that has correctly tipped the winning team, the difference between the Margin estimated by the Entrant for that Match and the actual winning margin for that Match. (e.g. if an Entrant estimates a Margin of 36, and their tipped team wins by 10, the Entrant’s “Margin Difference” for the Match will be 26). For an Entrant that has not submitted a tip for a Margin Game, it means the Average Margin of that game.

“Margin Game” for Rounds 1 to the penultimate round of the Season is the first completed match of each Round. In the final Round of the Season, the margin game will be the first completed match.

“Match” means a single game of NRL Football, which is conducted during the Season.

“Privacy Policy” means the Promoter’s policy regarding collection and use of personal data and available via website - <https://www.reece.com.au/privacy>.

“Ranking” means an Entrant’s rank in the Promotion based on the number of correct tips and Total Margin and in circumstances where there are equal Scores, as determined in accordance with clause **Error! Reference source not found.**

"**Reece Group**" includes Reece Australia Pty Ltd, Actrol Parts Pty Ltd, A.C. Components Pty Ltd t/as Metalflex and Viadux Pty Ltd.

"**Reece Tipping Website**" means the Promoter's website at <https://tipping.reece.com.au/> accessible on the internet through the World Wide Web or via mobile internet enabled devices.

"**Round**" means one of the fixtured rounds consisting of Matches conducted during the Season.

"**Season**" means the 2026 NRL 'Home and Away' season of NRL Football consisting of the fixtured rounds of matches commencing on 1 March 2026 AEDT or as otherwise advised by the NRL.

"**Score**" means the number of points allocated to an Entrant for the correct tipping of winning teams in each Round in accordance with these Terms.

"**Total Margin**" in respect of an Entrant, means, the sum of the Margin Differences for all Rounds completed to date or at the end of the Promotion Period.

4 Entry Conditions

- 4.1 To register for the Promotion, Entrants must, during the Entry Period, register their details via the online registration form located on the Reece Tipping Website.
- 4.2 The Promoter reserves the right to decline a registration for any Entrant or to disqualify an Entrant if the Promoter considers that the registration contains any defamatory or offensive material or is otherwise inappropriate.
- 4.3 An Entrant may only register as an individual.
- 4.4 Entrants will have the opportunity, in respect of each Match in each Round of the Season to tip by:
 - (a) Selecting a team that the Entrant expects will win the Match (note that a Draw cannot be selected); and
 - (b) Submitting those tip selections via the Reece Tipping Website.
- 4.5 Tip selections for each Match must be submitted before the scheduled start time of the relevant Match.
- 4.6 An Entrant may make or change a tip for a Match in a Round at any time provided it is prior to the scheduled start time of that Match.
- 4.7 For the Margin Game in each Round, in addition to selecting the team the Entrant expects to win, the Entrant must enter a Margin.
- 4.8 If the team the Entrant selects to win scores points greater than, or equal to the opposing team's score, the tip is considered correct.
- 4.9 Individuals who successfully register during the Entry Period but submit tips after the start of the Promotion Period, are still eligible to receive prizes in the Promotion (subject to any restrictions in clause 5 below), if they consent to these Terms as prompted when they first login to the Reece Tipping Website during the Entry Period.

5 Failure to Tip

- 5.1 If an Entrant does not submit a tip:
 - (a) prior to the commencement of the given Match; or

(b) for a given Match in a Round;

then the Entrant's tip for that Match will be at the Promoter's sole discretion and deemed to be for the Away Team (**Auto Tip**).

- 5.2 If an Entrant does not submit a tip for any Matches in an entire Round, the Entrant's tips for that Round will be at the Promoter's sole discretion and deemed to be the Away Teams (**Auto Tip**) up to a maximum of 5 correct tips for that Round.
- 5.3 If an Entrant registers for the Promotion after the commencement of the first Round of the Season, then the Entrant's tips for Matches that have been completed or commenced at the time of registration, will be deemed to be those of the teams determined to be the Away Teams" (**Auto Tip**) to a maximum of 5 correct tips for each such Round.
- 5.4 An Auto Tip will not count as a correct tip if the Entrant already has 5 or more correct tips for that Round, from tips entered or the Entrant has 5 correct tips from a combination of tips entered and Auto Tips.

6 Scoring and Ranking

- 6.1 Subject to the rules relating to failure to tip in clause 5, Entrants will be allocated one point for each correctly selected winning team for a Match.
- 6.2 In the event of a Match in any given Round being drawn that is cancelled, abandoned, not completed or not played for any reason, and the NRL does not officially declare a result within 1 day of the original scheduled date of the Match, it is treated as a win for both teams competing in that Match.
- 6.3 Throughout the Season, the Promoter will maintain a Leaderboard which ranks the Entrants from highest to lowest based on their cumulative Scores.
- 6.4 To determine the ranking of two or more Entrants that have an equal cumulative Score, the Entrant with the lower Total Margin will rank higher than any other Entrants with a corresponding equal Score (**Ranking**).
- 6.5 If at the conclusion of the Promotion, there is a tie for any of first place, second place or third place positions, then each tie will be resolved by a draw to determine the winner.

7 Prizes

Major Prizes

- 7.1 The Entrant that has the highest Ranking at the end of the last Round of the Season will win a Ballpark Entertainment experience-based prize up to the (approximate) value of \$8,500.
- 7.2 The Entrant that has the second highest Ranking at the end of the last Round of the Season will win a Ballpark Entertainment experience-based prize up to the value of \$2,500.
- 7.3 The Entrant that has the third highest Ranking at the end of the last Round of the Season will win a Ballpark Entertainment experience-based prize up to the value of \$500,
(**Major Prizes**).

Weekly Prizes

- 7.4 At the end of each Round, the 10 Entrants from that Round that have the highest Score for that Round (as calculated by the highest number of tips and the lowest Margin for the Round) will each win an NRL rugby ball to the value of \$130 (recommended retail price) (**Weekly Prize**).

- 7.5 If there is a tie for a Weekly Prize, the winner will be the Entrant that first submitted their complete tips for that Round, by date and time.
- 7.6 The winners of the Weekly Prize will be notified via email within three business days following the end of the relevant Round.

Prize Conditions

- 7.7 Full details of all prizes, including any further conditions that apply, can be found on the Reece Tipping Website.
- 7.8 The winners of each Major Prize, unless otherwise stated, will be determined at the Judging Location at 2:00 pm AEST within 10 business days following the final Round of the Season.
- 7.9 Determination of the Promotion winners will be carried out in the presence of and under the supervision of a person who is independent of the Promoter.
- 7.10 The winners of a Major Prize will be notified via the email used in the registration for the Promotion, of their winnings, and will be notified within 10 business days of the relevant determination date as per clause 7.8.
- 7.11 Prizes will be delivered to each Prize winner's Home Branch.
- 7.12 If after making all reasonable enquiries, the Promoter is unable to award or deliver a prize to a prize winner because it cannot locate the prize winner or because of other special circumstances, the prize will be taken to be unclaimed. The Promoter will publish information about any prize winners that are unable to be located on the Reece Tipping Website by 30 November 2026. In the event of a prize being unclaimed by 31 December 2026, the prize will be given to the next highest-ranking Entrant.
- 7.13 Prizes are:
- (a) Not transferable or exchangeable;
 - (b) Must be taken as offered and cannot be varied;
 - (c) Cannot be taken as cash; and
 - (d) Cannot be used or redeemed in conjunction with any other offer by the Promoter.
- 7.14 If any of the abovementioned prizes are not available due to unforeseeable, or special circumstances the Promoter reserves the right to supply a similar prize of equal or greater value.
- 7.15 Unless expressly stated otherwise, the winner of a prize in this Promotion is not excluded from winning another prize as part of this Promotion. All Entrants will be considered in the judging for prizes in this Promotion whether or not they have won another prize in this Promotion.
- 7.16 The Promoter accepts no responsibility for any tax implications that may arise from prize winnings. Independent financial advice should be sought.

8 General

- 8.1 The Promoter's NSW Authority Number is TP/01472.
- 8.2 The Promoter's ACT Permit Number is TP 25/03177.
- 8.3 The Promoter reserves the right to:
- (a) amend these Terms;
 - (b) at its sole discretion and subject to State or Territory regulation, modify, cancel, terminate or suspend the Promotion and invalidate any affected entries, or suspend or modify a prize, if for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus,

communications network failure, bugs, tampering, unauthorized intervention, fraud, technical failure or any cause beyond the control of the Promoter and/or

- (c) disqualify any person who has breached these Terms or otherwise interfered with the proper conduct of the Promotion.
- 8.4 The Promoter reserves the right, at any time, to verify the validity of entries, tips, registrations and Entrants (including an Entrant's identity, age and place of residence) and the Promoter reserves the right to disqualify any Entrant who submits an entry that is not in accordance with these Terms or who tampers with the entry, registration, or tipping process.
- 8.5 Incomplete indecipherable, and incorrect entries, registrations, tips or any entries, registrations or tips containing offensive or defamatory comments, or which breach any law or infringe any third-party rights, including intellectual property rights, are not eligible to win. Errors and omissions within entries and registrations may be accepted at the Promoter's discretion.
- 8.6 If there is a dispute as to the identity of an Entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the Entrant.
- 8.7 If this Promotion is interfered with in any way, or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including by not limited to technical difficulties, unauthorised intervention, or fraud, the Promoter reserves the right in its sole discretion to the fullest extent permitted by law:
- (a) Disqualify an entrant; or
 - (b) Subject to any written directions from a regulatory authority, to modify suspend, terminate or cancel the Promotion as appropriate.
- 8.8 To the extent permitted by law, the Promoter and its agencies associated with this Promotion are not liable and do not accept responsibility for:
- (a) Costs associated with accessing the Reece Tipping Website;
 - (b) An Entrant's entry or tips not being received, or which are received and subsequently corrupted by or rejected by a server of the Reece Tipping Website;
 - (c) Any private or public tipping competition which uses or relies upon the Reece Tipping Website in any way as a means for collecting and disbursing data, or for conducting a tipping competition;
 - (d) Any lost, misdirected, or corrupt registrations, entries, tips or emails whether to or from the Reece Tipping Website, or otherwise;
 - (e) Any loss or damage whatsoever, including but not limited to direct or consequential loss or personal injury suffered or sustained:
 - (i) In connection with the Entrant's participation in the Promotion, except which cannot be excluded by law;
 - (ii) Relating to the conduct of the Promotion, however caused, including failure of the Reece Tipping Website or incorrect or corrupt data supplied by the Promoter to the Entrant; and or
 - (iii) Failure of equipment or technical errors associated with the Promotion or for any incorrect information, commission, interruption or delay in operation.
- 8.9 Except for liability that cannot be excluded by law, the Promoter accepts no liability for any event, circumstances, loss or expense arising, in any way, in connection with the Promotion.

- 8.10 Notwithstanding the Promoter's rights under these Terms to not accept, or subsequently disqualify an Entrant, the Promoter will not be liable for any legal action arising out of any Entrant's name being defamatory, inappropriate, in breach of any third parties' rights, or in breach of any law, and an Entrant must indemnify the Promoter, its agents, contractors and related companies from any legal action, claim or dispute arising directly or indirectly from any Entrant's name being defamatory, inappropriate, in breach of any third parties' rights, or in breach of any law.
- 8.11 It is a condition of taking a prize that the winner must, if requested to do so by the Promoter, sign and return:
- (a) documents relating to their eligibility to enter (including ownership of entry);
 - (b) a statement of compliance with relevant terms and conditions; and/or
 - (c) a release of the Promoter's liability in taking prizes.
- 8.12 In the event of any dispute concerning the conduct of the Promotion, including claims for prizes, the Promoter's decision is final, and binding and no correspondence will be entered into.
- 8.13 This Promotion is not sponsored, endorsed or administered by or associated with, Facebook, Instagram, or any other platforms where this Promotion may be advertised.
- 8.14 To the extent of any inconsistency between these Terms and any other reference to the Promotion (or its terms), these Terms will prevail.
- 8.15 Nothing in these Terms limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia (**Non-Excludable Guarantees**). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion.
- 8.16 Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of:
- (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control);
 - (b) any theft, unauthorised access or third party interference;
 - (c) any entry, registration, tip or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter;
 - (d) any variation in prize value to that stated in these Terms;
 - (e) any tax liability incurred by a winner or Entrant; or
 - (f) taking and/or use of a prize.
- 8.17 Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

- 9.1 By entering into the Promotion, the Entrant acknowledges that use of the Host Platform is governed by the Host Platform End User Licence Agreement (**EULA**) which can be accessed from the Host Platform.
 - 9.2 The Entrant must comply with the EULA at all times;
 - 9.3 The Entrant acknowledges that the Promoter is not a party to the EULA and has no control over the content, functionality or performance of the Host Platform. To the maximum extent permitted by law, the Promoter is not responsible or liable for any loss or damage the Entrant incurs connected with the Entrant's use of the Host Platform.
 - 9.4 The Entrant consents to:
 - (a) the collection of Personal Information by the Host Platform Provider to enable it to host the Promotion; and
 - (b) the tracking of the Entrant's visits to the Host Platform including analytics, usage and engagement metrics.

10 Privacy

- 10.1 The Promoter and any third parties the Promoter appoints in connection with the operation of the Promotion collect **Personal Information** as defined by the *Privacy Act 1998 (Cth)* about an Entrant to include the Entrant in the Promotion, to operate the Promotion (where appropriate) and use the information to assist in marketing of the Promoter and its products and services. If the Personal Information requested by the Promoter is not provided, the Entrant will not be eligible to participate in the Promotion.
- 10.2 By participating in this Promotion, the Eligible Entrant agrees and acknowledges that:
 - (a) they may be contacted by the Promoter to provide comments about the Promotion and the Promoter (or an agent of the Promoter) may take photos of them;
 - (b) the Promoter may use such comments or photos (**Materials**) for the Promoter's future promotional and marketing purposes without further reference or compensation to them;
 - (c) the Promoter may duplicate, alter, adapt and utilise the Materials as the Promoter wishes at anytime, anywhere, and by any means. The Promoter may license, authorise or otherwise transfer the rights in the Materials to others to do the same;
 - (d) they acknowledge that the Promoter retains all right, title and interest, including copyright, in the Materials and, by participating in the Promotion, they assign to the Promoter on creation of the Materials all right, title and interest which might, but for these Terms, vest in them;
 - (e) they unconditionally and irrevocably consent to any act or omission that would otherwise infringe any of their moral rights in the Materials (as defined in Part IX of the Copyright Act 1968 (Cth)) and present and future rights of a similar nature conferred by statute anywhere in the world whether occurring before or after this consent is given (**Moral Rights**);
 - (f) they waive all Moral Rights in the Materials that arise outside Australia; and
 - (g) they agree not to institute, maintain or support any claim or proceeding for infringement of their Moral Rights in the Materials.
- 10.3 Information about Entrants is used by the Promoter to assess and process registration in the Promotion. If an Entrant does not provide the required information, the Promoter cannot process the registration. All registrations/entries become the

property of the Promoter and will be entered into a database. Information emanating from the Entrant's participation in the Promotion is used by the Promoter and its agencies, contractors and service providers associated with this Promotion for the determination of winners and distribution of prizes, if any, awarded to an Entrant. Entry is conditional on providing this information. Entrants consent to publishing their name and accumulated winning team points in the results section of the Reece Tipping Website and for their personal information to be disclosed to State and Territory lottery departments, as required under the relevant lottery legislation. The Promoter will not be held responsible for any loss of reputation, status or otherwise in connection with an Entrant's tipping selections and consequential results.

- 10.4 The Promoter will also use and handle an Entrant's personal information as set out in its Privacy Policy. In addition to any use that may be outlined in the Promoter's Privacy Policy, the Promoter may, for an indefinite period, unless otherwise advised, use an Entrant's personal information for promotional, marketing, publicity, research and profiling purposes, including sending electronic messages or telephoning the Entrant. The Privacy Policy also contains information about how Entrants may opt out, access, update or correct their personal information, how Entrants may complain about a breach of the Australian Privacy Principles or any other applicable law and how those complaints will be dealt with.
- 10.5 Entrants acknowledge and understand, that if they tick the 'opt in' to receive future offers from the Promoter and any third-party sponsors on the registration page, that their details will be provided to third-party sponsors. Should Entrants not want their details provided to third-party sponsors, they should not tick the 'opt in' box.
- 10.6 Entrants can gain access to, update or correct any of their Personal Information held by the Promoter, by contacting the Promoter's Privacy Officer. All Personal Information will be stored by the Promoter in accordance with the Privacy Policy and these Terms. A copy of the Privacy Policy and Collection Statement in relation to the treatment of any Personal Information collected may be obtained at <https://www.reece.com.au/privacy>.
