

Geberit 'Installation Masters - 2026' Promotion

Terms and Conditions

1 Introduction

- 1.1 This Geberit 'Installation Masters – 2026' Promotion (**Promotion**) is conducted by Geberit Pty Ltd (ABN: 44 103 224 273) (**Promoter**). In conjunction with Reece Australia Pty Ltd (ABN 84 004 097 090) of 57 Balmain Street, Cremorne, VIC 3121 (Host)
 - 1.2 By submitting an entry to the Promotion, you agree to be bound by these Terms and Conditions (**Terms**).
 - 1.3 The Promotion commences at 7:00am, 11th March 2026 and ends at 12:00pm, 1st December 2026 (**Promotional Period**).
 - 1.4 To the extent of any inconsistency between these Terms and any other reference to the Promotion, these Terms will prevail.
 - 1.5 The Promoter reserves the right to, at its discretion:
 - (a) cancel, suspend or restart the Promotion for any reason; and/or
 - (b) disqualify any individual who has breached these Terms or otherwise interfered with the proper conduct of the Promotion.

2 Eligibility

- 2.1 Subject to this clause, the Promotion is open to entry by qualified plumbers, apprentice plumbers or plumbing professionals, who are Australian Residents aged 18 years of age or older (at the time of entry).
 - 2.2 Employees (and their immediate families) of the Promoter and Host are not eligible to participate in this Promotion but may participate for demonstration purposes only.
 - 2.3 Immediate family means the spouse, ex-spouse, de-facto spouse, child or stepchild (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or cousin of that employee.
 - 2.4 The Promoter reserves the right, at any time, to verify the validity of entries and any person who submits an entry (including that person's identity, age and place of residence) and reserves the right to determine any person to be ineligible to participate in the Promotion in its sole discretion.
 - 2.5 Entrants may be required to produce photographic identification and evidence of their plumbing qualification or apprenticeship status upon request. Failure to provide such evidence will result in disqualification.

3 Entry

- 3.1 The Promotion will be conducted by participants registering at the event location, during the promotional period.
 - a) The location, date, and time of the Installation Masters service may be changed

at the Promoter's discretion.

- 3.2 Each participant may choose to compete in one or both of the following challenge attempts
- (a) *Challenge 1:* Correctly replace the inlet valve and outlet valve and install the appropriate Geberit flush button on a Geberit Sigma8 or Omega concealed cistern.
 - (b) *Challenge 2:* Correctly prepare and electrofusion weld two Geberit HDPE pipes together utilising an approved Geberit Pipe Scraper and Geberit Electrofusion Welder.
- 3.3 Each challenge attempt is timed and judged independently.
- 3.4 Attempts must follow the official procedure as demonstrated or explained by event staff.
- 3.5 Incorrect installation, incomplete installation, or unsafe conduct will result in disqualification for that attempt.
- 3.6 The Promoter may disqualify any participant suspected of tampering, attempting to gain an unfair advantage, or otherwise breaching these Terms.
- 3.7 All participants must follow safety instructions and use required personal protective equipment (PPE)
- 3.8 The Promoter reserves the right to refuse participation or stop a run at any time, if unsafe behaviour is observed
- 3.9 The Promoter may, in its sole discretion, limit the number of participants permitted to take part in each event or challenge. Attendance at an event does not guarantee participation. If more than thirty (30) participants attend an event, the Promoter reserves the right to restrict or refuse participation, shorten or modify challenge attempts, or close registrations once available materials or resources have been exhausted. The Promoter accepts no responsibility and will not be liable to any person for any loss, disappointment, or inability to participate arising from limited capacity or insufficient materials.
- 3.10 The promoter may cancel, suspend or modify a participants attempt if conditions

become unsafe or equipment fails

- 3.11 If contacted by a representative of the Promoter, the entrant must provide such additional information that the Promoter may request as reasonably necessary for the administration of the Promotion. Failure to provide the requested information may result in the entrant's entry being rejected or not being selected as the winning entry.
 - 3.12 Each submission is classified as one entry, entry is limited to one attempt, for each of the two Challenges, per person. Multiple entries, per challenge, are not permitted.
 - 3.13 Any entry that contains content that the Promoter, in its sole discretion, considers to be offensive, obscene, crude or inappropriate in any way or that the Promoter considers may infringe any intellectual property rights or other rights of any person, corporation or entity will not be accepted as an eligible entry into the Promotion. This includes but is not limited to any entry which the Promoter considers to be disparaging of it or any of its promotion partners or any of it or their products and/or services or is otherwise not in keeping with the spirit of Promotion.
 - 3.14 No repeat attempts are permitted except where the Promoter cancels the attempt due to equipment failure, safety concerns or operational issues beyond the entrant's control.

4 Winner

- 4.1 The Promotion is a game of skill, no element of chance determines the winner.
- 4.2 The winning entry will be based solely on skill, as judged independently, for each challenge and in line with the judging criteria
- 4.3 Judging Criteria
 - a) Challenge 1 – Cistern Challenge (Replacing Valves Task)
 - 1. Fastest valid time
 - 2. Accuracy of valve replacement
 - 3. Correct installation of the flush button
 - 4. Workmanship and adherence to installation steps
 - b) Challenge 2 – HDPE Challenge (HDPE Preparing and Welding Task)
 - 1. Fastest valid time
 - 2. Correct pipe preparation
 - 3. Weld quality and coupling installation
 - 4. Proper use of Geberit HDPE pipe scraper and welder
- 4.4 If two participants achieve identical valid times, the judge will determine the winner based on workmanship and adherence to required installation steps.
- 4.5 The winner of the prize will be announced at the event location, immediately following the final participants challenge run and upon final determination of the winner, by the independent judge, in line with the judging criteria, unless otherwise notified. The winner and runner up will be notified by phone call (**Notification**). The Notification will contain instructions for the winner to claim their prize, from the event location.
- 4.6 The winning entry will be the provisional winner until the winning entrant has been

verified by the Promoter.

4.7 The winner must claim their prize within 14 days of receiving the Notification.

Prize

4.8 The Challenge prizes consist of;

- Challenge 1: Cistern Challenge (Replacing Valves & Flush Button installation Task) 1 x \$250.00 Visa Debit card
- Challenge 2: HDPE Challenge (HDPE Preparing and Welding Task) 1 x \$250.00 Visa Debit card

All other costs (including travel and all other out of pocket expenses) are excluded and will be the sole responsibility of the winner.

4.9 The winner must verify their entry and confirm that they meet the Terms and Conditions of this Promotion with the Promoter prior to claiming their prize. Arrangements will then be made for redemption of the prize.

4.10 The Prize:

- (a) is not transferable or exchangeable;
- (b) must be taken as offered and cannot be varied; and the Promoter makes no guarantee regarding suitability for any specific purpose, except as required by Australian Consumer Law
- (c) cannot be taken as cash; or redeemable for gift cards
- (d) cannot be used or redeemed in conjunction with any other offer by the Promoter.

4.11 If a prize is unavailable, the Promoter reserves the right to substitute that prize with a prize of equal value, in its sole discretion.

4.12 If:

- (a) The prize is not claimed within 14 days of being notified as the winner.
- (b) The winner does not respond to the Promoter within 14 days of being contacted by the Promoter notifying the winner that they have won the Promotion;

that winner's right to the prize is forfeited. The Promoter reserves the right (in its sole and absolute discretion) to:

- (c) select a new winner and award the prize to that entrant; or
- (d) not award the prize at all.

4.13 Any winner found to have breached these Terms will not be entitled to any prize and must return any claimed prize within 30 days of a request to do so. The Promoter will have the final decision on what to do with the prizes (including announcing a new winner who will become entitled to that prize).

4.14 The Promoter accepts no responsibility for any tax implications that may arise from prize winnings. Independent financial advice should be sought.

4.15 Use of the Visa Debit card is subject to the issuer's terms and conditions, including expiry dates and lost card policies, which are outside the Promoter's control.

5 Liability

5.1 An entrant must not enter into any arrangement with a third-party in relation to a prize

- where a prize is promoted or used as an incentive or reward for that entrant and that third-party entering into any commercial or other arrangement.
- 5.2 Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
- 5.3 Any attempt to cause malicious damage, interference with or to undermine:
- (a) the business of the Promoter;
 - (b) the normal functioning of, or the information on, the website(s) of the Promoter or;

- 5.4 The Promoter reserves its rights to recover damages or other compensation from any person who breaches these Terms.
- 5.5 To the maximum extent permitted by law, each entrant indemnifies, and must defend and hold harmless, the Promoter and each of their employees, servants, agents and contractors, from and against all losses arising from:
- (a) a breach by the entrant of any of these Terms;
 - (b) any third party claim arising directly or indirectly from a breach by the entrant of any of these Terms;
 - (c) any negligent, wilful or otherwise wrongful act or omission of the entrant;
 - (d) any fraudulent or dishonest acts or omissions by the entrant;
 - (e) any breach by the entrant of any applicable laws;
 - (f) any claim by any third party (including individuals, legal entities and governmental departments or agencies) arising directly or indirectly as a result of the entrant entering the Promotion; and
 - (g) participants engage and participate in the promotion, at their own risk and must ensure they are physically capable of performing the required task

- 5.7 Nothing in these Terms limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the *Competition and Consumer Act 2010 (Cth)*, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia ("Non-Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any event, circumstances, loss or expense arising from the Promotion for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect,

special or consequential, arising in any way out of the Promotion.

6 Privacy

- 6.1 The Promoter collects **Personal Data and Personal Information** as defined by the *the Privacy Act 1998 (Cth)* about an entrant to include the entrant in the Promotion, award the prizes (where appropriate) and use the information to assist in marketing of the Promoter and its products and services. If the Personal Information requested by the Promoter is not provided, the entrant will not be eligible to participate in the Promotion.
- 6.2 By entering into the Promotion, each entrant consents to the Promoter using the entrant's name, locality, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media worldwide at any time without further notification, remuneration or compensation for the purpose of promoting, publicising, or marketing the Promotion (including any outcome), and/or promoting any products or services manufactured, distributed and/or supplied by the Promoter.
- 6.3 By entering into this Promotion, each entrant consents to the collection, use and disclosure of the entrant's Personal Information by the Promoter to:
- (a) provide the relevant prize to the entrant if the entrant is a winner; and
 - (b) contact the entrant in the future with information about the Promoter and its affiliates, including special offers, market research or to provide the entrant with marketing materials via any medium.
- 6.4 The entrant agrees that, in the event they are the winner, the entrant will participate in all reasonable activities in relation to the Promotion as requested by the Promoter and sign any additional documents reasonably required by the Promoter to give effect to this condition.
