

REHAU 50 Year Competition

Terms and Conditions

1 Introduction

- 1.1 This REHAU 50 Year Competition (**Promotion**) is conducted by Reece Australia Pty Ltd (ABN 84 004 097 090) of 57 Balmain Street, Cremorne, VIC 3121 (**Promoter**). In conjunction with REHAU Pty Ltd (ABN: 78 001 298 577) of Suite 7.05, Level 7, 4 Dawn Fraser Ave, Sydney Olympic Park NSW 2127 (**Prize Supplier**).
- 1.2 By submitting an entry to the Promotion, you agree to be bound by these Terms and Conditions (**Terms**).
- 1.3 The Promotion commences at 12:01am AEST Tuesday, 1 September 2026 and ends at 11:59pm AEST Wednesday, 30 September 2026 (**Promotional Period**).
- 1.4 To the extent of any inconsistency between these Terms and any other reference to the Promotion, these Terms will prevail.
- 1.5 The Promoter reserves the right to, at its discretion:
- (a) cancel, suspend or restart the Promotion and/or
 - (b) disqualify any individual who has breached these Terms or otherwise interfered with the proper conduct of the Promotion.
- If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify or suspend the Promotion and invalidate any affected entries, or suspend or modify a prize, subject to State or Territory regulation

2 Eligibility

- 2.1 Subject to this clause, to be eligible for this Promotion, you must be a new or existing Reece Account Customer, who is an Australian Resident 18 years of age or older (at the time of entry).
- 2.2 Employees (and their immediate families) agents, and contractors of the Promoter and Prize Supplier, are not eligible to participate in this Promotion.
- 2.3 Immediate family means the spouse, ex-spouse, de-facto spouse, child or stepchild (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or cousin of that employee.
- 2.4 The Promoter reserves the right, at any time, to verify the validity of entries and any person who submits an entry (including that person's identity, age and place of residence) and reserves the right to determine any person to be ineligible to participate in the Promotion in its sole discretion.

3 Entry

- 3.1 Entrants must meet the spend requirements (3.2), on REHAU products at Reece, during the promotional period.
- 3.2 Every \$50.00 (AUD), GST inclusive spent on REHAU products during the promotional period will be one (1) entry into the Minor Prize Draw.
- For the avoidance of doubt, if a customer spends \$200.00 (AUD) on REHAU products, they will have 4 entries submitted into the Minor Prize Draw;

(1 of 50 limited edition REHAU 50 Year cricket sets)

- 3.3 If contacted by a representative of the Promoter, the entrant must provide such additional information that the Promoter may request as reasonably necessary for the administration of the Promotion. Failure to provide the requested information may result in the entrant's entry being rejected or not being selected as the winning entry.
 - 3.4 Entry to Promotion will be automatically submitted on behalf of the Reece Account customer upon receipt of purchase and full payment on REHAU products, to the minimum value requirement of \$50.00 AUD, calculated based on the total monthly REHAU spend, at the end of the competition term (Wednesday, 30 September 2026, at 11:59pm AEST).
 - 3.5 Any entry that contains content that the Promoter, in its sole discretion, considers to be offensive, obscene, crude or inappropriate in any way, or that the Promoter considers may infringe any intellectual property rights or other rights of any person, corporation or entity will not be accepted as an eligible entry into the Promotion. This includes but is not limited to any entry which the Promoter considers to be disparaging of it or any of its promotion partners or their products and/or services or is otherwise not in keeping with the spirit of Promotion.

4 Winner

- 4.1 The Promotion is a game of Chance
- 4.2 The winning entries will be drawn at random from all correctly completed entries received prior to Wednesday, 30 September 2026, at 11:59pm AEST (end of Promotional period).
 - a) The winning entries will be drawn on the Prize Draw dates in 4.3
- 4.3 The Prize Draws will take place at 11:00am AEST on the following date/s:
 - a) Thursday, 8 October 2026 (Minor and Major Prize Draws)
- 4.4 The location of the draw will be 'The Works', 57 Balmain Street, Cremorne, Victoria Australia 3121
- 4.5 All decisions by the Promoter are final and binding. No correspondence will be entered into.
- 4.6 Entrants (Reece Account Customers) are not able to win more than one Minor Prize. In the event that multiple winning entries are drawn for the one entrant, the subsequent winning entry (or entries) will be re-drawn until a different winning entrant is drawn.
- 4.7 The winners of the Minor Prize Draw will be notified by being sent an email on Thursday, 8 October 2026 (**Notification**). The Notification will contain instructions for how the winners must claim their prizes.
- 4.8 Minor Prizes will be delivered to the winning Reece Customer Account's (Reece Group) Home Branch, for collection by the Minor Prize Draw winners on or before Thursday, 19 November 2026.
- 4.9 The winner of the Major Prize Draw will be drawn at random, from all eligible entries received during the promotional period (including those entries that may have won a Minor prize)..,
- 4.10 The winner of the Major Prize Draw will be notified by being sent an email, immediately after the draw on Thursday, 8 October 2026 (**Notification**). The Notification will contain instructions for how the winner must claim their prize.
- 4.11 The winning Major Prize draw entry will be the provisional winner until the winning entrant has been verified by the Promoter.
- 4.12 The winners of all prize draws (Minor and Major) must claim their prize within 2 weeks of receiving the Notification.

- 4.13 The Promoter will also publish the name of the winning Reece Account Customer (Surname, First Initial and Postcode) on the Reece Website and on Reece Social Media channels, as required by the Trade Promotions requirements for a period of 30 days from date of the draw (inclusive).
- 4.14 In the event of an Unclaimed Prize draw, Unclaimed Prize draw winners details will also be published (Surname, First Initial and Postcode) by the Promoter, on the Reece Website and Reece Social Media channels for a period of 30 days from the date of the Unclaimed Prize draw (inclusive).

5 Prize

5.1 The prizes consist of

Minor Prizes:

- 1 of 50 limited edition REHAU 50 Year cricket sets (valued at \$117.15 each)

Major Prize:

- Cricket Experience Grand Prize is 2 x tickets to Day 2 of the 150th Anniversary Test with a corporate hospitality package and 2 nights' accommodation in Melbourne CBD. (total package value is \$5,000.00 AUD)
- Return economy-class flights (if required).

5.2 The winner must verify their entry and confirm that they meet the Terms and Conditions of this Promotion with the Promoter prior to claiming their prize. Arrangements will then be made for redemption of the prize.

5.3 All Minor Prizes must be redeemed on or before Thursday, 19 November 2026.

5.4 The Prizes:

- (a) are not transferable or exchangeable;
- (b) must be taken as offered and cannot be varied;
- (c) cannot be taken as cash; and
- (d) cannot be used or redeemed in conjunction with any other offer by the Promoter or Prize Supplier.

5.5 If a prize is unavailable, the Promoter reserves the right to substitute that prize, in consultation with the Prize Supplier, with a prize of equal value, in its sole discretion.

5.6 If:

- (a) The winner does not respond to the Promoter within 14 days of being contacted by the Promoter notifying the winner that they have won the Promotion;

that winner's right to the prize is forfeited. The Promoter reserves the right (in its sole and absolute discretion) to select a new winner (**Unclaimed Prize draw**) and award the prize to that entrant; :

5.7 In the event that an Unclaimed Prize Draw for either of the Minor or Major Prize draws is required, the Unclaimed Prize Draw will occur on;

- (a) Friday 23rd October 2026 at 11:00am (location of the Unclaimed Prize Draw will be as per location in clause 4.4)
- (b) Winners of any unclaimed prize draw prizes will be required to claim their prize within 14 days of the unclaimed prize draw (claim must be made on or before Friday 6th November 2026).
- (c) Winners of the Minor Unclaimed Prize Draw

1. who meet the eligibility criteria and have claimed their prize within the advised claim timeframe will be required to;
2. Redeem their prize, as per the notification they receive, from their Reece Account Home branch within 4 weeks of the notification and / or by no later than Friday, 4th December 2026.

(d) The Winner of the Major Unclaimed Prize Draw

1. will be who has met the eligibility criteria and has claimed their prize within the advised unclaimed prize draw timeframe 5.7 (b);
2. The Major Unclaimed Prize winner will be required to redeem their prize, as per the notification details they receive, by no later than Thursday, 11th March 2027 (date of the 1st nights accommodation in Melbourne).

- 5.8 Any winner found to have breached these Terms will not be entitled to any prize and must return any claimed prize within 30 days of a request to do so. The Promoter will have the final decision on what to do with the prizes (including announcing a new winner who will become entitled to that prize).

6 Liability

- 6.2 Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
- 6.3 Reece Account Customers are not permitted to copy and share the link with other customers, refer to clause 6.4 (c) below.
- 6.4 Any attempt to cause malicious damage, interference with or to undermine:
- (a) the business of the Promoter;
 - (b) the normal functioning of, or the information on, the website(s) of the Promoter or;
 - (c) the security, fairness, integrity or proper conduct of this Promotion,
- will constitute a breach of these Terms.
- 6.5 The Promoter reserves its rights to recover damages or other compensation from any person who breaches these Terms.
- 6.6 To the maximum extent permitted by law, each entrant indemnifies, and must defend and hold harmless, the Promoter and each of their employees, servants, agents and contractors, from and against all losses arising from:
- (a) a breach by the entrant of any of these Terms;
 - (b) any third-party claim arising directly or indirectly from a breach by the entrant of any of these Terms;
 - (c) any negligent, wilful or otherwise wrongful act or omission of the entrant;
 - (d) any fraudulent or dishonest acts or omissions by the entrant;
 - (e) any breach by the entrant of any applicable laws; and
 - (f) any claim by any third-party (including individuals, legal entities and governmental departments or agencies) arising directly or indirectly as a result of the entrant entering the Promotion.

- 6.7 Facebook, YouTube and Instagram may be used to advertise or promote the Promotion. By entering the Promotion, entrants agree that the Promotion is in no way sponsored, endorsed or administered by, or associated with Facebook, YouTube or Instagram; and to release Facebook, YouTube and Instagram from all liability in relation to this Promotion. - 6.8 Nothing in these Terms limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the *Competition and Consumer Act 2010 (Cth)*, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia ("Non-Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any event, circumstances, loss or expense arising from the Promotion for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion.

7 Privacy

- 7.1 The Promoter collects **Personal Data and Personal Information** as defined by the *Privacy Act 1998 (Cth)* about an entrant to include the entrant in the Promotion, award the prizes (where appropriate) and use the information to assist in marketing of the Promoter and its products and services. If the Personal Information requested by the Promoter is not provided, the entrant will not be eligible to participate in the Promotion.
- 7.2 By entering into the Promotion, each entrant consents to the Promoter using the entrant's name, locality, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media worldwide at any time without further notification, remuneration or compensation for the purpose of promoting, publicising, or marketing the Promotion (including any outcome), and/or promoting any products or services manufactured, distributed and/or supplied by the Promoter.
- 7.3 By entering into this Promotion, each entrant consents to the collection, use and disclosure of the entrant's Personal Information by the Promoter to:
- (a) provide the relevant prize to the entrant if the entrant is a winner; and
 - (b) contact the entrant in the future with information about the Promoter and its affiliates, including special offers, market research, or to provide the entrant with marketing materials via any medium.
- 7.4 The entrant agrees that, in the event they are the winner, the entrant will participate in all reasonable activities in relation to the Promotion as requested by the Promoter and sign any additional documents reasonably required by the Promoter to give effect to this condition. The entrant will not be entitled to any compensation or remuneration for participating in those activities.
