TERMS & CONDITIONS

1. MILWAUKEE TOOL (AUSTRALIA) (ABN 98 002 277 509) of PO Box 302 Mount Waverley VIC 3149 and Rothenberger Australia (ABN 12 008 411 658) of 6/13 Hoyle Ave, Castle Hill NSW 2154, Australia like to reward its loyal customers.
2. This promotion is conducted by Reece (the Promoter).
3. These Terms & Conditions set out the basis on which Eligible Entrants are eligible to receive a Gift from Milwaukee or the Promoter as part of the Promotion.
4. By participating in the Promotion, Eligible Entrants are deemed to have agreed to comply with these Terms & Conditions.
5. While we strive for accuracy in our catalogue, errors may occur. We reserve the right to correct any errors, inaccuracies, or omissions, including after an order has been submitted and whether or not the order has been confirmed and your payment processed. In such cases, we will notify you of the error and offer the option to proceed with the corrected order or cancel it for a full refund.

ELIGIBILITY

6. Participation in the Promotion is open to all Australian residents (Eligible Entrant).
7. Employees (and their immediate families) of Reece, Milwaukee, their related bodies corporate (within the meaning of the Corporations Act 2001 (Cth)), and agencies associated with this Promotion, are ineligible to participate in this Promotion.

PROMOTION CRITERIA

8. Subject to these Terms & Conditions, each Eligible Entrant who spends the required minimum amount in one transaction of certain Milwaukee and Rothenberger branded products (each minimum amount includes GST and is listed in the Schedule to these Terms & Conditions) (Eligible Spend) between 12:01am (AEST) on 1 June 2026 and 11:59pm (AEST) on 31 July 2026 (Promotional Period) from a Reece store in Australia will be eligible to receive the applicable gift listed next to the Eligible Spend in the Schedule (Gift).
9. The Eligible Spend can only be made in a single transaction.
10. If any item purchased during the Promotional Period (the cost of which attributed to the Eligible Spend required to receive a Gift) is returned to Reece for a refund, that product will not count towards the Eligible Spend that entitles an Eligible Entrant to a Gift under these Terms & Conditions. However, if a product is exchanged for another (excluding any of the excluded items listed in the Schedule) during the Promotional Period, the replacement product will count towards the Eligible Spend that entitles an Eligible Entrant to a Gift under these Terms & Conditions. This clause does not limit an Eligible Entrant's rights under section 21 of these Terms & Conditions.
11. Automated entries, fraudulent entries, or entries by persons using an alias, will be ineligible to count towards a Gift.
12. The Promoter reserves the right, at any time to verify:
 - a) the validity of entries,
 - b) tax invoice(s) relating to the Eligible Spend, and
 - c) the details of any Eligible Entrant (including identity and place of residence).
13. The Promoter reserves the right, at any time to disqualify:
 - a) any entrant who is ineligible to enter this Promotion or fails to fulfil the criteria to be an Eligible Entrant,
 - b) invalid or non-compliant entries (including items attributed toward the Eligible Spend that cannot supported by a proof of purchase), and
 - c) Eligible Entrants who fail comply with these Terms & Conditions.
14. The Promoter may exercise its rights referred to in sections 11 and 12 above at any time, including where it becomes aware of the invalidity or non-compliance of an entry or entrant after awarding

- a Gift. In that case, the Promoter may require the person who received the Gift, to return it or make a payment of the value of the Gift to the Promoter immediately.
15. On or around the last day of either June or July 2026, the Promoter will notify Eligible Entrants who are eligible to receive a Gift under this Promotion, and thereafter, make the Gift available for collection by the Eligible Entrant at a Reece retail store as notified to the Eligible Entrant (typically the Eligible Entrant's 'home' Reece retail store) within six (6) weeks from the end of the Promotional Period.
 16. Please allow up to six (6) weeks from the end of the Promotional Period for delivery of the Gift.
 17. If any Gift (or any part of the Gift) is unavailable, the Promoter, in its absolute discretion, reserves the right to substitute the Gift (or any part of the Gift) with another gift of equal value.
 18. Unless otherwise expressly stated in these Terms & Conditions, Gifts or any unused portion of a Gift, are not transferable or exchangeable and cannot be redeemed for cash.
 19. Eligible Entrants must retain the original tax invoice, or a legible photocopy of the tax invoice, for the duration of the Promotional Period plus a period of four (4) months after the end of the Promotional Period, as proof of purchase of the products attributed to the Eligible Spend by Eligible Entrant in connection with this Promotion. The Promoter may require Eligible Entrants to submit a tax invoice (or copy) for verification purposes as a condition of the Eligible Entrant receiving a Gift. Each tax invoice relating to the purchase made toward the Eligible Spend must clearly indicate that a product whose purchase counted toward the Eligible Spend was purchased within the Promotional Period. Failure by an Eligible Entrant to provide proof of purchase when requested by Reece may, in Reece's absolute discretion, result in invalidation of the relevant entry and ineligibility to receive a Gift.

GENERAL

20. All costs related to participating in this Promotion, and any tax liability arising out of participating in this Promotion, are the responsibility of the Eligible Entrant.
21. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the Promoter's reasonable control, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion and to the fullest extent permitted by law:
 - a) to disqualify any Eligible Entrant; or
 - b) subject to any written directions from any applicable regulatory authority, to modify, suspend, terminate or cancel the Promotion, as appropriate.
22. Nothing in these Terms & Conditions exclude, restrict, or modify any consumer guarantee, right or remedy conferred by the Australian Consumer Law or any other applicable law that cannot be lawfully excluded, restricted, or modified by agreement.
23. Except for any liability that cannot by law be excluded, each recipient of a Gift agrees that they take the Gift at their own risk and Promoter (including its respective officers, related bodies corporate, employees and agents) is not responsible, and excludes all liability whether in contract, tort (including negligence) or otherwise, for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of or in connection with the Promotion (including, without limitation, any delay in delivering the Gift for any reason).
24. To the maximum extent permitted by law, each Entrant indemnifies, and must defend and hold harmless, the Promoter and each of their employees, servants, agents and contractors, from and against all losses arising from:
 - a) a breach by the Entrant of any of these terms;
 - b) any third party claim arising directly or indirectly from a breach by the Eligible Entrant of any of these Terms;
 - c) any negligent, wilful or otherwise wrongful act or omission of the Eligible Entrant;
 - d) any fraudulent or dishonest acts or omissions by the Eligible Entrant;
 - e) any breach by the Eligible Entrant of any applicable Laws; and
 - f) any claim by any third party (including individuals, legal entities and governmental departments or agencies) arising directly or indirectly as a result of the Eligible Entrant entering the Promotion.
25. Eligible Entrants must not assign or transfer or purport to assign or transfer to any other person any of their rights under these Terms & Conditions. The Promoter may assign or transfer to a

related body corporate (within the meaning of the Corporations Act 2001 (Cth)) any of their rights or obligations under these Terms & Conditions.

26. These Terms & Conditions are governed by the laws of Victoria.
27. Any part of these Terms & Conditions that is unenforceable, ambiguous, or illegal will be severed, and such severance will not affect the enforceability of the remaining provisions of these Terms & Conditions.
28. The Promoter's decision not to enforce a specific section of these Terms & Conditions does not constitute a waiver of that restriction or of these Terms & Conditions generally.
29. The Promoter's decision in relation to this Promotion are final and no correspondence or communication will be entered into in relation any aspect of this Promotion.

PRIVACY

30. The Promoter collects Personal Data and Personal Information as defined by the *Privacy Act 1998* (Cth) about an entrant to include the entrant in the Promotion, award the prizes (where appropriate) and use the information to assist in marketing of the Promoter and its products and services. If the Personal Information requested by the Promoter is not provided, the entrant will not be eligible to participate in the Promotion.
31. By entering into the Promotion, each entrant consents to the Promoter using the entrant's name, locality, likeness, image and/or voice (including photograph, film and/or recording of the same) in any media worldwide at any time without further notification, remuneration or compensation for the purpose of promoting, publicising, or marketing the Promotion (including any outcome), and/or promoting any products or services manufactured, distributed and/or supplied by the Promoter.
32. By entering into this Promotion, each entrant consents to the collection, use and disclosure of the entrant's Personal Information by Reece to provide the relevant prize to the entrant if the entrant is a winner.
