



ASSUMPTION OF RISK AGREEMENT (18+)

TO BE SIGNED BY EACH PARTICIPANT AGE 18 OR OLDER

IN CONSIDERATION for myself,	(the "Participant") participating in the
Business & Education Partnership of Waterloo Region's ("BEP") Youth Creativity Fund program created
to further BEP's charitable purposes (the "Program"), and for o	ther good and valuable consideration, the
undersigned, being the Participant, agrees to all the terms and o	conditions set forth in this Assumption of
Risk Agreement (this "Agreement"):	

SUPERVISION & RISKS

- 1. I acknowledge that I may be exposed to physical and/or emotional harm by participating in the Program. I am voluntarily exposing myself to physical or emotional risks inherent to the activities which I detail in my Application.
- 2. I further acknowledge that I have reviewed the risks that are associated with my participation in the Program and that I appreciate and understand these risks.
- 3. I further acknowledge that I may cause physical or property damage to third parties, as well as myself, by participating in the Program and confirm that I have sufficient insurance coverage to provide sufficient remedies at law to cover any related damages.

COLLECTION & USE OF INFORMATION

- 4. I consent to the collection of, and grant full permission in perpetuity to BEP and its affiliates and Program sponsors, to copy, reproduce, use, reuse, license, exhibit, display, distribute and create derivative works of, any photographs, slides, films, videotapes, recordings, or any other content taken of me in connection with the Program, whether in print, online, digital, electronic or other format for any purpose whatsoever (including, but not limited to, promotional materials such as informational brochures, websites, television shows and public information campaigns) and to make such materials available to third parties for broadcast and/or publication without further notice and with no financial or other consideration to be paid to me in connection therewith. I acknowledge and accept that such materials, including any appearance of myself included therein, may be edited at the sole discretion of BEP and its affiliates, and their related organizations or Program sponsors. I understand that such parties are not obligated to use such materials and that the materials will not be provided or returned to me.
- 5. I understand that in the course of my participating in the Program, I may have access to confidential information related to BEP and the Program. "Confidential Information" means all information, and all documents which record information, whether on paper, in digital, electronic format or otherwise, relating to BEP and its affiliates (including, without limitation, the terms of this Agreement, plans, results, prospects, or donor information), which is of a confidential nature. I agree never to disclose such Confidential Information to any third party and understand that breaching this agreement may lead to my removal from the Program.
- 6. I consent to BEP's collection, use, and disclosure of the personal information included in my Application and submitted throughout my participation in the Program.

- 7. I understand that I will have ongoing reporting obligations as part of the Program which I will be required comply with as part of my participation in the Program. I acknowledge that as part of these reporting obligations I will need to justify how I used the funds provided to me by BEP.
- 8. I understand that I can end this Agreement at any time and, should I choose to do so, I agree to provide as much advance notice as possible to BEP.
- 9. I understand that this Agreement shall be construed and enforced in accordance with the laws of the Province of Ontario and the laws of Canada applicable therein. This Agreement enures to the benefit of BEP and its successors and assigns and is binding upon me.
- 10. Because funding for this program has been received through the Canada Service Corps, the following information will be shared with the Government of Canada related only to participants 15 years of age or older, if provided, to allow Canada to measure the results and evaluate the success of their funding and meet their accountability to the public: province of residence, gender, racial and/or Indigenous identification; age range; level of education; project start date; hours spent on the project; number of grantees and team members that participated in each project; total amount disbursed per project.
