Automatic Knife Warranty Return Form

The CRKT product warranty covers any defects in materials or workmanship to the original owner. If one of our knives or tools ever breaks or fails because of material or manufacturing defect, at CRKT's option the product will be repaired, replaced, or substituted with a product of equal value. Broken blades are not covered if the item has been used in any manner other than its intended purpose of cutting. Coverage ends if you sell or otherwise transfer the knife to someone else, or if your CRKT knife is modified in any way.

NOTE: Any automatic knife returned for warranty or service from outside of Oregon must also include either a signed "Automatic Opening Knife Acknowledgment Form" (see next page) or be returned through an authorized CRKT dealer. No exceptions will be made.

By completing this document, you are acknowledging that you truthfully agree to your status as one or more of the exemptions listed below.

Federal law prohibits shipment of automatic knives across state lines, with the following exceptions:

- To civilian or Armed Forces supply or procurement officers and employees of the Federal Government ordering, procuring, or purchasing such knives in connection with the activities of the Federal Government;
- 2. An active Armed Forces member or employee acting in the performance of his or her duty;
- 3. To supply or procurement officers of the National Guard, the Air National Guard, or militia of a state, territory or the District of Columbia ordering, procuring, or purchasing such knives in the connection with the activities of such organization;
- 4. To supply or procurement officers or employees of the municipal government of the District of Columbia or the government of any State or Territory, or any county, city or other political subdivision of a State or Territory;
- 5. To manufacturers of such knives or bona fide dealers therein in connection with any shipment made pursuant of an order from any person designated in paragraphs 1, 2, 3, and 4.

It is your sole responsibility to ascertain and obey all applicable local, state, and federal laws with regard to the possession and use of automatic knives.

CRKT will not be held liable for the misuse or misrepresentation of the purchaser/recipient.

CRKT will not ship automatic knives to the following states - CA, CT, DE, HI, MA, MD, MN, NJ, NM, VT, or WA, with the exception of the A1005 Minnow Automatic knife which can ship to California.

CRKT will not ship automatic knives to PO/APO addresses.
