



Update - Weekend Simulated Trading Event Details

Event Details

The Exchange will conduct a Simulated Trading Event on Saturday, April 18, in advance of our plan to make test securities available on the production system beginning April 24. We are closely monitoring industry readiness as we prepare to commence trading and plan to continue issuing periodic updates as needed.

Details for Saturday, April 18, Weekend Event

On Saturday, participants will have the opportunity to connect to the LTSE production environment and test production functionality and settings. Participants in the Simulated Trading Event should expect to:

- Connect to their production sessions using their designated credentials
- View market data specific to LTSE on the SIPs
- Enter orders to the Exchange (Limit, MKT, IOC and ISO)
- Cancel on Disconnect
- Interact with liquidity provided by the Exchange for securities in the table below
