



## Updated Long-Term Stock Exchange Test Dates and Plans

Following yesterday's announcement to extend our phase-in schedule, LTSE will modify the scope of optional testing for both Saturday, March 21, 2020 and Saturday, March 28, 2020. In addition, the Exchange will offer two additional weekend test opportunities on April 4 and April 18. Details concerning the newly announced test dates will be provided closer to the events.

As previously noted, the Exchange will make test securities available on our production system beginning April 24, with the gradual phase-in of non-test securities anticipated to begin on May 15. See [MA-2020-006](#) for further detail.
