Democratic governance is reinvigorated by improving the **accountability**, **transparency**, **effectiveness** and **trustworthiness** of **rule-of-law** based institutions and policies and through the expansion of active and inclusive **citizenship** empowered by the safeguarding of **fundamental rights**.

## HORIZON-CL2-2025-DEMOCRACY-01 Advisory support and network to counter disinformation and foreign information manipulation and interference -FIMI- (CSA)

€ 3.5 million / 1 project

- Cooperation with previous or ongoing projects
- FAIR data principles

#### Scope

- The EU aims to counter disinformation and Foreign Information Manipulation and Interference (FIMI) by building on previous research and making its findings accessible to a wider audience.
- Proposals should utilize existing frameworks, such as the DISARM Framework, and collaborate with past and ongoing EU-funded projects to develop capacity-building activities and advisory support for stakeholders.
- The goal is to provide stakeholders, including public bodies, NGOs, and policymakers, with the tools and knowledge to identify and counter disinformation, and to explore the potential of new technologies, such as AI, to detect and prevent disinformation.

- EU institutions and decision-makers gain understanding and tools to prevent disinformation.
- Practitioners and organizations get access to networks, advisory support, and improved frameworks to detection
- Citizens and societal actors increase awareness and capacity to identify and counter disinformation.

### HORIZON-CL2-2025-DEMOCRACY-02 Fostering the consolidation of European science diplomacy (CSA)

€ 3 million / 1 project

- International cooperation particularly encouraged
- FAIR data principles

#### Scope

- Against the background of a rapidly changing geopolitical and scientific-technological environment, with global competitors
  using science diplomacy in a much more strategic manner, there is a need to consolidate European science diplomacy (ESD)
  efforts and explore synergies to tackle existing vulnerabilities.
- This CSA will contribute to consolidating the ESD landscape both in research and in practice, in particular by establishing a ESD Platform as a "do tank", supporting policy needs like (some examples): advise on the use of SD to help achieving EU's foreign and security policy goals; identify research needs and provide expert knowledge to policymakers and diplomatic services through science advice and science communication, strengthening multilateralism and democratic governance; design methods for assessing the impact of relevant actions; explore synergies with other fields of diplomacy, tech / innovation / digital diplomacy, as well as public diplomacy and culture diplomacy...

- Taxonomy of ESD, mapping relevant players (academia, policymaking, diplomacy, civil society, private second overview of capacities, infrastructures, networks, training, strategies and publications, at national and EU
- Design and launch a ESD Platform as a community of research and practice.
- Competence frameworks and curricula for training, capacity-building, and mutual learning in European scient

### HORIZON-CL2-2025-DEMOCRACY-03 Preparing the EU for future enlargement: challenges and opportunities (RIA)

€ 10.5 million / 3 projects

Clustering and cooperation with other EU funded projects under Horizon Europe, Horizon 2020, Global Europe or the Instrument for Pre-accession is encouraged.

#### Scope

- This research aims at exploring the history, politics, and economies of candidate countries and potential candidates, considering the implications for a EU with over 30 Member States and drawing lessons from past enlargements.
- Proposal should examine the EU's readiness to enlarge, but also the "enlargement fatigue" and the rise of euroscepticism, to develop strategies to engage citizens and civil society, and promote a more inclusive enlargement process.
- The research should also investigate the role of education, societal dialogue, and digital tools in promoting EU integration and enlargement, including pilots in at least four EU Member States to test effective communication strategies.

- Provide policymakers and public administration with thematic insights on lessons learned from previous enlar
- Raise awareness of the implications of EU enlargement versus non-enlargement both in the EU and in (portion country (ies).
- Improve use of interactive tools to educate citizens on enlargement within the EU.
- Public involvement in enlargement is enhanced through transparent and participatory processes.

### HORIZON-CL2-2025-DEMOCRACY-04 Open strategic autonomy, economic and research security in EU foreign policy (RIA)

€ 7 million / 2 projects

- FAIR data principles

#### Scope

- The EU's open strategic autonomy refers to its ability to act independently in key policy areas, including energy, research, and defence.
- Recent initiatives, such as the European Economic Security Strategy and the Council's Recommendation on Enhancing Research Security, aim to strengthen the EU's autonomy and manage economic security risks.
- Proposals should contribute to clarifying key concepts, gathering evidence for policymaking, and analysing drivers and risks for open strategic autonomy and economic security in various sectors, including research and innovation.

- EU institutions and decision-makers have a solid evidence base for policymaking on open strategic autonomy security.
- They understand the benefits and impacts of these policies on the EU, its members, and partner countries
- They receive policy recommendations to enhance autonomy and security without harming economic and st EU's geopolitical influence.

### HORIZON-CL2-2025-DEMOCRACY-05 Countering and preventing radicalisation, extremism, hate speech and polarisation (RIA)

€ 10.5 million / 3 projects

- Clustering & cooperation
- FAIR data principles

#### **Scope**

- Radicalisation, extremism, and hate speech are growing threats to democracy and social cohesion, amplified by social media and algorithm-driven personalisation.
- Online interactions and media outlets can distort public discourse, fostering misinformation and disinformation, and proposals should consider both online and offline social networks.
- Research activities should involve a wide range of stakeholders, including public bodies, media organisations, and social media platforms, to test and implement research results and provide access to necessary data.

#### **Expected outcomes**

• EU decision-makers and researchers gain a comprehensive understanding of radicalisation, extremism, and hat deliver effective provention measures.

• Improved understanding of hate ecosystems, disinformation, and hate speech, and their links to radicalisati

 Enhanced understanding of media consumption, polarisation, and the role of traditional and social media in disinformation.

New tools and methods to assess source reliability, improve journalistic practices, and provide training for educations and extremism.

### HORIZON-CL2-2025-DEMOCRACY-06 Towards a European research hub on contemporary antisemitism and Jewish life and culture (CSA)

€ 3.5 million / 1 project

- International cooperation encouraged
- Invitation to consider the data offered by European Research Infrastructures in the SSH domain
- 3 years minimum duration

#### Scope

- Establish a network of researchers on contemporary antisemitism and Jewish life in Europe
- The network will need to work on its mid- and long-term sustainability and the proposals should demonstrate the capacity of the consortium to secure funding beyond the project's lifetime.
- The network should be anchored within an appropriate existing research community, and provide opportunities for members to meet in person (conferences, seminars, events etc)

- Network of practitioners, including researchers in the field of contemporary antisemitism and research on Jewish
- Discussion and formulation of methodological standards in the field are facilitated
- Strategic planning for the field on a Europe-wide level, including a concrete and credible action plan to rendesitations.
- Deepened links between research and policymaking within and for Jewish communities as part of the wider nurturing Jewish life in Europe

### HORIZON-CL2-2025-DEMOCRACY-07 The autocratic appeal: nature, drivers and strategies (RIA)

€ 10.5 million / 3 projects

- International cooperation encouraged
- Multidisciplinary and actor-based approach
- Engage citizens and civil society organisations
- Clustering with projects funded under the topic and collaboration with previous/ongoing projects

#### Scope

- Instead of the announced triumph of the liberal democratic order, authoritarianism seems to have gained appeal while the democratisation wave rolls back.
- Social and psychological aspects, as well as philosophical and historical dimensions, to be considered for the analysis of growing acceptance of autocratic approaches in well-functioning democracies.
- The resistance playbook against autocratisation requires further investigation: the actors resisting autocratisation and their strategies, the modalities and patterns of resistance, including in the digital realm as reaction to digital authoritarianism.

- Updated and exploitable scientific knowledge and understanding of the increasing autocratic tendencies is av policymakers, public authorities and citizens.
- Methods and tools capable of a) early warning and characterisation of autocratic tendencies, their drivers a
  identifying tactics for resisting and combating them.
- Relevant actors (democratic governments, media, civil society organisations) are enabled to take more information when engaging and dealing with autocracies

### HORIZON-CL2-2025-DEMOCRACY-08 Economic inequalities and their impact on democracy (RIA)

€ 10.5 million / 3 projects

- Proposals should consider at least three additional intersecting dimensions of inequalities alongside economic ones, such as sex, gender, disability, social class, religion or belief, age, and racial or ethnic origins.

#### Scope

- Economic inequalities (income, wealth, and access to resources) threaten democratic legitimacy by fueling polarisation, eroding trust, and undermining inclusion and representation.
- Projects should explore how actual inequalities and citizens' perceptions of inequality affect attitudes toward democracy, trust in institutions, participation, and support for rights, while considering the roles of media, mobility, and intergenerational transfers.
- Proposals are encouraged to examine the efficiency and effectiveness of public policies in addressing inequalities, involve diverse disciplines, and build on existing EU-funded research and networks as listed in the topic.

#### Expected outcomes

Better understanding of the interplay between economic inequalities and democratic attitudes across diverse.

### HORIZON-CL2-2025-DEMOCRACY-09 Balancing the fight against disinformation and the right to freedom of expression (RIA)

€ 10.5 million / 3 projects

- FAIR data principles

#### Scope

- Misinformation and disinformation can hinder responses to challenges like climate change and public health, and solutions
  must be based on evidence.
- Proposals should investigate how media systems favour disinformation, including market incentives and regulations that balance freedom of expression with countering disinformation.
- Research should develop a healthy online media sphere, including trust indicators and fact-checking, and involve media organisations and practitioners to counter disinformation and astroturfing, and understand the role of mediators and media dissemination hubs.

- EU institutions and decision-makers are better equipped to prevent disinformation while protecting freedom
- · They understand how digital media shapes public opinion and can regulate it without compromising citizen
- Projects aim to increase knowledge and tools to counter disinformation, including understanding astroturfing media literacy. [OPTIONAL]

#### **HORIZON-CL2-2025-DEMOCRACY-10**

The role of civic and citizenship education for strengthening civic and democratic participation and support for common European values (RIA)

€ 10.5 million / 3 projects

Consortia must include at least one secondary or higher education establishment, or public body with the capacity to roll out curricula, or public body in charge of teacher education and training; and at least one civil society organisation.

#### Scope

- Formal education, can also cover non-formal education; Age range of 15 to 29 years old
- Develop young people's critical thinking, willingness to participate.
- Assess effectiveness of teaching methods.
- Test innovative methodologies.

#### **Expected outcomes**

Policymakers, education and training institutions, and educators have a better understanding of :

- how citizenship education is best learned, taught, and assessed.
- what the impact of citizenship education is on young people's civic and democratic engagement
- what are effective collaborative mechanisms between different actors in formal and/or non-formal education delivering effective citizenship education

Policymakers, education and training institutions, and educators can roll out transformational and action-oriented approaches to citizenship education

### HORIZON-CL2-2025-DEMOCRACY-11 Independence of the judiciary as an aspect of rule of law compliance (RIA)

€ 10.5 million / 3 projects

Proposals are encouraged to network with and build on EUfunded projects under the Horizon Europe or the Citizen, Equality, Rights and Values, and the Internal Security Fund.

#### Scope

- The EU already has tools, such as the annual EU Justice Scoreboard and the annual European Rule of Law Mechanism, which provide valuable insights into the functioning of justice systems across the EU.
- This research aims to increase understanding of international and EU standards' implementation and impact on judicial independence, and to build knowledge on national legal practices and frameworks.
- •It should consider the complexities of national justice systems and ongoing reform efforts and explore how these factors impact the functioning of safeguards for judicial independence in different Member States.

- EU authorities and public authorities will have access to comparative research information on the independence, impartiality, and integrity of judicial institutions across the EU.
- Policymakers and judicial authorities will have a better understanding of the functioning of the safeguards for judicial each other's justice systems, strengthening judicial cooperation between the Member States.
- Policymakers and public administrations in Member States are provided with research on the implementation a international and EU rules and standards to better assess their impact on judicial independence.
- The EU's capacity to proactively promote the rule of law, fundamental human rights, and democracy will be strengunderstanding of the functioning of the safeguards for judicial independence in the Member States

### HORIZON-CL2-2025-DEMOCRACY-12 Community of democracy practitioners and researchers (CSA)

€ 3.5 million / 1 project

 Consortia must include, as beneficiaries or affiliated entities, at least one public body with a policy-making role, and at least one civil society organisation.

#### Scope

Establish an innovative successor to the Nets4Dem network of democracy research organisations and practitioners of
democratic innovation, which will produce policy recommendations, help policymakers design civic participation strategies,
organise retreats for policymakers to learn and exchange from experts and peers on democratic strengthening and renewal,
design capacity building activities on participatory and deliberative democracy, organise conference(s) on democratic
innovation.

#### **Expected outcomes**


