1. Introduction

The European Commission is committed to protect your personal data and to respect your privacy. The Commission collects and further processes personal data pursuant to [Regulation \(EU\) 2018/1725](#) of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data.

This privacy statement explains the reason for the processing of your personal data in the context of your subscription to the Research and Innovation Community platform (mentioned as “the platform” hereafter). It explains the way we collect, handle and ensure protection of all personal data provided, how that information is used and what rights you have in relation to your personal data. It also specifies the contact details of the responsible Data Controller with whom you may exercise your rights, the Data Protection Officer and the European Data Protection Supervisor.

The information in relation to processing operation of the event, undertaken by the Directorate-General for Research & Innovation (DG RTD), is presented below.

2. Why and how do we process your personal data?

Purpose of the processing operation: The controller collects and further processes your personal data to provide you with information about the events and content on the platform (before, during and after) and to process your application for participation in events.

Live web-streaming and audio-visual recording of the speakers and organisers, as well as photographs of the speakers may be taken and published in the context of the events on online resources of the European Commission such as the Streaming Service of the European Commission (<https://webcast.ec.europa.eu/>), YouTube account of DG RTD (<https://www.youtube.com/c/EUScienceInnovation>), other YouTube accounts managed by the European Commission and websites under Europa.eu domain.

Your personal data will not be used for any automated decision-making including profiling.

The data controller shall not be held accountable for any processing of personal data that you might carry out on your own initiative during or after the event. For instance, if you decide to take photographs/audio-visual recordings of participants of the event and/or publish them online, you assume full responsibility for these actions.

3. On what legal ground(s) do we process your personal data?

The processing operations on personal data, linked to the organisation, management, follow-up and promotion of the event (including web-streaming, photos, audio-visual recording) are necessary for the management and functioning of the Commission, as mandated by the Treaties. Those provisions are in particular, the communication actions to promote the activities and results of the programme as explained in the General Provisions of Framework Regulation for Horizon 2020, Horizon Europe and other EU-funded Programmes as well as Article 11 of the Treaty on European Union and Article 15 of the Treaty on the Functioning of the European Union.

Consequently, those processing operations are lawful under Article 5(1)(a) of Regulation (EU) 2018/1725 (processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the Union institution or body).

Your consent is required for:

- The processing of your personal data relating to the creation of your online account;
- The sharing of the event's participants list containing your name and affiliation with other participants for networking purposes solely within the event platform;
- The sharing of the meeting/event attendee list containing your name and affiliation among participants, in order to create working groups to continue the collaborate work launched during the event;
- The processing of your personal data for inviting you to future events the data controller may organise;
- The processing of your personal data for managing your subscription to a newsletter of the data controller.

4. Which personal data do we collect and further process?

The following personal data will be processed:

- Mandatory for registration on the platform: first name, last name, e-mail address.
- Optional for monitoring and communication purposes: Title, Academic Title, Year of birth, Nationality, Phone number, Organisation type, Organisation name, Position, Current location, Biography, Topics of interest (via predefined list), Social media profile links (Facebook, LinkedIn, Twitter), URL of website, Photograph.

5. How long do we keep your personal data?

The Data Controller only keeps your personal data for the time necessary to fulfil the purpose of collection or further processing.

For each of the categories of personal data that is processed, please find below the retention details and the reference to the relevant record of processing:

- All mandatory personal data provided during registration will remain on the platform until the account deletion by the user;
- All optional data provided during registration will remain on the platform until the account deletion or until user modification, removing this data from the optional fields in the profile;
- In case of audio-visual recording of the event, the recordings will be stored on online resources and social media platforms managed by of the European Commission for an undetermined period. These resources include websites under Europa.eu domain such as the Streaming Service of the European Commission (<https://webcast.ec.europa.eu/>), and social media platforms such as the YouTube account of DG RTD (<https://www.youtube.com/c/EUScienceInnovation>) and others. 6. How do we protect and safeguard your personal data?

All personal data in electronic format (e-mails, documents, databases, uploaded batches of data, etc.) are stored on the servers of the European Commission. All processing operations are

carried out pursuant to [Commission Decision \(EU, Euratom\) 2017/46](#) of 10 January 2017 on the security of communication and information systems in the European Commission.

In order to protect your personal data, the Commission has put in place a number of technical and organisational measures. Technical measures include appropriate actions to address online security, risk of data loss, alteration of data or unauthorised access, taking into consideration the risk presented by the processing and the nature of the personal data being processed. Organisational measures include restricting access to the personal data solely to authorised persons with a legitimate need to know for the purposes of this processing operation.

The Commission's contractors are bound by specific contractual clauses for any processing operations of your personal data on behalf of the Commission, and by the confidentiality obligations deriving from the General Data Protection Regulation ('GDPR' - Regulation (EU) 2016/679).

7. Who has access to your personal data and to whom is it disclosed?

Access to your personal data is provided to the Commission staff responsible for carrying out this processing operation and to other authorised Commission staff according to the "need to know" principle. Such staff abide by statutory, and when required, additional confidentiality agreements.

Where necessary, we may also share your information with service providers for the purposes of organising events and content under the platform:

- VO Europe SA (Communication Agency);

- Eyes On GmbH (video conferencing tool);
- DeadSimple Chat (chat);
- Talk JS (networking tool);
- Calendly (book a Meeting tool);
- Contentfull (CMS – Speaker names);

- VideoHouse (Media agency);

Third party IT tools, including Social Media

We use third party IT tools to inform about and promote the event (e.g. Sli.do), which may collect personal data and have their own cookies and privacy policies. The use of a third party IT tool, does not in any way imply that the Agency or European Commission endorses them or their privacy policies. In the event that one or more third party IT tools are occasionally unavailable, we accept no responsibility for lack of service due to their downtime.

We use third party IT tools to inform about and promote the event through widely used communication channels, including the social media. You can watch audiovisual material on the platform, which is hosted either via European Commission platforms such as the Streaming Service of the European Commission (<https://webcast.ec.europa.eu/>), or via third parties such as the DG Research and Innovation account on YouTube channel ([YouTube](#)) or other EC-managed accounts of the European Commission.

In order to protect your privacy, our use of third party IT tools to connect to those services does not set cookies when our website pages are loaded on your computer (or other devices), nor are you immediately redirected to those social media or other websites. Only in the event that you click on a button or “play” on a video to watch it, a cookie of the social media company concerned will be installed on your device. If you do not click on any social media buttons or videos, no cookies will be installed on your device by third parties.

In order to view such third-party content on our websites, a message will alert you that you need to accept those third parties’ specific Terms and Conditions, including their cookie policies, over which the Commission has no control.

We recommend that users read the relevant privacy policies of [Youtube](#), [Facebook](#), and [Twitter](#), carefully before using them. These explain each company’s policy of personal data collection and further processing, their use of data, users' rights and the ways in which users can protect their privacy when using those services.

Use of cookies

Cookies are short text files stored on a user’s device (such as a computer, tablet or phone) by a website. Cookies are used for the technical functioning of a website (functional cookies) or for gathering statistics (analytical cookies).

When you visit the website(s) of the platform and when you register, we will keep the browser history of your visit for a maximum of 2 years. This information will then be deleted. The collection, aggregation and anonymising operations are performed in the data centre of the European Commission under adequate security measures.

Enabling these cookies is not strictly necessary for the website to work but it will provide you with a better browsing experience. You can delete or block these cookies, but if you do that, some features of the meeting/event website may not work as intended.

The cookie-related information is not used to identify data subjects personally and the pattern data is fully under the Commission’s control. These cookies are not used for any purpose other than those described here.

Should you wish to opt your personal data out of our anonymised, aggregated statistics, you can do so on our cookies page. In particular, you can control and/or delete those cookies as you wish.

8. What are your rights and how can you exercise them?

You have specific rights as a ‘data subject’ under Chapter III (Articles 14-25) of Regulation (EU) 2018/1725, in particular the right to access, your personal data and to rectify them in case your personal data are inaccurate or incomplete. Where applicable, you have the right to erase your personal data, to restrict the processing of your personal data, to object to the processing, and the right to data portability.

You have the right to object to the processing of your personal data, which is lawfully carried out pursuant to Article 5(1)(a) of Regulation (EU) 2018/1725 on grounds relating to your particular situation.

The data will ensure that the data subjects can exercise their right to object to processing whenever possible by the organisers of the meeting/event.

You have consented to provide your personal data to the data controller for the present processing operations. You can withdraw your consent at any time by notifying the data controller. The withdrawal of your consent will not affect the lawfulness of the processing carried out before you have withdrawn the consent.

You can exercise your rights by contacting the data controller, or in case of conflict the Data Protection Officer. If necessary, you can also address the European Data Protection Supervisor.
