The completed, signed form must accompany the contract/purchase order at the time of submission.

I (We) acknowledge that U.S. law prohibits the sale, transfer, export, or re-export or other participation in any transaction involving products with individuals or companies identified on the U.S. Department of Commerce restricted party list (i.e. entity, denied party..etc), the U.S. Department of Treasury Specially Designated Nationals Lists.
- 9. I/We certify that the products(s) will not be exported/reexported for military end use, or to military end users in China, or Venezuela without the appropriate export license or approval from the US government.
- 10. I/We certify that the products(s) will not be exported/reexported to the following regions in Ukraine, Crimea, Donetsk People’s Republic and Luhansk People’s Republic regions of Ukraine as well as Russia and Belarus.
- 11. I/We will also comply with all applicable laws and regulations regarding export-controlled items defined or sold under this contract, and shall not export, re-exports, transfer, divert or disclose any Products or Proprietary information, to any destination restricted or prohibited by US export laws, or without the appropriate export license or approval from the US Government.
