# I. Guiding principles

Changes of the Diesel surcharge are calculated based on the following principles:

- I. Official sources determine the base for adjustments.
- 2. An adjustment of the freight agreements will be performed on a monthly basis applying a defined threshold.
- 3. Equal treatment the same adjustment factors are used for increases as well as decreases of the Diesel surcharge.
- 4. Traceability: Applicable values shall be documented in the respective freight agreement.

The MBS Diesel model, latest version, is an integral part of the MBS "General Terms and Conditions" for road and intermodal transportation in Europe. Any other Diesel price model will not be accepted by MBS.

# I. Guiding principles

## Calculation principles

#### Monthly Average

- Calculation as an average per month and country
- The Diesel price value of the country of the transport source / loading point is applicable

## Threshold

 Any deviations of the monthly average Diesel price value of at least +/-10% lead to an adjustment of the Diesel surcharge

# Applicable surcharges

- The same adjustment factors are used for increases and decreases
- The adjustment factors always refers to the <u>base freight</u> and NOT to an already diesel-adjusted rate
- Adjustment factors will increase/decrease by steps of 2,75

• The Diesel price reference value and the applicable adjustment factor shall be documented in the respective freight agreement




# I. Guiding principles

## **Reference value**


- If not specified by MBS, the reference value is the average Diesel price value of the month previous to the final price setting
- Any Diesel adjustment leads to a new reference value
- The new reference value is >/= 10% above or below the previous baseline

## **Example: Increase of the Diesel price surcharge**



# 2. Process of Diesel price adjustments



- > Surcharges / deductions can only be applied by using the average value of the previous month.
- Backdating will not be accepted
- Late application (after 15<sup>th</sup> of the month) will not be considered. Re-application is required in the following month.

# 2. Process of Diesel price adjustments

How to apply for an adjustment of the Diesel surcharge?

• Application <u>exclusively via e-mail</u> to your contact person within the MBS organization

Service providers need to apply for an adjustment of the surcharge by the 15<sup>th</sup> calendar of the month at the latest
