MasterCast 630S admixture is a ready-to-use plasticizer for use in no-slump concrete fabrication processes. Formulated to improve the manufacturing efficiency of non-plastic concrete products, this admixture adds a significant degree of cohesion for block and pipe applications. MasterCast 630S admixture improves cement particle wetting and increases strength development as a result.

#### **Guidelines for Use**

**Dosage:** MasterCast 630S admixture is recommended for use within a dosage range of 3-8 fl oz/cwt (195-520 mL/100 kg) of cement.

**Mixing:** For maximum efficiency, add MasterCast 630S admixture early in the sequencing procedure. Best results typically occur by adding the MasterCast 630S admixture during the prewet process (with at least 70-80% of the required mix water), before adding the cementitious materials. Allow a minimum of 90 seconds of additional mixing time after all components have been dispensed.

# Storage and Handling

**Storage Temperature:** MasterCast 630S admixture must be stored at temperatures above 40  $^{\circ}$ F (4  $^{\circ}$ C) and below 105  $^{\circ}$ F (42  $^{\circ}$ C). MasterCast 630S admixture should not be used after it freezes.

**Shelf Life:** MasterCast 630S admixture has a minimum shelf life of 12 months. Depending on storage conditions, the shelf life may be greater than stated. Please contact your local sales representative regarding suitability for use and dosage recommendations if the shelf life of MasterCast 630S admixture has been exceeded.

MasterCast 630S admixture is available in 55 gal (208 L) drums, 275 gal (1040 L) totes and by bulk delivery.
