1. PREAMBLE

- 1.1.** The International Biathlon Union (IBU), in collaboration with [Olympic Solidarity](#), is organising a training camp aimed at supporting developing National Federation Members and to promote Biathlon and Para Biathlon (**the IBU - IOC Camp**). Athletes and Coaches will be offered the opportunity to enhance their skills and knowledge for future International Competitions.
- 1.2.** The IBU - IOC Camp will comprise of both practical and theoretical training in sports and Biathlon and/or Para Biathlon. All IBU courses are facilitated to maximize candidate involvement in a high-quality learning environment. This will be achieved by blended



educational activities that involve varied training sessions, seminars and input provided by experts.

2. RESPONSIBILITY

2.1. National Federations and Heads of Delegations shall ensure that any and all charges and costs of health and accident insurance are carried by the participants of the IBU - IOC Camp at their own responsibility, except of the expenses as mentioned in this Declaration of Participation. The IBU is to be held harmless.

2.2. National Federations acknowledge full responsibility for any accidents, injuries, deaths, or other incidents involving their participants to the extent permitted by law.

3. ACKNOWLEDGMENTS

3.1. The Invited National Federation shall ensure that all participants it is sending to the IBU - IOC Camp hereby agree to be bound by and to comply with the IBU Rules, in particular the IBU Integrity Code.

3.2. The Invited National Federation shall ensure that all participants it is sending to the IBU - IOC Camp further confirm that they understand that failure to abide by the IBU Integrity Code during the course of the IBU - IOC Camp may result in disciplinary proceedings up to and including exclusion of the IBU - IOC Camp.

4. APPLICABLE LAW AND JURISDICTION

4.1. This Declaration of Participation and any dispute or claim arising out of or in connection with it or its subject matter shall be governed by and construed in accordance with the laws of Austria.

4.2. The participants of the IBU - IOC Camp and the IBU agree that any dispute, arguments or claims arising with respect to or in connection with IBU - IOC Camp shall be the object of an amicable resolution.

4.3. In the absence of amicable resolution, the dispute shall be submitted to the exclusive jurisdiction of the Court of Arbitration for Sport (CAS) in Lausanne, Switzerland, and settled definitively in accordance with the Code of Sports-related Arbitration. The panel will consist of one arbitrator. The language of the arbitration will be English.
