1	Welcome and approval of agenda • Agenda was approved
2	 Minutes from the previous meetings: Minor change in minutes from the event working group ACTION ITEM: Jan to share change details
3	 Reports from the Working Groups & Action Items IBU's team of race directors went to Interalpin fair in Innsbruck and connected with Biofuels Express in Austria, an alternative HVO provider Marlen was able to catch up with Sandy Lanz (BKW): temporary infrastructure (tents) heating feasibility study was not funded in full – planned change to focus on 2 case studies Wengen Alpine Ski World Cup – already using pellets for some temporary infrastructure heating Lenzerheide World Cup 2023 or World Championships 2025 Sandy will contact Riikka 120.000 liters of diesel were used for heating temporary infrastructure during the Oberhof 2023 World Championships => Not a best practice

•	 Decision: OC Sustainability: Charter for EHD Few changes in grammar and wording Will be signed by OC President and OC General Secretary and additionally, NF President The Commission decided to approve the Sustainability Charter as a voluntary commitment and to be included in the IBU Event Hosting Declarations (EHD) for 2023/2024 season – not for Summer Championships 2023 ACTION ITEM: IBU S&E will include the final charter in EHD 2023/2024 as one of the annexes and also present at OC Meeting
5	 Update: OC Sustainability Sustainability financial support concept (see above) First come first serve as limited budget will be available in season 2023/2024 OC Award This year is the second year Feedback: Prize money is helpful to have to invest in sustainability Ensure that the criteria is not too complicated for OC Positive media coverage resulted Good and important award as an incentive ACTION ITEM: Send out OC sustainability award application form as reference Last year, case studies of all applicants were designed and can be found here Event Recycling pilot Common templates for signage in IBU events in the accredited areas were created for recycling



	 IBU would like to have a panel discussion at the OC meeting on sustainability matters; recycling pilot as a discussion topic Feedback from Martin: Good initiative, worked great, should be continued. Feedback from Sari: Surprised that the Finnish team did not do great on recycling but the best team was awarded by OC Kontiolahti Jan: Containers were bought and organized special garbage pick up by the municipality of Nove Mesto Given that it was a pilot, Athlete ambassadors reported when they could not find the recycling bins as a given OC was not properly trying => Agreed that this will be a topic to discuss during the sustainability discussion at the OC meeting
6	 Decision: Sports for Nature Katrina's students from a MBA course at the University of Oregon conducted their group project on whether and how the IBU should join the Sports for Nature framework EU is currently drafting a directive for a lead ban If published and implement expect to have a 5 year transition period In accordance with its sustainability commitments, IBU would prefer to commit to a certain recovery rate but does not want to be limited by the method To join the Sports for Nature Framework, a document needs to be signed by IBU, not the NFs NFs can also sign but that is an independent NF decision Mapping created by Riikka explains the POTENTIAL impact if the IBU joined the framework, yet all measures are highly dependent on the Action Plan that the IBU would choose to adopt => Annual action plans would be reviewed by IBU Sustainability Commission and the EB before approval Feedback: Sari: an important step for the IBU to join especially given that the sport uses lead Jan: An IBU license application procedure should not go as far as requiring an EIA. In many countries, this is required by national legislation in certain cases and it involves a much more significant effort as typically also includes public consultation which often prolongs timeframes significantly.



	 Sport of cycling (UCI) has a Biodiversity Guideline (in checklist style) where the suggestion is to have an 'environmental screening'; EIA only suggested if severe environmental concerns are identified by a screening National legislation will have primary improtance also regarding any future IBU licensing regulations Marlen: In Switzerland, the topic is not a priority and also not included in Swiss-Ski's the sustainability strategy Klaus: Agrees with Marlen, not a focus in Germany Commission happy to recommend for the IBU to join the Sports for Nature Framework Overall, biodiversity is not a current priority at national level Generally speaking, the framework points out things that can be achieved, some that are already happening, and some that could look a certain way Initial IBU Action Plan under the Framework would foresee the development of a guideline which is not mandatory on the NFs or OCs and IBU would initially work with those that are already engaged in the topic
7	 IBU Updates IBU development support sustainability project received 5 applications SWE, NOR, FIN, LTU, POL all applied Decision will be made by end of June Snow Network / Sieppur project www.sustainablesnow.sport The first newsletter will be released in June University Grant: Texas AM University First ever research grant from the IBU regarding sustainability matters Looking into the decision making by fans on their travel to sports events How can the IBU reduce with impact of travel of the fans which is the main event impact IBU President meeting 1st July in Vienna Biathlon Canada did a risk assessment where sustainability as not highly rated – leads to limited budgets for sustainability as not a priority Is there the possibility to increase the importance of sustainability risk on assessment so that that topic is given higher priority? On IBU's list, sustainability is in the Top Ten twice, as nr 1 and nr 7, both long term and short term – IBU calculated the scores based on



	 likelihood of occurrence and its estimated financial impact where the financial risk in assessed within a certain time frame (10 years) Sustainability Education: All IBU staff will need to complete a 4-5h sustainability education online training in the IBU's new Learning Suite, consisting of 4 modules Macro level module (1): general topic and why is it important Micro level moduls (3-4): what does this mean for biathlon Ideas of opening it up to other snow sports as well, not only biathlon Commission suggests course should also be available for both NFs and also OCs To be also shared on the Presidents meeting in the introduction Suggest to make education available in the different languages: at least German, French, Italian Germany is currently working on training courses for coaches and athletes, possible to include there IBU learning suite will be available for all in late August; a sustainability module was already included in the Level 1 Coaching Certificate course
8	 Next meeting and any other business Switzerland preparing guidelines for sustainable snow sports events – how to report the preparation of the slopes when a resort operates a full season with several competitions How much energy and water is counted and how – any experience? Under Snow Network, the IBU collects data with the Position Green online tool Must consider timing of the most valuable events, timing of the distribution of snow during the season (i.e. related to timing of the main event) – these are considered into the calculation of what % is applied to IBU event in analysis of CO2 / event environmental impact Going forward, it will be ilmportant to consider the image of the winter sport when season starts – be prepared well with facts to counteract the negative image Big topic for sponsors as well ACTION ITEM: All to collect messaging and supporting facts/data points to share with all on what the real climate impact of snow sports with manmade snow is
