



## Conditions of participation Climate Club Trophy

As part of the communication via the International Biathlon Union (IBU) social media channels, IBU website, Viessmann Sport social media channels on Instagram and Facebook, the International Biathlon Union (IBU), Sonystraße 20, 5081 Anif b. Salzburg, Austria and Viessmann Climate Solutions SE, Viessmannstraße 1 in 35108 Allendorf (Eder), Germany, are organizing the Climate Club Trophy during the winter sports season 2022/23.

Official club representatives who have reached the age of 18 can participate on behalf of their club, which must be affiliated with the IBU through the federations.

Representatives of clubs who fill out the Climate Club Trophy form on the IBU website, submit their data and agree to the conditions of participation and data protection will participate. Participation via participation and entry services, automated participation and multiple participation are excluded. In the event of suspected manipulation, the organizer is entitled to exclude the respective participants.

Entries that do not comply with the rules of good manners and our netiquette will be removed without notice. These participants are thus excluded from winning.

The Climate Club Trophy starts on 25 January 2023 00:01 am and ends on 01 March 2023 11:59 pm. Submissions will only be accepted via the corresponding form on the IBU website. Only submissions in German or English language will be considered. All submissions after 01 March 2023 will not be considered.

The prize:

The prize of the Climate Club Trophy is a voucher for a Viessmann climate solution\*. The amount of the value voucher is calculated on the basis of all hits at the shooting range of the athletes at the Biathlon World Championships 2023 in Oberhof from 08 - 19 February 2023\*\*. For each hit, we increase the CO2 savings of the climate solution provided as a prize by 9 kg\*\*\* and thus the amount of the value voucher by 3 € \*\*\*.

\* The value voucher can be redeemed for the following Viessmann climate solutions in the amount of the voucher value: Photovoltaics, heat pump, solar thermal.

\*\*\* Calculation basis is a Viessmann photovoltaic system, details in the conditions of participation.

Calculation basis:

The basis of the calculation for the CO<sub>2</sub> savings and the value calculation is a Viessmann photovoltaic system (PV system) incl. installation at the reference location Allendorf (Eder), Germany under standard framework conditions (south orientation, 30° module inclination) and the system size of 30 modules á 410 Wp with a total output of 12.3 kWp and an energy yield of approx. 10,000 kWh/year. Further calculation bases are the average value of CO<sub>2</sub> emissions by electricity generation in the EU in 2021 of 0.275 kg/kWh (source: <https://de.statista.com/statistik/daten/studie/1009521/umfrage/co2-emissionen-durch-stromerzeugung-in-der-eu/>) and the consideration period of 20 years. With the mentioned energy yield under the mentioned conditions, this means approx. 2.75 t savings per year for the PV system and approx. 55 t CO<sub>2</sub> savings in the consideration period of 20 years. Assuming 6,000 shots of the athletes, 30 modules of the PV system and approx. 55 t CO<sub>2</sub> savings. Per hit at the Biathlon World Championships\*, the CO<sub>2</sub> savings are increased by approx. 9 kg, which corresponds to a monetary value increase of approx. 3 € per hit.

The participants for the preliminary top 3 selection will be selected by a jury consisting of representatives of the IBU and Viessmann on the basis of the evaluation criteria presented and will be informed by 07 March 2023 at the latest. They will receive a message via the provided email address and will be asked to report back to the IBU or Viessmann. These participants for the pre-selection will then be published via the IBU website and the final winning club will be determined via fan voting from March 13, 2023 0:01 am until March 19, 2023 at 11:59 pm via the IBU website. For this purpose, participants agree when submitting their initiatives that the provided descriptions of their sustainability initiatives as well as photo and video material and the club name may be published and used for an unlimited time in the context of communication via the International Biathlon Union (IBU) social media channels, IBU website, social media channels of Viessmann Sport on Instagram and Facebook. The fan voting from March 13 - 19, 2023 will be published on the IBU website and fans can vote for their favorite via voting form. The official representative of the winning club will then be contacted again directly by email. To redeem the prize, Viessmann Climate Solutions SE requires the full name and address of the winning club as well as the full name and address of the official club representative. The value voucher will be issued to the club and the corresponding address and can only be used for the club purposes. By confirming their win and providing their name and address, the winners agree to Viessmann Climate Solutions SE collecting, processing and using this personal data for the purposes of the competition. The data will be used exclusively for the purpose of the Climate Club Trophy and the competition. If the winners do not notify Viessmann Climate Solutions SE within two



days of receiving the information that they have won, the claim to the prize will be forfeited without compensation.

The value voucher can only be redeemed at an authorized Viessmann specialist partner in the local vicinity of the association. The name and address of the specialist partner will be provided by Viessmann. The value voucher is valid until 31.12.2024 and cannot be redeemed at a later date. The winners will be informed about the further processing and how the prize will be made available when they are contacted that they have won.
