IBU Executive Board Meeting 149

Munich/GER

- 1. <u>President's welcome</u>
 - The President welcomed the Executive Board members to the 149th IBU Executive Board meeting in Munich/GER. A special welcome went to former Interim Secretary General Alf Koksvik.

2. Approval of agenda items

- The agenda was approved as listed above.
- 3. Confirmation of EB minutes 148/2019
 - The minutes were approved without any comment.
- 4. <u>Reports</u>
 - I. President a.WCH Laser Run UIPM

- The President reported from the UIPM WCH in Budapest/HUN, where the President attended the Penthalon and the Laser Run competition. According to the President this competition with a laser pistol is especially used for the recruitment of athletes for the sport. The President also reported that he gave an appreciated speech at the UIPM Gala Event with several IOC Members and IF Presidents present.
 - b. OC Meeting Antholz/ITA
- The President reported from the very positive OC meeting, which was chaired and prepared by the SD and CD. Round-table sessions were hold around Sustainability and Social Media. The EB was informed that these meetings will be held annually from this year on.
- II. Other EB-members
 - EB Member Ivor Lehotan reported from his attendance with RD IBU Cup Kristjan Oja at the GAISF World Urban Games in Budapest/HUN. He informed the EB to be prepared for a winter version of the event as this is the trend in international sports.
 - Lehotan also reported about the presence of the IBU at the Forum Nordicum in Antholz/ITA. Together with the SD and CD, he particiated in panel discussions and presentations of the IBU to international Nordic ski journalists. According to Lehotan, the IBU needs to think about the way of participation in the future.
- III. Secretary General
 - The SG submitted a written report concerning the situation at the HQ. The SG raised concerns about the expectations on implementations of the commitments under the new Constitution and the Strategic Plan for which resources need to be adapted accordingly.
 - The SG reported that he has now formally ended his engagement with FIS.
 - The SG reported about assessment reports on good governance by international organisations like Play the Games and ASOIF. There will be improvement in the IBU score in the future under the new constitution but actions need to be implemented.

Jonathan Taylor presented the EB the interim report no. 8 of the External Review Commission (ERC). The report is published on the IBU <u>website</u>.

- Stephan Netzle informed the EB about the latest developments in the cases and investigations against Russian athletes based on the Moscow LIMS Data.
- The EB agreed in this regard that ongoing cases will stay with the ADHP, which will be dissolved after the cases are closed, and that any new cases would go to the Biathlon Integrity Unit/CAS ADD according to the new Constitution.
 - b. report "Criteria Follow-up RBU" (F.Steinle)
- Nothing to report since the last EB phone meeting. No answer has been received by the RBU to a letter which was sent to the NF detailing the criteria status.
- VI. Media- and Sponsorships rights
 - The SG reported about the current status of the negotiations for new media and sponsorship rights contracts, which have started by the IBU negotiation group. The update included the schedule for further proceedings. The EB started to discuss the National Federations to which the frames of the media and marketing contracts will be presented before the signature.

5. Finances

- I. Report: Follow-up, May-Sept 2019/20 (N.Carlsson)
 - The EB reviewed the financial report for the period May-Sept 2019 in a follow-up to the previous EB meeting 148.
- II. Report: Follow-up, Financial Reserves (O.Dahlin/K.Leistner)
 - The EB reviewed the monthly report of the financial reserves dated 30 September 2019. The VP Finances informed the EB about latest changes in the portfolio and interactions with the bank.
 - The EB agreed to a proposal by the VP Finances about an enhanced baggage insurance for officials traveling for IBU and additional outfits for officials representing IBU.
- III. Report: New Head-office (K.Leistner)
 - The VP Finance informed the EB that the renting contract for the new HQ in Anif near Salzburg has been signed and registered. He expressed his hopes to be able to buy the facilities at a later point.
 - The SD added that there will be a meeting with the architect to start the process of refurbishing for a move in May-June 2020.





- IV. Decision: PP-bonus (basis 2018/19)
 - The EB decided to confirm the presented proposal, which is attached as Annex 1 to these minutes. It was pointed out, that the PP-bonus will be a part of the review of NF Financial Support structure, so the NFs can't calculate with the same set-up the future.
- V. Decision: Request for support Alpencup
 - The Sports Director presented the submitted request for support of the Alpencup (by the NF SUI on behalf of all the Alpine NFs). The EB decided not to financially support the Alpencup for this time but will review such possibilityagain after the new IBU Development Support-system including a definition of regions has been finalized.
- VI. Decision: Additional Financial Support
 - The EB decided that the amount of € 1Million will be distributed as additional support to NFs. The EB tasked the IBU HQ with the support of EB Member Dagmara Gerasimuk to come up with a proposal for distribution principles for the next EB meeting.

 - The SG informed the EB about the recruitment process for the job opening of the IBU Development Director.

7. Sport

- I. Decision: Season calendar 2020/21: adjustment WC 7 & 8 (OWG Test Event China)
 - The EB decided to change the competition schedule for the season 2020/2021 switching the WC events in Beijing and Nove Mesto in order to allow the OWG test competition to take place at the same time as the OWG. The new season calendar is attached to these minutes as Annex 2.
- II. Season End Celebrations at WC, IBU Cup & Junior Cup
 - The EB decided to grant € 37.500 to support season end celebrations for the athletes of all three IBU competition series, distributed to the hosts of the season finals as follows: WC 25.000€, IBU Cup 7500€ and IBU Junior Cup 5000€
- III. New Venue SB WCH 2020



- After good faith discussions between the IBU and the OC Kontiolahti is was decided by mutual concent to reallocate the SB WCH 2020.
- Background of decision: the OC Kontiolahti is already hosting two World Cup events during the calendar year 2020 inclusing the new season opening and this decision will allow more focus on these important events.
- The Sports Director has informed the EB that Ruhpolding/GER and the NF Germany have agreed to take over this event on a short notice.

The EB therefore decided to reallocate the SB WCH 2020 to Ruhpolding/GER to be held from 20-23.08.2020. The exact competition schedule will be set in coordination with the EBU and shall be discussed at the Technical Committee afterwards.

 - The SB WCH 2021 which was already assigned to Nove Mesto na Morave/CZE (EB 141, Nov. 2018) will take place from 26-29.08.2021.

 - The EB decided to delete clause 41.3. of the draft Constitution put in front of Congress and to simplify the wording art. 41.2 according to the motions received from the NF Austria.
 - Concerning the Austrian motion on the VP Finances, the EB decided to change the draft constitution put to Congress, to modify the position of VP Finance, now named Treasurer; will "focus on strategy and consultations", in the new Constitution. It was also agreed to suggest that the Treasurer will be elected by the Congress. For legal representation it was added; "The Executive Board may decide from time to time as a matter of internal policy that only specified elected members of the Executive Board will exercise this power".
