01 Opening and welcome by the IBU President

IBU President Olle Dahlin opened the 16th Ordinary Congress 2024 on 27 September 2024 at 14:02 CET, welcoming the delegates, guests, representatives of various partner organisations, staff and other participants.

He highlighted the importance of this Congress, which marks both the conclusion of a very important stage in the IBU's history and the start of an exciting new chapter.

He further stressed the significance of the future oriented decisions that will be taken in Belgrade and encouraged everyone's active participation in the discussions.

He then invited Mr. Žarko Zečević, Vice President of the Serbian Olympic Committee, to greet the Congress with a few words of welcome.

A video greeting from IOC President Thomas Bach was played.

02 Confirmation of duly called Congress

The invitation for the 16th Ordinary IBU Congress was sent out by the IBU Secretary General Max Cobb according to the constitutional timelines on 29 May 2024. The Congress Agenda and Handbook were duly issued on 27 August 2024.

→ The Congress unanimously confirmed that it was duly called.

03 Roll call and first announcement of voting strength of the NF Members

Secretary General Max Cobb performed the roll call of nations, concluding that there are 46 voting members and one full member without voting rights present (MDA). He also welcomed the four provisional members in attendance. Six members had entered their registrations after the official registration deadline on 28 June 2024.

The President asked the Congress to accept the late entries and to approve the strength of voting, which the Congress unanimously confirmed.

According to the roll call on 27 September 2024, the following IBU member federations were present from the start of the session and entitled to vote:

04 Adoption of the Agenda

→ The Congress approved the agenda as distributed.

05 Congress procedure, appointment of Election Committee, and appointment of tellers

The President informed the Congress about the procedure for using a new voting software called Votebox, accessible through the delegates' mobile phones via a QR code and a specific PIN code assigned to each member federation. Three test votes were carried out to familiarise the heads of delegation with the technology.

As per the current IBU Constitution, any elections are managed by a so-called Election Committee. To manage the election for one vacant position in the Technical Committee under Agenda Point 14, the President proposed the appointment of an Election Committee consisting of the following:

- Lucas Harrati
- Nicola Bithell

→ The Congress unanimously confirmed the appointment of the Election Committee as proposed.

The President further proposed the appointment of two tellers to oversee the Election as follows:

- Carlos Pruneda, MEX
- Jeremy Hope, BIU
- → The Congress unanimously confirmed the appointment of the tellers.

06 Motion relating to NF status: NF Lebanon

The President recalled that as per the IBU Constitution, the Congress decides about full membership.

He stated that since Lebanon has demonstrated full compliance with all requirements and procedures, the Executive Board has proposed that Lebanon become a full member of the IBU.

He invited the President of the Lebanese Ski and Biathlon Federation Freddy Kairouz to deliver a presentation on the federation's biathlon activities.

Following the presentation, the President asked the Congress to vote to approve Lebanon's application.

The Congress unanimously approved the application of NF LBN for full membership with 44 votes, with 1 abstaining.

6.1 Second announcement of voting strength

Secretary General Max Cobb confirmed that following the approval of the full membership of Lebanon and hence voting rights, there were 47 voting members and one full member without voting rights present.

07 Receipt and approval of the annual reports of the Executive Board

7.1 Activity Reports 2022/2023 and 2023/2024

The President provided a high-level overview of the IBU's activities during the two seasons since the 2022 Congress in Salzburg, summarising the Activity Reports 2022/2023 and 2023/2024 which were provided as part of the Congress Handbook.

He particularly recalled the challenges over the past two years caused by the geopolitical situation, the energy crisis as well as adverse effects of climate change. He stressed the cooperation within the Biathlon Family that has been key to overcome these challenges and to deliver two fantastic seasons while also making great progress in the implementation of Target 26.

The President asked the Congress to approve the annual reports of the Executive Board.

→ The Congress unanimously approved the reports for the preceding two seasons.

7.2 Strategic Plan Target 26 Final Report

The President delivered a detailed presentation summarising the accomplishments of the Target 26 strategic plan that has been completed two years ahead of time.

A full report was provided to the delegates as part of the Congress documentation.

The President asked the Congress to approve the report.

→ The Congress unanimously approved the Final Report for the strategic plan Target 26.

08 Presentation of the audited financial statements and the Auditors' report for the preceding two financial years

Lead auditor Flora Hoffmann representing the IBU's auditor BDO Assurance GmbH presented a summary report on the audit of the IBU's financial statements 2022/2023 and 2023/2024. Full copies of the audited financial statements and Auditors' reports were provided as part of the Congress Handbook.

Anders Pettersson, President of the Brazilian Snow Sports Federation, asked the auditor to confirm whether all information that was requested of the IBU was provided. The auditor confirmed that all information requested was received in full and provided in timely fashion.

The President asked the Congress to approve the financial statements for the preceding two years using the electronic voting solution.

→ The Congress unanimously approved the financial statements for 2022/2023 and 2023/2024 financial years with 43 votes in favour (100%), and no abstentions.

09 Discharge of the Executive Board for the financial years 2022/2023 and 2023/2024

The President further asked the delegates to discharge the Executive Board for the financial years 2022/2023 and 2023/2024.

→ The Congress discharged the Executive Board with 43 votes in favour (97.7%), 1 against (2.3%), and no abstentions.

10 Receipt and approval of the annual reports from the Vetting Panel and the BIU Board

The Head of the BIU Greg McKenna provided a summary of the annual activities of the BIU. Full copies of the BIU's annual reports for 2022/2023 and 2023/2024 seasons were included as part of the Congress Handbook.

He further summarised the report of the Vetting Panel provided in full in the Congress Handbook.

The President asked the Congress to approve the annual reports of the BIU Board and the Vetting Panel.

→ The reports were unanimously approved by the Congress.

11 Presentation and approval of Target 2030

The IBU President introduced the Target 2030 strategic plan which is the continuation of Target 26 elevated to a new level. He highlighted that the NFs were critical to the development of Target 2030.

Starting with the Regional Workshops held between November 2022 and May 2023, several opportunities for gathering feedback and for consultation were provided. The Regional Workshops were also important in establishing a direct connection between Target 26 and the 2030 objectives set in the IBU House.

The Executive Board prepared the first draft of the Target 2030 strategy for presentation at the Presidents' Meeting 2024 at the World Championships in Nove Mesto/CZE. An online survey for written feedback followed and the Technical Committee, the IBU Organising Committees and the staff were also consulted, along with other stakeholders to ensure a truly collaborative process.

Compared with Target 26, the new plan sets adjusted priorities and new areas of emphasis. However, the National Federations remain at the very heart of biathlon and its global growth. Success in delivering against this plan will again require the individual efforts of everyone in the biathlon family.

The members of the Executive Board then presented the details of the final plan for the Target 2030 strategy. A printed copy was also provided to the delegates in attendance as well as a soft copy as part of the Congress documentation.

Sofia Domeij, President of the Swedish Biathlon Federation, expressed her confidence in the strategic direction of the IBU. She complimented the work behind Target 2030 as ambitious, inclusive, and inspiring, and thanked the board, the staff and everyone involved in the process. She noted that the IBU now needs a concrete action plan to turn this roadmap into reality, with clear steps, responsibilities, timelines and a priority plan. Finding the right balance between tradition and innovation, sustainability and growth, is crucial to ensuring that biathlon remains relevant and attractive for future generations.

She encouraged everyone in the biathlon family to support Target 2030, and the IBU together its stakeholders in realizing this vision.

The President asked the delegates to formally approve the Target 2030 as presented.

→ The Congress unanimously voted to approve the strategic plan Target 2030 with 43 votes in favour (100%), no abstentions.

The President closed Day One of Congress proceedings at 17:35 CET.

CONGRESS DAY TWO

The IBU President opened Day Two of Congress at 9:38 CET on 28 September 2024.

Tarmo Kärnä, President of the Estonian Biathlon Federation, took the opportunity to thank the IBU and its staff for all their efforts to stage the first day of Congress and a very nice evening at the IBU Awards Night.

Roll call and third announcement of voting strength of the NF Members

Secretary General Max Cobb conducted the roll call. According to that, the following IBU member federations were present and entitled to vote, meaning that there were 47 voting members and one full member without voting rights present at the start of the session:

12 Presentation of updated Budget proposal for 2024/2025 and Budget frames 2025/2026

The President asked the IBU Treasurer Christian Scherer and Secretary General Max Cobb to present the updated budget proposal 2024/2025 and budget frames 2025/2026.

Treasurer Christian Scherer thanked the Congress for discharging the Executive Board for the financial years 2022/2023 and 2023/2024.

Secretary General Max Cobb presented an overview of the IBU's financials.

The expected revenues for the 2024/2025 fiscal year are budgeted to amount to €56 million and are estimated to be slightly lower in the 2025/2026 fiscal year given the Olympic season where there will be no Biathlon World Championships. However, both years are expected to deliver a positive result.

Between 2016-2024, the financial support for the IBU National Federations, Organising Committees and athletes in terms of prize money has increased by 113%, a testimony to excellent work by the Executive Board.

The President then asked the Congress to confirm the updated Budget for 2024/2025 and the Budget frames for 2025/2026.

→ The Congress confirmed the updated Budget for 2024/2025 and receipt of the Budget frames for 2025/2026 unanimously, with 44 votes (100%), no abstentions.

Vice President Jiri Hamza thanked the IBU's media partner European Broadcasting Union and marketing partner Infront for their continued support for the IBU.

13 Motions

13.1 Motions proposing amendments to the Constitution

The President introduced motions seeking changes to the Constitution proposed by the Executive Board. He noted that motions changing the Constitution require a two-thirds (2/3) majority to pass. He further explained that in each case Secretary General Max Cobb will present the motion and then the Congress will be asked to vote using the voting tool.

The full text of all motions and their rationale can be found in ANNEX 9.

13.1.1 Motion from the Executive Board for the integration of Para Biathlon

This motion concerns Articles 1, 2, 3, 22, 25 and 26 of the IBU Constitution, and Article 1 of the Integrity Code: Chapter B IBU Code of Conduct.

Secretary General Max Cobb explained the rationale of the motion and the Congress was asked for approval.

→ The Congress approved the motion for the integration of Para Biathlon with 40 votes in favour (97.6%), 1 against (2.4%) and 2 abstentions.

13.1.2 Motion from the Executive Board for asserting IBU governance over all forms of biathlon including Esports

This motion concerns Article 1.

Secretary General Max Cobb explained the rationale of the motion and the Congress was asked for approval.

→ The Congress approved the motion for IBU governance over Esports with 43 votes in favour (95.6%), 2 against (4.4%) and no abstentions.

13.1.3 Motion from the Executive Board for a minimum level of event participation

This motion concerns Article 6.1.6.

Secretary General Max Cobb explained the rationale of the motion and the Congress was asked for approval.

→ The Congress approved the motion for a minimum level of event participation by the NFs with 35 votes in favour (76.1%), 11 against (23.9%) and no abstentions.

13.1.4 Motion from the Executive Board on the number and gender of NF candidates for the Executive Board

This motion concerns Article 7.1.5.1

Secretary General Max Cobb explained the rationale of the motion and the Congress was asked for approval.

→ The Congress approved the motion on the number and gender of NF candidates for the Executive Board with 38 votes in favour (84.4%), 7 against (15.6%) and 1 abstention.

13.1.5 Motion from the Executive Board for the introduction of a biathlon refugee team (BRT)

This motion concerns Article 7.1.9.6

Secretary General Max Cobb explained the rationale of the motion and the Congress was asked for approval.

→ The Congress approved the motion for the introduction of a biathlon refugee team with 41 votes in favour (91.1%), 4 against (8.9%) and 1 abstention.

13.1.6 Motion from the Executive Board concerning the process of requesting information from the National Federations

This motion concerns Article 8.1.4

Secretary General Max Cobb explained the rationale of the motion and the Congress was asked for approval.

→ The Congress approved the motion for a simplification of the process of requesting information from the NFs with 41 votes in favour (93.2%), 3 against (6.8%) and 2 abstentions.

13.1.7 Motion from the Executive Board for a virtual or hybrid Congress

This motion concerns Article 14.1.4.

Secretary General Max Cobb explained the rationale of the motion and the Congress was asked for approval.

→ The Congress approved the motion for a virtual or hybrid Congress with 37 votes in favour (82.2%), 8 against (17.8%) and 1 abstention.

13.1.8 Motion from the Executive Board for weighted voting

This motion concerns Article 16

Secretary General Max Cobb explained in detail the rationale of the motion and presented the amended wording proposal that was changed based on feedback received from the members since the distribution of the Congress Handbook. This amendment provided for the inclusion of Regional Events in the junior category as a determinant for points for NF participation.

NF GBR asked the Secretary General to briefly summarise the benefits of the proposal for those unsure of their decision.

NF TUR queried about easing of the quota for World Cup and World Championships participation as part of the proposed change for voting strength, which is not currently planned.

NF BRA thanked the IBU for supporting developing nations in the past years and provided arguments against the proposal.

NF FIN asked whether Para Biathlon was also considered in the motion at this time, which is currently not planned.

NF BEL asked to clarify the impact of Regional Events on the simulation data. These data are not included in the simulation due to incomplete data availability for this series in the IBU database at present time.

The President asked the Secretary General to clarify the impact of the minimum criteria for national activities that was approved by Congress under 13.1.3. This change allows for the Executive Board to relegate a Full Member to the status of a Provisional Member if it does not meet the minimum criteria for two seasons prior.

NF MDA asked for a clarification of the basis of points calculation and whether participation in several events per series also plays a role, which is not the case.

The President asked the Congress to approve the amendment to allow its inclusion into the Congress motion. This amendment requires a single majority.

→ The Congress approved the inclusion on agenda of the amended proposal for weighted voting with 33 votes in favour (73.2%) and 12 against (26.7%), no abstentions.

The President then asked the Congress to approve the motion for weighted voting which represents a change to the Constitution and requires a 2/3 majority to pass.

→ The Congress rejected the motion with 26 votes in favour (55.3%), 21 against (44.7%) and no abstentions.

13.1.9 Motion from the Executive Board for restricting multiple international winter federation board membership by EB members

This motion concerns Article 17.5

Secretary General Max Cobb explained the rationale of the motion and the Congress was asked for approval.

→ The Congress approved the motion for restricting multiple international winter federation board membership by EB members with 37 votes in favour (78.7%), 10 against (21.3%) and 1 abstention.

13.1.10 Motion from the Executive Board for expanding Athlete Committee eligibility

This motion concerns Article 25

Secretary General Max Cobb explained the rationale of the motion and the Congress was asked for approval.

→ The Congress approved the motion for expanding Athlete Committee eligibility with 42 votes in favour (78.7%), 4 against (21.3%) and 1 abstention.

13.1.11 /13.3.4 Combined motion from the Executive Board for erasing current Article 28 on the Vetting Panel and merging the vetting function into the BIU Rules as a task of the BIU Board

This combined motion concerns Articles 27 and 28 of the Constitution and Articles 11, 13 and 14 of the BIU Rules.

The President asked the Head of the BIU Greg McKenna to explain the rationale of the motion. He also noted a minor editorial error concerning Article 27 that was in the version distributed as part of the Congress Handbook. The corrected version was shown to the Congress.

The President asked the Congress for approval.

→ The Congress approved the motion for making the vetting function a task of the BIU Board with 45 votes in favour (97.8%), 1 against (2.2%) and 2 abstentions.

13.1.12 Motion from the Executive Board for additional definitions and specifications to interpretation

This motion concerns Appendix 1 Definitions and Interpretation.

Secretary General Max Cobb explained the rationale of the motion and the Congress was asked for approval.

→ The Congress approved the motion for additional definitions with 46 votes in favour (97.9%),
 1 against (2.1%) and no abstentions.

13.2 Motions seeking approval of Reserved Rules

The President asked IBU Sport & Event Director Daniel Böhm to explain the rationale of the motion for various adjustments to the restricted rules governing the IBU competition series set-up in the Event and Competition Rules (ECR).

His presentation including proposed timelines can be found along with the full motion details in **ANNEX 10**.

NF POL took the floor to explain that they did not agree with proposed changes and renaming of the competition classes for junior and youth categories under Article 1.3 of the ECR and asked to separate the motion into two separate Congress approvals.

The IBU Sport & Event Director suggested that the Congress decide about changes to the Competition Classes in Article 1.3 separately from the rest of the proposed amends concerning the competition series set-up adjustments.

The President asked that the Congress to approve the proposal for the amendments of the restricted Event and Competition Rules without the changes to Article 1.3.

→ The Congress approved the motion for the ECR changes without Article 1.3 with 35 votes in favour (74.5%), 12 against (25.5%) and 1 abstention.

The President then asked the Congress for approval for the proposed changes to the Article 1.3 concerning Classes of Competitors.

→ The Congress approved the motion for changing the restricted rule Article 1.3 with 30 votes in favour (62.5%), 18 against (37.5%) and no abstentions.

13.3 Motions seeking amendment or annulment of other Rules

13.3.1 Motion from the Executive Board for simplification of the conflict-of-interest management procedure and the concept of duty of loyalty

This motion concerns IBU Integrity Code, Articles 3 and 4 of Chapter B.

The President asked the Head of the BIU Greg McKenna to explain the rationale of the motion. In addition, a **video** explaining the proposed procedures was shown.

→ The Congress unanimously approved the motion for simplification of the conflict-of-interest management procedure and the concept of duty of loyalty with 44 votes in favour (100%) 0 against and no abstentions.

13.3.2 Motion from the Executive Board for minor amendments to the IBU Anti-Doping Rules

This motion concerns Chapter D of the IBU Anti-Doping Rules, Articles 5.2.2 and 5.5.3

The President asked the Head of the BIU Greg McKenna to provide any further comments to the motion. He stated that the proposed amendments had been agreed with the WADA prior.

The Congress was asked for approval.

→ The Congress approved the motion for amendments to the IBU Anti-Doping Rules with 44 votes in favour (100%), 0 against and no abstentions.

13.3.3 Motion from the Executive Board for minor amendments to the BIU Rules

This motion concerns Articles 2, 5, 7, 8, 9, and 15 of the BIU Rules.

The President introduced the motion, and the Congress was asked for approval.

→ The Congress approved the motion for amendments to the BIU Rules with 46 votes in favour (100%), 0 against and no abstentions.

13.3.5 Motion from the Executive Board for optimisation of the Rules of Congress

This motion concerns Articles 4, 9 and 10 of the Rules of Congress, as well as Articles 13 and 14 of the Rules of Congress

The President introduced the motion, and the Congress was asked for approval for changes to Articles other than Article 14..

→ The Congress approved the motion concerning Articles 4, 9, 10 and 13 of the Rules of Congress with 45 votes in favour (97.8%), 1 against (2.2%) and no abstentions.

The President then asked the Congress to separately consider the proposed changes to the Article 14 of the Rules of Congress.

→ The Congress approved the changes to Article 14 with 43 votes in favour (95.6%), 2 against (4.4%) and no abstentions.

13.4 Any other motions

There were no further motions.

14 Elections

14.1 Procedure for elections presented by the chair of the Election Committee

The Chair of the Election Committee, Alex Marshall, explained the election procedure. As for the motions, the election will be conducted by secret ballot using the electronic voting software called Votebox.

14.2 Election of the Members of the Technical Committee

For the vote for one vacation position in the Technical Committee until Congress 2026, there are 3 candidates (one woman and two men). They will not provide presentations.

The Chair of the Election Committee, Alex Marshall, asked the delegates to cast their votes.

In the first ballot, 46 ballots were cast. The candidates received the following number of votes:

Since all three candidates are bidding for both editions of the event, they will first present their championships concepts and the Congress will then be asked to consider the Executive Board's proposal for 2028 and 2029, respectively.

The President then asked the Congress to support the proposal to approve Oslo-Holmenkollen as the host of the Biathlon World Championships 2029.

→ The Congress approved the proposal to appoint Oslo-Holmenkollen as the host of the Biathlon World Championships 2029 with 41 votes in favour (91.1%), 4 against (8.9%) and 1 abstention.

18 Awarding of IBU Honours

The IBU President stated that under the current Rules for IBU Honours, the Congress is asked to acknowledge the IBU Certificates of Honour for individuals approved by the Executive Board.

The following Certificates of Honour for individuals have been awarded:

- Ilmo KURVINEN, FIN

The Certificate of Honour for Mr Budzishvili was presented at the Congress by the IBU President Dahlin and Secretary General Cobb. Mr Budzishvili thanked the IBU for its support for Georgia over the years and recalled fine memories of his life spent to develop biathlon.

The Certificate for Mr Kurvinen will be presented at an IBU event suitable to all parties.

19 Information from Organising Committees on upcoming events

The OC Lenzerheide reported on their preparations for the 2025 IBU World Championships.

The OCOG for the Olympic Winter and Paralympic Games MilanoCortina 2026 reported on their Games preparations.

The OC Otepää reported on their preparations for the 2027 IBU World Championships.

20 Other items and closing

Jose Maria Peus Espana from NF ESP expressed his thanks to the IBU for the great development cooperation that has helped them grow rapidly and encouraged the IBU to continue its work in similar fashion.

Philippe Heck, President of the Belgian Biathlon Federation, recalled the federation's work to develop the sport over the years and reflected on significant growth that now provides for their participation across all IBU competition series. Given the increasing needs for reporting and other non-sports duties, however, the federation staff is reaching its limits, and he asked the IBU to also support the administration of its member national federations.

Representing the NF FIN and OC Kontiolahti, Matilda Suhonen complimented the IBU for having several highly qualified candidates for hosting the Biathlon World Championships year after year, which can be seen a sign of the strength of the sport. She hopes Finland, too, will be among future hosts and congratulated the winning bids for the 2028 and 2029 championships.

Urs Lehmann, Co-President of Swiss-Ski, complimented the IBU for its development over the last several years and the clear vision and a future strategy built on a strong financial foundation. IBU Secretary General Max Cobb thanked the member nations for their great cooperation that enabled smooth proceedings during the Congress. He further thanked the Serbian Biathlon Federation for their support and hospitality as hosts of the Congress Gala dinner on the final night.

President Dahlin also congratulated the upcoming the World Championships hosts and challenged them to follow the great example set by the organisers of the 2024 edition in Nove Mesto na Mesto/ CZE with over 200'000 spectators.





RATIONALE

As of July 2022, the International Paralympic Committee (IPC) has transferred governance of the sport of Para Biathlon to the IBU. The IBU then became a full member of the IPC in September 2023. To comply with the IPC Constitution, the IBU must amend its Constitution to include references to Para Biathlon and the IPC, like Biathlon and the IOC.

Notably, Article 25 has been adapted to comply with the IBU's obligation as an IPC member to "establish and implement mechanisms in its decision-making structures to engage with (and seek the perspective of) Para athletes and athlete representatives" (see Article 13.2.19 of the IPC Constitution).

Concerns Article 1

RATIONALE

With the advent of online streaming video platforms, participation in multi-player gaming competitions or Electronic Sports, short Esports, has surged and become an industry that generates significant global revenues annually. Following approval at the 142nd IOC Session, Olympic Esports Games are slated to be held every two years in-between the Summer and Winter Olympic Games starting in 2025. The proposed amendment asserts the IBU's role in the governance of biathlon Esports.

This motion requires the support of a two-thirds majority (2/3) of the votes cast.

13.2 MOTIONS SEEKING APPROVAL OF RESERVED RULES

RATIONALE FOR THE MOTION

Following in-depth analyses of the past seasons' events and the subsequent discussions in the Technical Committee and Executive Board, an adjustment to the IBU event series setup is proposed in line with the priorities of the Target 2030 plan, in particular 'Closing the competition gap' and 'Developing a modern and sustainable sport and event concept'.

The adjustment aims to:

- Ensure long-term excellence and appeal of the sport
- Offer better competition options for a growing number of athletes
- Decrease the financial investment by NFs while fostering sustainability

The Technical Committee has worked out a series of measures and prepared the corresponding rule amendments, which were approved by the IBU Executive Board at EB 171.

At a high level, the changes to the restricted rules of the Event and Competition Rules (ECR) consist of the following:

- Implementation of a Qualifying Point (QP) calculation for the IBU Junior Cup and Regional Events beginning with the season 2025/2026
- Implementation of a QP requirement for the IBU Cup including the IBU Open European Championships, Junior Cup and Junior World Championships beginning with the season 2026/2027
- Re-definition and re-naming of the age classes for the seasons 2025/2026 until 2027/2028, including an adaption of the age limit in the U21 / Junior class
- Removal of the Youth category from the Youth and Junior World Championships, starting with the 2027 edition and cancellation of the Junior Open European Championships beginning with the season 2026/2027. To replace the Youth World Championships, adequate and feasible event alternative for the youth athletes will be developed by the IBU.

All these changes are designed to provide a more flexible and efficient event structure for the IBU Junior Cup and Regional Events

13.3.1 Motion from the Executive Board for simplification of the conflict-of-interest management procedure and the concept of duty of loyalty

Concerns IBU Integrity Code, Articles 3 and 4 of Chapter B

RATIONALE

Currently, Article 3 of Chapter B of the IBU Integrity Code is referring to the duty of loyalty only within its first provision. The proposal is to move this provision to Article 4 and to refocus Article 3 to the topic of conflicts of interest.

With this change all other IBU policies relating to conflict of interest will be replaced by Article 3, together with a separate practical guideline to provide guidance on its application.

The BIU has developed a structured process for the nomination and vetting of prospective candidates for the IBU Executive Board (EB). This outlines the comprehensive steps involved. Although the governance of this process has been enhanced, the BIU has committed to processing all EB Candidates within the current 60 days. Such a tight schedule requires the BIU to insist any missing or supplementary information is provided within 72 hours of time of request.

A simplification of Congress procedures is also proposed to consider the BIU Board as the Election Committee without a separate appointment.
