The IBU and the International Ski Federation (FIS) are jointly developing a test device to detect the use of fluorinated ski wax that will be tested over the summer. Once these tests have been completed, the IBU will announce new rules including details on thresholds, procedures and sanctions in due course. Such thresholds are being developed to ensure that very small amounts of fluorine existing in well-cleaned bases of skis or existing in the environment will not result in sanctions.

IBU Sustainability Expert Reference Group - Terms of Reference

Context

Sustainability is one of the key objective areas included in the IBU's new Target 26 strategy approved in September 2019. The goal is to establish biathlon as a leader in promoting sustainability in sport by 2026. It is within this context that the international biathlon family acknowledges its responsibility to contribute to the fight against climate change and commits itself to the practice of managing existing and available resources in such a way as to maximise positive impact and minimise negative impact in the social, economic and environmental spheres.

Role of the IBU Sustainability Expert Reference Group (ERG)

To ensure that its sustainability strategy and related activities are sound and incorporate the latest available know-how, the IBU has established a Sustainability Expert Reference Group (ERG). The ERG will provide the responsible IBU staff with both scientific and practical advice to implement sustainability in the sport of biathlon.

Composition

The ERG will consist of a maximum of seven members representing the three dimensions of sustainability (social, economic and environmental) and specific areas of expertise related to sustainability in sport, in particular in winter sport. One of the members will be appointed as the Chair, and at least three members will be female and three members will be male.

Term

The term of office of members of the ERG will be ongoing. A member may resign by giving not less than one month's notice in writing to the Chair.

Core Responsibilities

The responsibilities of the ERG will include:

- Advice the development of a long-term IBU sustainability strategy 2020-2030 including definition of the strategic focus areas
- Advice the development of concrete sustainability goals and measures for the sport
- Propose appropriate sustainability targets and key performance indicators for each focus area
- Support the IBU in the delivery of its sustainability strategy
- Leverage its network of experts in and beyond the sports industry to obtain additional guidance and new information if required
- Propose research projects when needed to be undertaken to identify specific solutions to meet IBU's sustainability goals
- Contribute to and review the IBU's annual sustainability report; and
- Act as IBU's sustainability ambassadors in all related matters, actively promoting the vision and work of the sport

What is the UNFCCC Sports for Climate Action Framework?

- UNFCCC = United Nations Framework Convention on Climate Change
- A treaty initially signed at the Earth Summit in Rio de Janeiro in 1992 with the goal of committing nations to reduce greenhouse gases
- In December 2018, IOC partnered with the UNFCCC to launch the Sports for Climate Action Framework to create a platform for the development of a joint approach by the sports movement to climate action
- The Framework now includes more than 120 international sports organisations, such as IOC, IPC and several IFs



Why should IBU join the Sports for Climate Action Framework?

- As a winter (snow) sport, climate change is one of the main areas of concern (as recognised in Target 26)
- Basic membership does not commit the IBU to any specific action we are free to defined our own
 goals and activities as those suit us
- Requires that IBU observes the following principles
 - Undertake systematic efforts to promote greater environmental responsibility
 - Reduce overall climate impact
 - Educate for climate action
 - Promote sustainable and responsible consumption
 - Advocate for climate action through communication
- By joining the 20+ other Olympic IFs, IBU can benefit from lessons learned and participate in the working groups that have been set up
- Dow Chemical has pledged to offset our carbon footprint for 2020 (baseline calculation for future)



Biathlon Integrity Unit (BIU) Update for Member Associations

JUNE 2020



BIU Board meetings

The four members of the Biathlon Integrity Unit Board currently meet every two weeks.

Strategic Planning

A draft strategic map and plan have been formulated. This Integrity Units strategy is to separate the responsibilities of the Integrity Unit into four interdependent work streams:

- Prevention education / communication / safeguarding.
- Case Management effective management of the prosecution process / leadership in integrity.
- Testing & Compliance implementing the WADA Code on behalf IBU / enhanced testing framework / close working with NADOs.
- Operations developing an understanding of risks to biathlon through information gathering / investigation capability.

Enhanced working with other Sports Integrity Units, Law Enforcement Agencies and Educational Institutions is an important and fundamental aspect of the Integrity Units strategic planning.

Staffing

Following a short absence, in March Louise Reilly has returned to her role as Chair of the Integrity Board. Whilst Louise took a short break from her duties, the Chair had been held by fellow Board member Markus Hauptmann.

Sarah Fussek-Hakkarainen has now stood down from her role as acting Head of the Biathlon Integrity Unit and has now returned to her role in of the International Ski Federation.

The Biathlon Integrity Unit currently employs two members of staff. The Head of the Unit is currently being performed by the Board Managing Advisor, who is a highly experienced investigator, with significant experience in dealing with sensitive information. Anti-doping co-ordinator Lucie Rothauer has built up significant expertise in the field of anti-doping and has recently extended her role to become the units Anti-Doping Manager. This post will also take the lead for delivering Integrity Units 'prevention' strategy. Within the next two months, these staff members will be joined by an Office Administrator and Anti-Doping Coordinator.



Martina Perendi, a member of the anti-doping team and Project Manager will take up a new role as Executive Assistant within the IBU.

The Unit is also supported through use of various external contractors.

Website Development

It is recognised that many of those involved in the sport, may not be aware of the Integrity Units mandate and vision to protect biathlon to ensure a clean and trusted sport. The new website will form an important part of the Integrity Units Communication Strategy. It is important to recognise that the new website will provide several means by which secure and confidential contact can be made with the Integrity Unit. This will enable any person to raise any concerns or provide any information. Any information provided will be treated with the utmost care and can be sent without the requirement to disclose personal details.

The website is in the final stages of development and will be launched week commencing 8th June. The Integrity Unit has attempted to ensure the site is focused on the athletes, allowing them to gain knowledge in areas such as rules, safeguarding and reporting mechanisms in an understandable way.

The launch of the site is only the first step, the Integrity Unit will continue to work with the Biathlon Family to develop an 'Athletes Hub'. This will allow all connected with the sport to see audio and video clips from role models within the sport, providing their views on a range of topics relating to clean sports.

The Integrity Unit encourages all members of the Biathlon Family and associated organisations to visit the site and provide feedback on its appearance, functionality and most importantly, the information provided by it.

WADA Code revision and changes to IBU Integrity Code

Since November 2017, the WADA Code Review process has been underway. This has resulted in a final draft Code being presented for consideration and approval at the fifth

World Conference on Doping in Sport, which was held in November 2019 in Katowice, Poland.

It was agreed the revised code should enter into effect on 1 January 2021.



There is a requirement for us to revise the IBU Integrity Code and this work is currently being undertaken on our behalf by Lawyers at Bird & Bird, London. The updated and final version of the Biathlon Integrity Code will be completed by September 2020.

WADA – Operation LIMS Update

Together with 26 other International Federations, the IBU recently received additional information from WADA's Intelligence and Investigations team regarding its Russian investigation. The IBU's Biathlon Integrity Unit is currently reviewing the information received from WADA, together with other intelligence the Integrity Unit may be in possession of, and will take appropriate action in due course.

Background

At EB 151 the EB decided to review the procedure for membership requests and table all requests until this is done. A working group of the VP, SG and EB member T. Boygard was established, that will report their findings at EB meeting 152.

The Constitution have the following article about membership requests:

5. Requirements to be an NF Member

5.1 To be and to remain a full NF Member of the IBU, a National Federation for the sport of Biathlon must satisfy (both at the time it applies for membership and at all times after it has been admitted as an NF Member) all of the following requirements:

5.1.1 It must be a legal entity properly constituted in accordance with the law applicable in its Country

5.1.2 It must be concerned with the administration, organisation and practising of Biathlon, either solely and exclusively or else in conjunction with other sports.

5.1.3 It must claim the exclusive right to govern both men's and women's Biathlon in its Country, i.e., it must not recognise any other body's claim to govern either men's or women's Biathlon in its Country (other than by exercise of powers delegated to that other body by the National Federation).

5.1.4 lts constitution must:

5.1.4.1 be compliant with the Olympic Charter and the World Anti-Doping Code, and consistent in all respects with this Constitution and the Rules;

5.1.4.2 declare its opposition to any unlawful discrimination on the grounds of race, skin colour, national or social origin, gender, sex, sexual orientation, language, political or other opinion, religion or other beliefs, circumstances of birth, or other improper grounds; and

5.1.4.3 include a formal undertaking by the National Federation to be bound by and to comply with the obligations placed on NF Members by this Constitution.

5.1.5 It must not be insolvent.

5.1.6 It must carry out Biathlon activities in its Country at least to the minimum level prescribed by the Executive Board from time to time.

5.2 A National Federation that satisfies all of the requirements set out in Article 5.1 except for the Article 5.1.6 requirement to carry out Biathlon activities in its Country at least to the minimum level prescribed by the Executive Board from time to time may be

admitted as a provisional NF Member, but it may not be admitted as a full NF Member until it satisfies the Article 5.1.6 requirement as well.

We currently have membership requests from Kuwait, Afghanistan and Thailand.

Proposal from the working group

The working group have discussed the content of this and decided to focus on point 5.1.4.2 and to work to ensure we get applicants are or will be active in Biathlon.

We are of the opinion that the applying federation must demonstrate how their constitution, status, policies or guidelines will ensure/demonstrate that they are in opposition to any lawful discrimination following article 5.1.4.2.

We also believe that it is of importance that we work hard to get active members and based on that the following questions will be addressed to the applying federations:

Why does your federation want to become a member of IBU?

Do you do any Biathlon activities currently in your country?

If so, what activities?

If not, what are your plans for future Biathlon activities?

Please send us the number of members in your federation and the number of clubs.

The working group is also of the opinion that we should have a group that reviews the applications and makes recommendations to EB for decision.

The group should consist of the SG, Development Director and one to two EB members.

Proposal for decision

The working group recommends the EB to support the above presented procedure.

Next step if proposal is approved.

The review group will apply the procedure for the three nations applying to be members currently and make recommendations to the EB when the applications has been reviewed and necessary information have been received.

Financial Support 2020-2021

Budget

3 350 000 EUR in 2020 (2 350 000 EUR transfer in June, 1 000 000 EUR transfer in November)

- 10% for the base support
- 55 % depends on NFs IBU Nation Cup in WC, IC, JC and gender representativeness.
 - The NFs IBU Cup ranking values the most, than IBU Junior Cup and World Cup.
- 35 % depends on number of Athletes representing NFs in IBU competitions

Principles

1. All NFs participating in any IBU competition receives 5 000 EUR (48 NFs)

According to the total score of Men and Women ranking in Nations Cup the NF receives the largest amount of funding for a position in the Nations IBU Cup ranking. The second factor taking into account in allocating financial support is the Junior Cup ranking. The last factor is the position in Nations Cup WC ranking.
 The NFs, which is represented by representatives of only one gender receives half of the amount.
 The last factor determining the amount of financial support is the number of NF's Athletes participating in the IBU campatitions during account (from SIMUDATA) according to:

IBU competitions during season (from SIWIDATA) according to:

- 30 athletes and more
- 20-29 athletes
- 30 000 EUR per NF - 20 000 EUR per NF
- 1-19 athletes
- 1000 EUR per Athlete per NF
