CODEDAY is a 24-hour event to introduce and educate newer students in computer science and programming. We continued to CodeDay across the US. 8,652 students attended a CodeDay during the fiscal year, with approximately 68% from a background traditionally underrepresented in technology.

4b (Code:) (Expenses \$ 0 including grants of \$ 0) (Revenue \$ 0)
CODELABS (formerly CodeBreak) is a semi-virtual summer program which provides online classes and mentorship for students across the US. We provided the program to 482 students (with 80 receiving full mentorship) at the beginning of this fiscal year, and registered 1,018 for the program to start at the beginning of next fiscal year.

SRND launched its CS FAIRS program, providing educational Computer Science field trips for school groups. Events were planned in Atlanta, GA, Birmingham AL, and Los Angeles, CA (however only the latter two cities held events due to school calendar restrictions). 700 students registered to attend these events through school partnerships.
