

Installation and Operation Instructions WS1L, WS2L - Window Shroud

IMPORTANT! Read all instructions before installing and using. Installer: This manual must be delivered to the end user.



WARNING

- 1. Proper installation combined with operator training in the use, care, and maintenance of emergency warning devices are essential to ensure the safety of emergency personnel and the public.

Install this product so that output performance of the system is maximized and the controls are placed within convenient reach of the operator so that they can operate the system without losing eye contact with the roadway.

Equipment mounted or located in an air bag deployment area may reduce the effectiveness of the air bag or become a projectile that could cause serious personal injury or death. Refer to the vehicle owner's manual for the air bag deployment area. It is the responsibility of the user/operator to determine a suitable mounting location ensuring the safety of all passengers inside the vehicle particularly avoiding areas of potential head impact.
- 6. It is the responsibility of the vehicle operator to ensure daily that all features of this product work correctly. In use, the vehicle operator should ensure the projection of the warning signal is not blocked by vehicle components (i.e., open trunks or compartment doors), people, vehicles or other obstructions.
- 7. The use of this or any other warning device does not ensure all drivers can or will observe or react to an emergency warning signal.




Installation and Mounting

Unpacking and Pre-Installation:

The Window Shroud is designed for use with the Code 3 MR6, CD3800, and CD3794 series LED lights. An adhesive tape completely surrounds the unit, stopping flashback and creating a strong seal. The Window Shroud can be mounted in the following orientations:

- Front / rear window orientation using Low Slope orientation: LED light tilt adjust $38 \pm 8^{\circ}$ from horizontal
- Side window orientation using High Slope orientation: LED light tilt adjust 60 ± 15° from horizontal





LOW SLOPE




Figure 3 Figure 4

Installation:

- 1. Install the Lighthead to the Metal Plate.
- 2. Determine what application best fits the window to be installed on using the guidelines above.
- 3. Insert Metal Plate with Lighthead into Shroud.
- 4. Install Plastic Dished Washer, Metal Washer, and Nut. Do not fully tighten.
- 5. Hold the Shroud up to window glass and determine the best angle for the Lighthead.
- 6. Position the Lighthead to desired angle and tighten the Nuts.
- 7. Clean the window glass where the Shroud will be applied.
- 8. Remove liner from VHB strips on Shroud.
- 9. Apply uniform pressure on the Shroud to the glass, pushing along the flange area where there is tape. For best results, install using a minimum 10 PSI and a minimum temperature of 60° F.


