Proper Identification for Claim Processing

U.S. Citizen or Resident Prize Claimant – Original unexpired, government-issued picture identification is required along with an original Social Security Card to claim a lottery prize. Per IRS regulations, prize claimant's legal name must appear on both presented forms of identification. Per Lottery procedures, the first and last name on the presented government-issued picture identification and Social Security Card must match as outlined below in the "Name Rules".

Name Rules:

- Acceptable:
 - If a middle name is on one form of identification and not the other, this is acceptable.
 - If a middle name (Frank) is on one form of identification and a middle initial (matching such as F) is on the other, this is acceptable.
- Unacceptable:
 - o If the claimant's name is Joe on one form of identification and Joseph on the other, this is not acceptable.
 - o If a middle name is (Frank) and a middle name or initial is anything other than "F" or "Frank", this is not acceptable.
 - If Jr, Sr, I, II, III, etc. is included on one form of identification and a different suffix or no suffix is included on the other, this is not acceptable.

Non-Resident Prize Claimant – An original unexpired, government-issued picture identification is required along with proof of non-U.S. residency.

Club Representative - A Club Representative is responsible for submitting a completed Substitute 5754 form (BSL-A-2164) prior to prize payment. The club rep and each club member must include legible copies of their unexpired, government-issued picture identification and Social Security Card and sign their section of the Substitute 5754 form. Incomplete forms will delay all club members' checks. Club checks will be issued by Lottery Central to each club member.

Acceptable types of government-issued picture identifications must include a picture and an unexpired expiration date.
