- 1.) No overnight of vehicle is permitted without permission.
- 2.) No storage of vehicle is permitted.
- 3.) If self-parked, customer agrees to hold LAZ Parking harmless as LAZ Parking is renting space and no bailment is created. LAZ Parking is not liable for damage to, or theft of, vehicle under any circumstances.
- 4.) Customer agrees not to leave articles of personal property of any value in the vehicle; and specifically agrees to not hold LAZ parking responsible for any damages resulting from loss of or damage to say articles of personal property left in vehicle in violation of this Agreement.
- 5.) When a "credential" entry card (one credential per contracted vehicle parked) is supplied by LAZ Parking, the credential shall be used to enter and exit automatic-system-equipped facilities. Any attempt at manipulation of monthly parking procedures will result in cancellation of monthly parking privileges and will be subject to posted daily rates .
- 6.) This agreement may be terminated by LAZ Parking.
- 7.) Location manager or attendants are not authorized to make or allow exceptions to this Agreement and operating regulations.
- 8.) Vehicle keys should not be left with parking attendants. If there is an emergency involving the parking garage, we could need the vehicle relocated. We require that you provide the name and number of an emergency contact so that they can move the vehicle, should the need arise.
