

# International goods transport services – Contract prices 16.10.2025

The pricing of parcels is based on units and the mailed item's measured weight or volume, whichever is the greater. The cubic measure used for parcels is 1 m3 = 250kg. The minimum pricing weight is 1000 g. The maximum batch size for multi parcel shipments (MPS) is 10 items.

The pricing of Express Freight is based on the transport unit type, the size of the shipment lot, transport distance, and the additional service used.

Unless otherwise stated, the prices include transport from a Posti outlet to the recipient or pick-up location. A pick-up can be ordered for shipments (subject to a separate charge), or a pick-up and delivery contract can be signed with Posti.

An applicable fuel surcharge will be charged separately. The currently valid fuel surcharges are specified on Posti's website on page <u>posti.fi/fuelsurcharge</u>.

#### Value added tax

The tariffs and rates are quoted excluding Value Added Tax (VAT), unless otherwise stated. VAT valid at the time will be added to prices during invoicing. No VAT is added to the tariffs and rates applying to mail addressed to the special areas outside the European Union's excise and VAT zone and non-EU member states.
